Sub – Refusal of Consent under section 27 of water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981

We refer to application for grant of Renewal of Consent to Operate for Sugar unit - 2500 TCD u/s 26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & Other Wastes (Management and Transboundary Movement) Rules, 2016.

AND WHEREAS, Your application for grant of Renewal of Consent was discussed in the Consent Committee meeting held on 28.10.2015, and it was decided to grant renewal of consent after submission of Bank Guarantees as per previous consent conditions.

AND WHEREAS, this office has issued letter referred at Sr. No. 3 for submission of Bank Guarantees as per previous consent conditions. AND WHEREAS your reply referred at Sr. No. 4 was placed and discussed in Consent Committee meeting dtd: 23.03.2016 and it was decided to issue Show Cause Notice for refusal of consent for following non-compliances:


- a. You have not submitted Bank Guarantees as per previous Consent Conditions.
- b. You have not provided online monitoring system.

- c. You have not provided Air Pollution Control System as per CREP norms.
- d. JVS analysis results are exceeding prescribed consented standards.

AND WHEREAS You have failed to submit reply to Show Cause Notice issued by the Board on 26.04.2016. AND WHEREAS your application was re-discussed in Consent Committee meeting of the Board held on 14.09.2016 and it was decided to issue final refusal for Renewal of Consent as you have not submitted Bank Guarantees as per previous consent conditions and JVS analysis results are exceeding the prescribed Consented standards.

In view of the aforesaid non compliance, your application for grant of renewal of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016.
