LETTER OF REGISTRATION / AUTHORISATION [Registration /Authorization for import of Metal Scrap]

Ref: Your application for Grant of registration for import of ferrous and non ferrous metal scrap (Part-D of Schedule-III) on behalf of end user under Hazardous Wastes (Management, Handling & Transboundry Movement) Third Amendment Rules, 2010 dt: 10/09/2015.

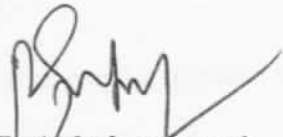

2. M/s. Reevax Trading Pvt. Ltd., H. No. 571/9, Flat No. 301, 3rd Floor, Ambalik, Durgesh Park, Kalher, Bhiwandi, Thane - 421302 is hereby granted an registration / authorization for import of ferrous & non ferrous metal scrap on behalf of end user mentioned in Part-D of Schedule-III of Hazardous Wastes (Management, Handling & Transboundry Movement) Third Amendment Rules, 2010.
3. The registration is valid for import of ferrous & non ferrous metal scrap [Not containing any of the constituents mentioned in the schedule-II of Hazardous Waste (MH & TM) Rules 2008] on behalf of end user mentioned and marked ** (Double Star) in Part-D of Schedule-III of Hazardous Wastes (MH&TM) Third Amendment Rules, 2010.
4. The registration is valid for import of hazardous waste listed in Part-D of Schedule-III of Hazardous Wastes (MH& TM) Third Amendment Rules, 2010. The importer shall strictly comply all the provisions made under Hazardous Waste (MH & TM) Rules, as amended.
5. The registration is subject to the conditions stated below and sub conditions as may be specified in the rules in force under the Environment (Protection) Act, 1986.
6. The import is permitted only on behalf of actual user having consent from State Pollution Control Board / traders having registration from SPCB. In case of high sea sales by importer the bill of entry shall be filled by actual user / registered trader. The importer shall submit quarterly report in form - 10 including quantity of metal scrap imported with documents for Bill of lading, Bill of entry, quantity sold to scrap dealer / actual users and submit annual returns in form-4 as per Hazardous Waste(MH&TM) Third Amendment Rules, 2010. The manifest system as per rule 21(1) in the Form No. 9 shall be implemented after reporting imported scrap at ports.
7. The importer shall obtain a letter / certificate from the actual user / registered trader of SPCB stating that the importer is importing the hazardous waste on his behalf. All the imported hazardous waste shall be directly transferred to the actual user from the port directly or through registered importer.
8. They shall obtain necessary permission from MPC Board for temporary storage of metal scrap if intended to store the material in Maharashtra.

9. In case of illegal import or import other than mentioned in Part-D of Schedule-III of Hazardous Wastes (Management, Handling & Transboundary Movement) Third Amendment Rules, 2010, the waste has to be re-exported by the importer at his own cost within a period of 90 days from the date of its arrival in India.

- General Conditions:

1. The registration / authorization shall comply with provisions of the Environment (Protection) Act, 1986 and the Rules made there under. The registration or its renewal shall be produced for inspection at the request of an officer authorized by the Maharashtra Pollution Control Board.
- 2.. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous wastes without obtaining prior permission of the Maharashtra Pollution Control Board. Any unauthorized change in personnel or working conditions as mentioned in the application by the person authorized shall constitute a breach of the authorization.
3. It is the duty of the authorized person to take prior permission of the Maharashtra Pollution Control Board to close down the facility. An application for the renewal of registration shall be made as laid down in rule of Hazardous Wastes (M, H & TM) Third Amendment Rules, 2010.
4. Minimize storage needs by purchasing smaller amounts of material more frequently and as needed for specific jobs. Stockpiling materials, which often must be stored outside and exposed to storm water, increases the possibility of pollutants flowing offsite.
5. Always store used parts (i.e. vehicle, electronic, mechanical) under cover to prevent the leaching of any materials into storm water runoff.
6. The Hazardous material must be stored to prevent unauthorized people from accessing the area.
7. The Board reserves right to cancel/ Amend/Revoke the authorization at any time as per the Policy of the Board / Government.

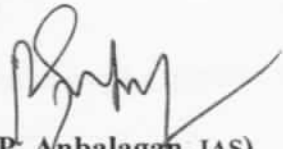
