The Consent to Establish is granted for a period up to Commissioning of the project or 5 years whichever is earlier

"Consent to Establish will be operational only after obtaining Environmental Clearance from Competent Authority by the applicant and subject to the compliance of conditions stipulated in an Environmental Clearance including conditions which may be more stringent, if stipulated by / in the Environmental Clearance."

- CONDITIONS UNDER WATER (PREVENTION & CONTROL OF POLLUTION) ACT, 1974: 3.
 - (i) The daily quantity of trade effluent from the factory shall not exceed 8.5 M3.
 - (ii) The daily quantity of sewage effluent from the factory shall not exceed 1 M³.
 - (iii) Trade Effluent Treatment: The applicant shall provide comprehensive treatment system consisting of primary / secondary treatment as is warranted with reference to influent quality and operate and maintain the same continuously.
 - (iv) Trade Effluent Disposal: The treated trade effluent shall be passed through RO & MEE and shall be 100% recycled/ reused in the process as mentioned in the undertaking submitted by the unit dated 07.07.2011.
 - (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards:

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

5. CONDITIONS UNDER AIR (PREVENTION & CONTROL OF POLLUTION) ACT, 1981:

- (i) The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:
 - A) Control Equipment:

1. Air pollution control equipments of sufficient capacity shall be provided to limit the emissions.

B) Standards for Emissions of Air Pollutants :

(i) SPM/TPM Not to exceed 150 mg/Nm³ (ii) SO₂ Not to exceed 4.5 kg/day (iii) Acid mist Not to exceed 35 mg/Nm³

(ii) The applicant shall observe the following fuel pattern :-

(iii) The applicant shall erect the chimney(s) of the following specifications:-

- (iv) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/displayed to facilitate identification.
- (v) The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.
- (vi) Other Conditions:
 - 1) The industry should not cause any nuisance in surrounding area.
 - 2) The industry should monitor stack emissions and ambient air quality regularly.

CONDITIONS UNDER HAZARDOUS WASTE (MANAGEMENT, HANDLING & TRANSBOUNDARY MOVEMENT) RULES, 2008:

(i)The applicant shall handle hazardous wastes as specified below:

(ii)The authorization is hereby granted to operate a facility for collection, storage, transport and disposal of hazardous waste.

7. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

8. General Conditions:

a. The applicant shall maintain good house keeping and take adequate measures for control of pollution from all sources so as not to cause nuisance to surrounding area/inhabitants.

b. The applicant shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, number of trees surviving as on 31st March of the year and number of trees planted by Sepetember end.

c. Solid Waste – The non-hazardous solid waste arising in the factory premises, sweepings, etc. be disposed of scientifically so as not to cause any nuisance / pollution. The applicant shall take

necessary permissions from civic authorities for disposal to dumping ground.

d. The applicant shall provide for an alternate electric power source sufficient to operate all pollution control facilities installed by the applicant to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent regarding pollution levels.

e. The applicant shall not change or alter the quantity, quality, the rate of discharge, temperature or the mode of the effluent/emissions or hazardous wastes or control equipments provided for

without previous written permission of the Board.

f. The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous waste to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.

g. The applicant shall make an application for renewal of the consent at least 60 days before the

date of expiry to the consent.

h The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.

 An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

- The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.
- k. Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of the collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers down stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system.

 Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.

m. The industry shall ensure that fugitive emissions from the activity are controlled so as to maintain clean and safe environment in and around the factory premises.

- The applicant shall obtain Consent to Operate from Maharashtra Pollution Control Board before actual commencement of the production activity.
- The applicant shall not take any effective steps towards implementation of the project before obtaining Environmental Clearance as per EIA notification, 2006 and amendment thereto. If any non-compliance of the conditions of Consent to Establish observed, the Board will initiate appropriate legal action including forfeiture of bank guarantee, revocation of consent & further action.
- This Board reserves the right to amend, revoke or add any conditions in this consent and same shall be binding on the applicant.
- 12 The industry shall submit an Irrevocable Bank Guarantee of Rs. 2,00,000/- valid for one year in favour of Regional Officer, MPCB, Raigad within 15 days period against the installation and satisfactory performance of RO & MEE.
- This consent is issued pursuant to the decision of Consent Committee Meeting held on 04.11.2011 of the Board.
- The Capital Investment of this expansion is ₹ 1.3/- Crores. Total capital investment is ₹ 41.8/- Crs.
