

- ४] प्रयोग शाळा सहाय्यक ही पदे सिमाई, चौकोदार, इत्यादि "ड" वर्गातील कर्मचा-यांतून पदोन्नतीने भरावयाची व नामनिर्देशाने विज्ञान शाखेतील पदवीधर उमेदवारांतून

नामनिर्देशनाने ०५ टक्के अंति प्रमाण ठेवावे.
५] "ड" वर्गातील कर्मचारी स्त.स्त.सी.पेक्षा कमी अर्हता प्राप्त असून

THE MAHARASHTRA POLLUTION CONTROL BOARD EMPLOYEES'
RECRUITMENT REGULATION, 1996

In exercise of the powers conferred by Sub-Section 3A of Section 12 of "The Water (Prevention and Control of Pollution) Act, 1974" (with Act No.53 of 1988) and rule 25 of "The Maharashtra Water (Prevention and Control of Pollution) Rules, 1983" and Section 14 read with clause (h) of Sub-Section 2 of Section 54 of "The Air (Prevention and Control of Pollution) Act, 1981" (with Act No.47 of 1987) and all other powers enabling it in this behalf, the Maharashtra Pollution Control Board, in supersession of all regulations and/or rules made for the recruitment of officers and employees to the posts as shown in 'Schedule-A' in Maharashtra Pollution Control Board, make the regulations namely :-

1. (a) This regulations may be called "The Maharashtra pollution Control Board Employees" (Recruitment) Regulations, 1996"
- (b) This shall come into force from the date of approval of the State Government in Environment Department.
2. In this regulation, unless the context otherwise requires -
 - (a) The words and expressions used, but not defined herein, shall have the same meaning as assigned to them in "The Water (Prevention and Control of Pollution) Act, 1974" and "The Air (Prevention and Control of Pollution) Act, 1981" and rules made thereunder;
 - (b) 'Board' means Maharashtra Pollution Control Board ;
 - (c) 'Degree' means a degree of a Statutory University/Board;
 - (d) 'Government' means the Government of Maharashtra ;
 - (e) 'Recognized Institution' means an Institute recognized by Government.
 - (f) 'Test' means oral test/interview prescribed by the Board.
 - (g) 'Cadre' means "Technical, Scientific, Legal and Ministerial" as indicated in Schedule-I.

3. Appointment to the post of 'Air Pollution Abatement Engineer/ Water Pollution Abatement Engineer' (Grade-A) in the pay scale of Rs.3700-125-4700-150-5000, shall be made either -


(a) by promotion of a suitable person on the basis of "Strict Selection" from amongst person holding the post of Regional Officers/Air Pollution Control Officer/Air Pollution Abatement Automobile Combustion Controlling Engineer/ Micro Meteorology Officer subject to following :-

- (1) 6 years service in the above post who is Post Graduate in Engineering/Doctorate in Science or its equivalent.
- (2) 8 years service in the above post who possesses Degree in Engineering/Post Graduate in Science/Post Graduation Diploma in Environmental Science or its equivalent.
- (3) 10 years service in the above post who possesses Diploma in Engineering or its equivalent.
- (4) 12 years service in the above post who possesses Degree in Science or its equivalent.

(b) by nomination, from amongst candidates who -

- (1) already in service of Board/Government should not be more than 50 years of age;
- (2) possess a Post Graduate Degree in Engineering from a recognized university /institution; or Doctorate in Science with Environmental Science as a special subject during the post graduation or its equivalent.
- (3) possess not less than 7 years experience after acquiring qualifications prescribed in sub-clause (2) of clause (b) of this rule.

(c) The posts to be filled in by nomination shall not exceed 50% of the total number of vacancies.



5. Appointment to the post of 'Sub-Regional Officer' (Grade-A) in the pay scale of Rs.2300-75-2800-EB-100-4000 shall be made either-

(A) by promotion of a suitable person on the basis of 'Seniority subject to fitness' from amongst person holding the post of 'Deputy Engineer' or 'Field Officer' subject to following:-

(1) Candidate from the post of Deputy Engineer should have minimum 4 years of regular service in that post.

OR

(2) Candidate from the post of Field Officer from the Engineering discipline should have -

(i) 5 years of regular service, in that post, having a Degree in Engineering or its equivalent from a recognized Institution;

(ii) 7 years of regular service, in that post, after having a Diploma in Engineering or its equivalent from a recognized Institution;
