Sub: Constitution of Committee for implementation of procedure for issuance of grant/renewal of Authorization of Industrial Units possessing environmentally Sound Management facilities for reprocessing / recycling & Actual Users/co-processing/Utilizations of the Hazardous Waste and Recycling of electronic – Waste (e-waste)

Ref: 1. E-Waste (Management) Rules, 2016 dated 23rd March 2016

 Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 dated 4th April 2016

3. Office Order No.16 dated 06.07.2016

Vide above Office Order dated 06.07.2012, the committee was constituted for implementation of procedure for issuance of grant/renewal of registration scheme of Industrial Units possessing environmentally Sound Management facilities for reprocessing / recycling of the Hazardous Waste and Recycling of electronic – Waste (e-waste). The said committee was constituted to examine the applications received for grant/refusal of registrations of the industrial processors involved in reprocessing and recycling of hazardous waste and E-waste.

Now the Ministry of Environment, Forest & Climate Change (MoEF & CC) has notified new Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and E-Waste (Management) Rule, 2016 vide Notification dated 4/4/2016 & 23/3/2016 respectively. As per these Rules, registration is not required to Hazardous Waste and E-Waste Recyclers or re-processors whereas authorization from the State Pollution Control Board is mandatory to every Occupier of the facility who is handling, generating, collection, storage, packaging, transportation, actual users, treatment, processing, recycling, recovery, pre-processing, co-processing, utilization, offering for sale, transfer or disposal of hazardous waste or other waste falls under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016. As per E-Waste (Management) Rules, 2016, every manufacturer, dismantler/ recycler/ refurbsher shall require to obtain authorization from the State Pollution Control Board (SPCB).

The Procedure for grant of authorization as per the Hazardous Waste (Management, Handling & Transboundary) Rules, 2016 and E-Waste (Management) Rule, 2016 is defined in the said rules.

As per the Rule 9 of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016, the procedure for obtaining authorization for utilization of hazardous waste and other waste as resource or after preprocessing either for co-processing or for any other use including within premises of the generator is prescribed. As per this rule wherever standard operating

procedure for utilization of hazardous waste is provided by CPCB in that case the SPCB shall grant the authorization to such type of industries by assessing infrastructure facility available in the unit.

In view of above newly notified Waste Rules, 2016, the Committee consisting of following members is constituted to examine the proposals/applications received for grant of authorization under both Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and E-Waste (Management) Rule, 2016 in the Maharashtra Pollution Control Board.

Terms Of Reference (TOR) of the Authorization Committee:

- A) For examining of grant/renewal of Authorization scheme of Industrial Units possessing Environmentally Sound Management Facilities for reprocessing / recycling of the Hazardous & Other Wastes under Hazardous & Other Wastes (M &TM) rules, 2016
- ➤ To examine the applications /proposals received from reprocessing / recycling & Actual Users of Hazardous Waste listed in Rule 2016 for grant/renewal of authorisation.
- > To evaluate the adequacy of the pollution control facilities installed in the Unit.
- > To evaluate whether the quantity of hazardous waste requested by the unit is possible with available facilities.
- > To evaluate the storage capacity (Raw Material & Product) of unit.
- > To evaluate the claim of the applicants about type & quantity of residue generated during recycling process.
- > To recommend for grant of Authorization by stating type & quantity of the hazardous waste that can be processed.
- To recommend for refusal of authorization stating the reasons and/or lay down additional conditions for improvements/modifications etc.
- Authorization committee will recommend the Authorization matters to the Member Secretary of the Board.
- B) For issuance of grant/renewal of authorization for dismantling/ recycling/manufacturer/refurbisher of the Electronic Waste under the E-Waste (Management) rules, 2016
 - To examine the applications /proposals received from dismantling/ recycling/manufacturer/refurbisher of the Electronic Wastes (E-Wastes) for grant/renewal authorization.
 - To evaluate the adequate technical capabilities of the dismantler / recycler of the E-Wastes.

- > To evaluate whether requisite facilities and equipment to recycle and process E-Wastes installed in the unit.
- To evaluate storage capacity (Raw Material & Product) of the Unit.
- > To evaluate & examine processing capacity of dismantler / recycler of the
- > To categorize for grant of authorisation by stating quantity of the E-wastes that can be either dismantled or recycled.
- > To recommend for refuse of authorisation stating the reasons and/or lay down additional conditions for improvements / modifications etc.
- > Authorization committee will recommend the authorisation matters to the Member Secretary of the Board.
- C) For Implementation of the procedure for issuance of authorization for utilization of Hazardous and other wastes as resource or after preprocessing either for co-processing or for any other waste under Rule 9 of the Hazardous Waste (Management & Transboundary Movement) Rules, 2016.
 - > To examine the proposal / applications received for grant of authorisation for utilization of Hazardous and other wastes as resource or after preprocessing either for co-processing or for any other waste under Rule 9 of Hazardous & Other Wastes (M & TM) Rules 2016.
 - > To evaluate the adequacy of the pollution control facilities installed in the
 - > To evaluate the compliance of standard operating procedure/guidelines published by CPCB for actual users of the Hazardous Waste.
 - To recommend/refuse the authorization.
