• Dr. Rakesh Kumar & Dr. G.S. Dang, Members of the registration committee could not attend the meeting due to their pre-occupancy of the schedule.

• Dr. Y.B. Sontakke Incharge HSMD, /RO (HQ) MPCB, Mumbai, Member Convener of registration committee for Environmental Sound Management of Hazardous Waste, welcomed Chairman Shri R.K. Garg & members of registration committee.

- Dr. Y.B. Sontakke Incharge HSMD, /RO(HQ) MPCB, Mumbai gave brief introduction about transfer of procedure for issuance of grant / renewal of registration scheme of Industrial Units possessing Environmentally Sound Management facilities for reprocessing /recycling of the Hazardous Waste from Central Pollution Control Board, New Delhi to MPC Board & discussed about requirement of constitution of registration committee in MPC Board vide office order no: E-104 dated: 31/12/2010 for issuance of grant / renewal of registration scheme of Industrial Units possessing Environmentally Sound Management facilities for reprocessing /recycling of the Hazardous Waste listed in Schedule IV As per rules 8(1) & 9 of Hazardous Waste, (MH&TM) rules, 2008 in MPC Board.
- Shri. R.K. Garg, Chairman of the registration committee shared his experience in CPCB's registration committee for issuance of grant /renewal of registration to industrial units possessing EST for reprocessing/ recycling of the HW with other members of registration committee.
- Shri. R.K. Garg Chairman of the registration committee, then disscued pre-requisite documents to be accompanied with application in prescribed Form V format for issuance of grant / renewal of registration to Industrial Units possessing Environmentally Sound Management facilities for reprocessing /recycling of the Hazardous Waste such as —
 - (a) consent to establish granted by the State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974 (25 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (21 of 1981);
 - (b) Certificate of registration issued by the District Industries Centre or any other government agency authorized in this regard;
 - (c) Proof of installed capacity of plant and machinery issued by the District Industries Centre or any other government agency authorized in this behalf;
 - (d) in case of renewal, certificate of compliance of effluent, emission standards and treatment and disposal of hazardous wastes, as applicable, from the State Pollution Control Board.

- Shri. R.K. Garg & committee members had discussion on scrutiny of application for issuance of renewal of registration to reprocessor /recyclers of the Hazardous Waste, the outcome of the discussion is to give emphasis on inspection report to submitted by respective Regional officers of the Board for checking compliance of the industrial unit for effluent, emission standards and treatment and disposal of hazardous wastes as well as equipments installed for reprocessing /recycling of Hazardous Waste had Environmentally Sound Management Technology (EST).
- Shri, Garg then explained different types of Hazardous waste required to obtain registration for reprocessing /recycling with EST, Such as Nonferrous Metals, Used Oil/Waste Oil & other types Hazardous Waste listed in Schedule IV Hazardous Waste (MH&TM) rules, 2008 & enquired about how many applications for registration received from CPCB to MPCB. Dr.Y.B.Sonatkke I/c. HSMD & RO (HQ) told to committee members that 39 applications for registration are received from CPCB & other 7 applications are received from industrial units directly to MPCB.

- Shri. R.K. Garg, Chairman of the registration committee told that cases complete in all aspects, such as inspection report submitted & along with necessary pre-requisite documents shall be considered for including in agenda of the Registration Committee meeting in future.
- Shri. R.K. Garg, Chairman of the registration committee & other committee members had disscuion on finalizing date of next registration committee meeting. Shri. R.K. Garg & registration committee members unanimously decided the date of next registration committee meeting on 10th Feb 2011 at 11.00 am, MPCB HQ, Sion Mumbai.
