GENERAL POINTS:

1. Committee has observed that many industry are started construction/production activity without obtaining Environmental Clearance and consent to establish, hence it was decided that Sr. Law Officer shall put up a proposal for policy decision in this regards in next CC Meeting.
2. It was noted during the meeting, RO/SRO are not submitting JVS Air/Stack analysis result along with application. Hence committee directed application shall be submitted along with latest JVS Air/Stack analysis result of air polluting industry.

The meeting ended with vote of thanks to the Chair.
