- 6. Industry has submitted the detail report calculating the pollution load comparing the existing consent quantity and proposed quantity.
- 7. Industry has carried out a detailed analysis of the Chemistry and Material Balance of the existing and proposed products and it was found that the pollution loads from the proposed change of products were less compared to the existing products. Detailed flowchart, description, chemical reaction, material balance and pollution load generated by each product per batch and per day are enclosed along with the report.
- 8. The Industry has also installed Multiple Effective Evaporator along with Stream Stripper and has constructed a full fledge Biological treatment plant for treatment of effluent to meet discharge norms of the board. The Industry has also provided solid waste storage yard for storage of Evaporation salts and Spent Carbon (Charcoal).
- 9. There is no change in existing Utilities like Boiler, D.G. set, cooling towers, chilling plants etc., even after change in production capacities.
- 10. In view of above, it is noted that industry now intend to obtain consent for less product quantity and pollution load compared to the earlier proposal, Hence it is proposed to place the case before CC with all details for decision about grant of change in product mix with amendment in the existing consent.
