General Points:

1. During the discussion of M/s. Shardashree Ispat, it was observed that as per EIA notification, 2006 there is no clarity whether a rolling mill project (which requires only heating furnace) would require EC or not; hence it was decided that a Committee of HODs shall be constituted for verification of applicability of EC to a industry on the line of category committee constituted vide Office Order no. E-95 dated 04.08.2012. This committee shall analyse the applicability of EC in cases where there is ambiguity/no clarity.
2. JD(PAMS) pointed that the BG submitted to Regional Offices are piled up unnecessarily at the offices and no action is taken against it. As per Board's policy, power of release & encashment of BG is withheld with Head Office. Now Board is obtaining BG for non-submission of Environment Statement, Cess Payment, etc also. Hence, it was suggested that the power of release of BG obtained for non-submission of Env't Statement, cess payment, etc should be given to Regional Office so that after compliance the BG may be returned to the industry, which will help in overcoming pending issues. In continuation to this, Hon'ble Member Secretary suggested that apart from the above Regional Offices should attend to the BGs submitted by the industry in time, so that BG of a non-complying industry can be forfeited before the validity period of BG is lapsed. Such circular shall be issued by Senior Law Officer.

3. During the meeting, it was observed that many applications were not submitted, by RO/SRO, through IMIS to Head Office and hence it was decided that RO/SRO shall follow the due procedure and all applications shall be placed in CC meeting only after submitting through IMIS.
4. It is observed that, for most of the cases the consent period is not mentioned alongwith the recommendations, hence all HOD/RO/SRO shall mention consent period while recommending the cases for grant of consent before submitting to CC.
