				S.L.O pointed out that the present case is somewhat different and not similarly situated because in the instant case of Baramati hitech Park Ltd., prior to 2009 amendment to the EIA notification, park could have been covered only if the development area is more than 50 hectares and therefore at that time in 2008, C to E was granted without EC requirement.
				Now, the unit has already been established and applied for grant of consent to operate, to which the amendment of 2009 cannot be made applicable retrospectively.
