### **REVIEW ITEM**

#### **CC-Special Item for policy decision**

#### <u>Subject:</u> Policy decision on grant of consent to industries intend to manufacture Pyrolysis Oil & Carbon Black by using waste tyres/plastic wastes.

- 1. This office is receiving application of Industries for manufacturing of Pyrolysis oil & Carbon black by using waste tyres/waste plastics. In the process molecular restructuring of rubber occurs, resulting rubber liquid in gaseous form along with other gases and rubber oil is formed by condensing these gases.
- 2. The Pyrolysis Oil process (manufacturing process enclosed) involves extraction of rubber oil from rubber/tyre by heating process without adding any chemical ingredients, but the molecular restructuring of rubber occurs during the process.
- 3. The process waste is utilized to convert it into valuable products such as Carbon black & Rubber Powder.
- 4. As per the EIA Notification dated 14/09/2009 Column No-5 (e) It is given that-Environmental Clearance is required to Petrochemical based processing (Processes other than cracking & reformation and not covered under the petrochemical complexes).
- In an identical matter Board has already referred to SEIAA vide Letter dtd-02/04/2012; 19/11/2012 for necessary guidance to ascertain the applicability of Environmental clearance for the aforesaid activities under the SEIAA Notification 2006, reply is still awaited.
