## **General Points:**

- 1. The consents shall be disposed after obtaining requisite consent fees as per GoM, revised fee structure dtd. 25.08.2011 and according to the industry wise new validity period. The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.
- 2. Report submitted by RO, Nashik regarding construction activities, specially plot area/ BUA mentioned in the processing report are abrupt. RO, Nashik should take a note of this and improve their consent processing.
- 3. HOD shall not call anyone industry for presentation in CC without the approval of MS in advance.
- 4. It is seen that the period recommended for grant of consent in the summary sheet is not as per the Sectoral Approach for processing of cases. Henceforth, recommended consent period in the summary sheet of the cases shall be as per Sectoral Approach for processing of cases only.
