Note:

General Points:

1. The consents shall be disposed after obtaining requisite consent fees as per GoM, revised fee structure dtd. 25.08.2011 and according to the industry wise new validity period. The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.

2. AS(T) - to issue circular regarding renewal cases, all FO's should specify Plain renewal or if there is any increases in production, consummation, effluent or any other expansion it should be mentioned in processing sheet. A similar circular be issued for amalgamation cases.

3. AS(T) to issued circular for sensitizing FO's / SRO's that they should comment on Total Built up Area of industry while processing green field project applications and in case of expansion total built up area (existing + proposed BUA) to decide applicability of Environment Clearance and to prescribe condition not to take effective steps prior to EC where applicable.
