3. JD(APC) shall issue separate circular that as per discussion and decision held in CC meeting dtd 15.02.2013, rolling mills does not require EC.

4. Short committee of AST, PSO & JD(WPC) to work on the issue of installation TOC analyser requirement in industries and submit draft guidelines to MS within 15 days.

5. Committee selected by JD(APC) shall establish VOC protocol by carrying out study on which industry VOC system is required, where is it present and other such aspects.
