General Points:

1. All the consents shall be issued only after obtaining requisite consent fees, as per the G.R. of Evt. Dept., GoM for revised consent fees dtd. 25.08.2011.
2. The specific conditions imposed in the consents as per CC meeting decisions should be rigorously reviewed by the respective sections in Head Office, on the similar line of CAC.
3. During the meeting it was observed that the JVS results submitted with the applications are very old, hence Member Secretary has directed that RO/SRO should submit the applications to HQ alongwith latest JVS results of consecutive three months.
4. Also, it was observed that RO/SROs are not reporting the present status of the industry in respect of cases of consent to establish and/ or expansion, hence it was decided that in such cases RO/SRO should submit their report with ground reality details (effective steps taken, erection work started /completed, trial runs taken, commercial production started, etc.).
