Sankhlekha Construction, "Waterway", Survey No. 385 & 389, Agartakli Shivar of nashik Municipal Corporation, Nashik

The case was discussed in detail in CC, as per policy decision taken in RRZ committee meeting held on 07.06.2013. PP submitted the approved plan by NMC showing position of STP plant from river Godavari which is at 375 mtrs distance. Secondly PP has proposed to give solid waste to M/s Avni Environmental services for the treatment in organic waste converter for recycling purpose, which is having permission of the Board.

In view of above it was decided to grant consent to establish for construction of residential cum commercial project, on total plot area of 96,006 sq. mtrs. & total construction BUA of 1,83,711 sq. mtrs. (As applied to EC), by imposing following conditions:

(i) PP shall submit Bank Guarantee of Rs. 10 lakh toward compliance of consent conditions.

(ii) PP shall submit an affidavit within 15 days in the prescribed format towards not taking further effective steps prior to obtaining the EC and BG of Rs. 20 Lakh for ensuring the compliances.

(iii) PP shall submit Board Resolution from company Board, towards starting of construction work without obtaining consent to establish from the MPC Board and Environmental Clearance thus violated the provisions of Environmental Laws and in future, they will not do such violations and BG of Rs. 2 lakh towards submission of Board resolution by 10.10.2013.

(iv) PP shall comply with the RRZ Policy, 2009 conditions

(v) For the disposal of MSW the above mention condition for disposal and treatment of common facility provided by M/s Avni Environmental Services shall be prescribed but the condition granted in Environment Clearance for the disposal and treatment of MSW will be binding on PP.

(vi) Revised approved plan for total project as proposed in EC approved by NMC, shall be submitted within 3 months period, otherwise this C to E will be stand cancelled.
