CIRCULAR

Sub: Checking compliance to Implementation of Plastic Rules/ Act by vigilance teams.

MoEF Govt. of India has published Recycled Plastic Manufacture & Usage (Amendment) Rules 2003 on 17 June 2003. Environment Department Govt. of Maharashtra published Maharashtra Plastic Carry Bags (Manufacture & Usage) Rules 2006, Maharashtra Non-Biodegradable Garbage (Control) Act, 2006 on 21/4/2006, and draft notification of Plastic (Manufacture Usage & Management) Rules 2009. The Maharashtra Pollution Control Board is the implementing authority as per all above rules.

MPC Board has prepared inventory on the basis of reports submitted by Regional officers of plastic manufacturing units and observed that, there are 446 units those are engaged in plastic manufacturing like containers, plastic bags (virgin/recycled) and obtained registration under Recycled Plastic Carry Bags (Manufacture & usage) Rules 2006. It is mandatory on the part of MPC Board to submit quarterly report to Government of Maharashtra. In this regard, it has been noticed that Regional Offices are not providing adequate information in timely manner to this office, which further leads to delay in submission of information to Govt. of Maharashtra. It is regret to say that in spite of frequent reminders Regional Offices have not submitting consolidated information to Head Quarter.

Further, on the basis of quarterly report received by Regional (ffices, it is noticed that the visit to the plastic manufacturing units and action taken on these units is not satisfactory. Which means there are no such units are in operations or the units are manufacturing plastic bags more than 50 microns in any regions. As per last six months report, it is noted that any Regional Office has not observed any unit who is manufacturing plastic carry bags more than 50 microns or operating without obtaining registration from the Board.

In view of the above, to implement the Plastic Rules more effectively, it has decided to form two squads in each Region containing two field officer (one from Regional Office and another from respective Sub Regional Office) to visit the plastic manufacturing units. Field Officers of Head Quarter will also be the member of the squad in Region which are in periphery of HQ i.e. Mumbai, Thane, Kalvan, Raigad and Navi Mumbai.

All Regional Officers and Sub-Regional Officers are directed to carry out this survey. The concerned team members shall prepare a data sheet mentioning total units in sub-region, consent status, plastic (virgin/reprocessor) etc. from the record available in the office. Also they shall obtain the information from DIC, industries association, MIDC, NGOs and update the office record. The respective ROs and SROs shall ensure facilities like availability of vehicle, Police in sensitive areas. They shall complete the survey preferably for major plastic carry bags manufacturing industries.

1) Preparation time dt. 4th Dec., 2009 to 10th Dec., 2009.

Vigilance team will start visiting units from 21st of Dec., 2009 to 31st Dec., 2009.

3) Above teams will come in force from date of circular and effective for one year. In absence of any Field Officer the temporary replacement shall be made by respective ROs immediately.

4) The comprehensive report shall be submitted by respective RO/SRO on next

day of visit to RO(HQ) I/c HSMD for further action.

5) During visit any team finds violation they shall prepare Panchnama on the spot and report to the respective Regional Officer as well as Member Secretary for immediate legal action.

6) The Regional Officers shall issue closure direction immediately to such units who are engaged in manufacturing/storing in the premises of industry plastic

carry bags less than 50 microns.

 All Regional Officers shall carry out vigilance in co-ordination with Regional Officer (HQ) I/C HSMD.
