Sub.: Finalization of the revised action plan for the Industrial Cluster, Navi Mumbai, regarding OA No. 77/2016 (WZ) before Hon'ble NGT, Pune

The Hon'ble National Green Tribunal (WZ), vide order dated 28/2/2017 (OA No. 77/2016 (WZ)), directed CPCB to review the action plan for the Industrial Cluster, Navi Mumbai for its adequacy & efficacy and finalization of the same within 4 week time. In this regard, a meeting of officials of CPCB and MPCB was held to review the Action Plan for the industrial cluster, Navi Mumbai on April 25, 2017 at CPCB Office, Delhi.

The compliance status report submitted by MPCB vide letter dated 29/3/2017 was discussed in detail and the observations were made for further necessary action.

Shri Mohekar, RO, MPCB, Navi Mumbai was requested to submit the revised action plan by 28/4/2017, for onward submission to the Hon'ble NGT as well as for its further implementation. Minutes of the meeting were forwarded vide our letter dated 28/4/2017 for your kind information and necessary action.

RO, MPCB, Navi Mumbai, vide e-mail dated 2/5/2017, submitted the "Environmental status and revised action plan for prevention and control of pollution of industrial cluster, Navi Mumbai (May 2017)". I have been directed to inform that the same has been reviewed and accepted by CPCB for its adequacy and efficacy and for its further implementation in time bound manner.

It is further requested to upload this Revised Action Plan (May 2017) as well as subsequent progress reports, CEPI monitoring reports, CEPI scores as well as other related details in public domain at MPCB website.

You are also requested to comply with all the directions issued by CPCB on 26.04.2016 to all SPCBs/PCCs under Section-18(1)(b) of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981, for adoption of the revised CEPI concept, which includes environmental quality monitoring in all the CPAs, installation of continuous ambient air quality monitoring stations, installation of continuous water quality monitoring stations, application of revised CEPI version and action plan & monitoring.
