1.0 Scope of work:

Supply of PlantConnect AQMS software to fulfil following requirements –





Collect ambient air quality data and CEMS data from various industries in Chandrapur (approximately 100 stations / stacks in industries). Data will be made available by the Industry in a suitable format as .csv / text files on a computer in the industry. Plant Connect data upload component shall send this data to server via FTP.

- Generate a file every day at end of day containing all data collected during that day and
 upload this file to Datafed Server FTP. Format of this file should be as per documentation
 provided by Datafed personnel. Uploading to Datafed server shall be done with the approval
 of MPCB for each set of data.
- Provide appropriate user interface to monitor the data and generate various reports, graphs and other statistical tools. etc.
