Madam,

Vide reference to above, MPCB is pleased to accept professional charges of Rs.6.25 Lakhs (Rs. Six lakhs twenty five thousands only + taxes extra as applicable) for preparation of Water Quality Report including Data compilation and the water quality indices for the year 2013-14 based on the data of about 250 monitoring stations. Other terms and conditions are as below:

Scope: Preparation of Water Quality Report 2013-14 based on the data provided by MPCB. Detail scope of work is mentioned below.

- 1) Identification of outliers and Parameter values exceeding the permissible limits.
- 2) Descriptive statistics shall involve compilation of each data and data of the following:
 - a) Percentage of missing values.
 - b) Minimum and maximum values, Data Range.
 - c) Percentiles, Arithmetic and Geometric Mean, Standard Deviation, Exceedance of Permissible Standards.
- 3) Surface water quality indices shall be prepared for rivers, seas and creeks. Ground water quality indices shall be prepared for tubewells, dugwells.
- 4) The data will be analysed for four parameters viz. Dissolved Oxygen, Faecal Coliforms, pH, Biochemical Oxygen Demand for surface water and for ground water pH, Nitrate, Fluoride, Total Hardness for preparation of water quality indices.

- 5) Submission of two draft report in black & white for comments and approval. Two coloured copies of the final report along with soft copy on CD shall also be made available to MPCB.

Time Period: 2 weeks from the date of receipt of this work order.

Payment Terms: 50 % payment shall be released after acceptance of WO and submission of invoice in duplicate for release of payment. Balance 50 % payment shall be released after finalization and acceptance of final report.
