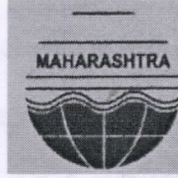



However, The MoEF & CC has issued Office Memorandum dtd 14.09.2020 and permitted activities with ceiling of 100 persons with effect from 21.09.2020 with mandatory wearing of face masks, social distancing, provision for thermal scanning and hand wash or use of sanitizers. If the number of participants is more than 100, more than one public hearing may be conducted by staggering the time and/or dates. 
