In compliance of Notification S. O. 1533 dt. 14/09/2006 and amended Notification S.O. 3067 (E) dt. 01/12/2009 of Ministry of Environment and Forests, Government of India, the Public Hearing Panel in respect of **Proposed** Development of a Greenfield Port at Vadhvan with capacity of 298 Million tons per annum with 9 container Terminals, 4 multipurpose berths, 4 liquid berths, Ro-Ro Berth, Coastal Berth, Coast Guard Berth & 10.14 km breakwater including dredging and container and cargo storage area of 1448 Ha reclaimed land etc. The proposed port is located at the coast of Vadhvan in Dahanu Taluka with Road connectivity from NH 8 and Rail Connectivity from Vangaon station. The port is proposed to be developed on reclaimed land in the offshore area. The port limits have been declared by GoI vide Gazette notification on 19th Feb 2020. The reclamation of land is proposed from sea sand sourced from Daman coast which is at 65 kms Northward of proposed Port. The quarry material required for construction of port infrastructure have been identified from Palghar Taluka. **Proposed by** M/s. Jawaharlal Nehru Port Authority, Maharashtra, is as below;
