The Public Hearing for proposed expansion in Synthetic Organic Chemical plant of M/s. Lakeland Chemicals (India) Ltd., Plot No. 63, 6 A, 6 B, Rasayani Road, Madap Gaon, Dist-Raigad, was held on 29/06/2017 at 11:00 a m at Vishwaniketan (Institute of Management Entrepreneurship and Engineering Technology) Vishwaniketan Imit Campus, Survey No, 52, Savroli – Kharpada Road, Kumbhivali, Tal. Khalapur, Dist. Raigad. Shri. Kiran Panbude, Additional District Magistrate, Raigad, presided over the hearing as a Chairman of Public hearing panel.

Shri. Sachin Adkar, Sub Regional Officer, M.P.C. Board, Raigad-I and Convener of the Public hearing Panel welcomed the Chairman, Members, as well as the public present for the hearing. The list of panel members as well as the public present during the hearing is enclosed herewith.
