

**MINUTES OF ENVIRONMENTAL PUBLIC HEARING  
IN RESPECT OF M/S. SHREE BHAIRAVNATH EARTHMOVERS AND  
COMPANY, GHUNGUR; SHREE JUGAI MINERALS, GHUNGUR;  
SHREE MALHAR MINERALS, KOLHAPUR AND M/S. SHREE

FOR THEIR  
PROPOSED LATERITE MINE PROJECTS AT GHUNGUR, PARALI,  
PARKHANDALE, AMBARDE AND SAVARDE BUDRUK,  
TAL: SHAHUWADI, DIST: KOLHAPUR  
(MAHARASHATRA STATE)**

Public hearing for the proposed laterite mine project of M/s. Shree Bhairavnath Earthmovers and Company, Shree Jugai Minerals, Shree Malhar Minerals and Shree Kedarnath Mining and Earthmovers Co. at village Ghungur, village Parali, village Parkhandale, village Ambarde and village Savarde Budruk, Tal. Shahuwadi, Dist: Kolhapur was conducted on 27-10-2017 at 11.00 A.M. at Shree Sant Dnyaneshwar Madhyamik Vidyalay, Ghungur, Tal: Shahuwadi, Dist: Kolhapur.

The proceedings of the environmental public hearing is as follows.

First of all, the convener of the environmental public hearing Mr. R.S.Kamat welcomed the people present for the public hearing and with the permission of Hon'ble Chairman started the public hearing. He informed that the environmental public hearing committee takes note of the objections/instructions/views of the public but does not take any decision regarding permission to start the project or with held the project. Today's

public hearing is conducted as per the Notification of MOEF, Govt. of India of 2006, amendment 2009 and 2016 for which the project proponent had submitted the proposal to M.P.C. Board. After receipt of this proposed at MPCB, with due approval of the Hon'ble District Magistrate, Kolhapur M.P.C. Board had published the notice in Daily 'Pudhari' in Marathi language and in 'Times of India' in English on 26-09-2017 regarding today's environmental public hearing. As mentioned in this notice, the copies of EIA report was made available for study of the public at Collector Office, Kolhapur; District Industries Centre, Kolhapur; Zilla Parishad, Kolhapur; Tahsil Office, Shahuwadi; S.D.O., Panhala; Forest Department, Kolhapur; Malkapur Municipal Council; Regional Office, MPC Board, Kolhapur; H.Q., MPC Board, Mumbai; Grampanchayat, Ghungur; Grampanchayat, Parali; Grampanchayat, Parkhandale, Grampanchayat, Ambarde; Grampanchayat, Savarde Budruk; Tal: Shahuwadi and Grampanchayat, Bandivade, Tal: Panhala, Dist: Kolhapur and requested public to submit their verbal/written objections, suggestions, views of the public to MPC Board. These objections, suggestions etc. will be recorded in the minutes of this public hearing. He further informed that this environmental public hearing committee has no right to take any decision whether grant permission or not to the proposed project but only to record the views, suggestions, complaints, etc. in the minutes of the public hearing and send it to Environment Department, Government of Maharashtra through proper channel. Hence, people should raise queries peacefully. Then, with the permission of Hon'ble Chairman of the Environmental Public Hearing Committee, he requested the technical consultant of the project proponent to start the presentation regarding proposed project.

Thereafter, Dr. Prashant Banne, technical consultant gave presentation with the help of slide show.

After presentation Mr. Dilip Khedkar, Member requested people to ask questions, objections, suggestions from environmental point of view only and informed that these objections will be recorded in the minutes of public hearing and the same will be submitted to the Environment Department, Government of Maharashtra.

Thereafter, Hon'ble Mr. Avinash Subhedar, District Magistrate, Kolhapur cum Chairman of the environmental public hearing addressed people that they should understand the importance and limits of the environmental public hearing. He informed that earlier projects were started without environmental public hearing, then the Environment Protection Act was amended in 2006, in which it was provided that the environmental public hearing of such projects must be held at the project site. This committee has no right to give any permission to the proposed project. The views of the public will be recorded in the minutes of the public hearing and the same shall be submitted to the government and the government will take decision whether permission to be granted or not. As explained by the project consultant, the proposed project site is a plateau which is situated at the height of 70 to 80 metres and the laterite mining will be up to 11 metres deep only, on this plateau, there are less trees and as the project consultant explained, there will be no damage to the forest land. Proposed project will generate jobs. It should be noted that from C.S.R. funds, every year

Rs. 52 lakhs will be spent for developments of villages, basic needs of the villages will be fulfilled and also facilities of roads, health, and water supply will be provided. Considering the explanation given by the project consultant, those who support the proposed project and those who do not support the proposed project can submit their written representations to the committee. I hope you will cooperate us in conducting this public hearing smoothly and peacefully.

Thereafter, following discussion/question answers were held.

**Q. 1. Mr. Tanaji Maruti Ravande, village Savarde Budruk, Tal: Shahuwadi, Dist: Kolhapur.**

I want to express my views orally and submit written complaint. The information given by the technical consultant is completely false and there is no fact. Laterite is available at a distance of 2 to 3 meters. For that there is no need of excavation up to 11 mtrs. deep. It must be noted that the 25 to 30 villages located around the proposed project have no other source of water. Also the technical consultant told that there are no trees in this jungle. This company had cut down 1000 trees in 2016. Instead of filing criminal complaint against them, today's public hearing is conducted. We have filed complaints to D.O. office regarding this matter, but no any action taken on the company. It is told that many people will get employment. In this taluka employment guarantee schemes are carried out. It has been come to know from D.O. office that not a single employment guarantee scheme is carried out. in these five villages. This means that these people do not want employment. If your want to provide employment, give it by way of tree plantation. Forest Department cannot give even one acre land to village for building water tank and how can it give 110 hectares of land to a private company ? The technical consultant told that there is no any water scheme, but I have all proofs which show that there is water source . Department of Ground Water Authority, Kolhapur has issued report to the project proponent that there is no water in the project area, but I can show you the proofs by visiting the various locations there. How can you say that there is no water ? Excavation will be 11 meter deep, but water is available on top. There are lot of animals in this jungle which can be seen from cameras of Forest Department. I have footages which I wish to submit to the committee. Secondly, MPCB had handed over documents regarding this public hearing to five grampanchayats for study of people, but neither grampanchayat nor tahasildar kept the documents to show us. When we went to see these documents, they arrogantly got us out of the office and threatened to file false criminal complaints against us. We can show that the presentation shown by the technical consultant of the proposed project is totally false, there is no fact. All public present here should oppose the proposed project.

**Q.2. Mr. Shahaji Patil, village Telave, Tal: Shahuwadi , Dist: Kolhapur.**

I support the proposed project. It was told that laterite can be found up to 4 meters, hence, excavation will be carried out up to 4 meters, soil will not be sold. Trees cannot grow on this type of laterite. As per scientist trees can be grown on laterite after deposition of soil by air movements. There is problem of water shortage of these 4 to 5 villages. People are cultivating land.

People of this area have left their villages for doing labour work like at various places. The proposed project will provide source of employment for these people and for good education in future to their children. If people should have not understood the concepts of the proposed project it can be briefed. The proposed project is beneficial for the people of this area and their future generations. In past when sugar factory was proposed to establish in this area, some persons took objection for that project, today also these persons are taking objection to proposed mine. Now, after these 20-25 years, if we talk to the farmers and the youngsters in that year, we can see that there is lot of development in their life. I expect that after 2 to 3 years when bauxite is taken out the project proponent will plant trees including fruit bearing trees on that area. The C.S.R. fund should be utilized for education, well being of people, medical facilities. I expect that the project proponent will arrange seminars for youngsters to guide them for taking higher education. I request project proponent that in addition to funds from CSR, they should provide more funds to help people in this area for taking education.

**Q.3. Mr. Ranvirsingh Mansingh Gaikwad, Director, M/s. Udaysingh Rao Gaikwad S.S.K Ltd., Tal: Shahuwadi, Dist: Kolhapur.**

In this area, there is a lot of issues of unemployment. In this taluka, there is only one industry i.e. M/s. Udaysingh Rao Gaikwad SSK Ltd. in which about 1000 employees are working. Except this, in this taluka there is no other large industry. From last 12 years, Shree Yuvraj Patil and Shree Bajirao Savale, Sarpanch are taking efforts to establish this proposed project. They are taking continuous follow up to start this project, to make development of this area and to solve the problem of unemployment. Hence, myself and on behalf of the sugar factory I express support to the proposed project. In India, presently unemployment is a big problem, and to face the problem of rising prices, farmers also needs employment. Childrens of farmers in this area are leaving this place for doing labour work in Pune, Mumbai, Kolhapur cities. The government should give permission to the proposed project which will help to develop the area. I request to give permission to the proposed project.

**Q.4. Mr. Ashok Dhondiram Khot, village Ghungurwadi, Tal: Shahuwadi, Dist: Kolhapur.**

I have objections to the proposed project because of serious problem of water shortage to the 20 villages located around the proposed project. These villages receives water by siphon technique through trenches from hilly area and not by installing motors. Hence, there will be big problem of water shortage. People should object to the proposed mine otherwise our villages will be destroyed, farmers will commit suicides, and we must think about our children and take objection against the proposed project. Water for our agriculture land is not supplied from river but it comes directly through trenches from hilly area. There is no any river water supply scheme to our villages. If water source is destroyed due to this mining activity, how can our agricultural crops will grow ? this we must think about. Concerned officers should actually see the hill area instead of looking photographs. Drinking water supplied by siphon technique. Due to the proposed project there will be

air pollution which has bad effects on health and will cause diseases like cancer. No crop will properly grow if dust particles settle on the leaves of the crops. If there is no agricultural production, what is the use of employment? Due to this project, water for drinking and agriculture will stop. As promised, no ambulance, clinic facilities will be provided. Till today, no such facility has been provided. We have to go to Kolhapur city for medical treatment for which there is no other option. Don't fall for baits given for this project. Cutting of trees will have adverse effect on rainfall. It will become difficult to grow crops in absence of rain. Cutting of trees will also cause insoil erosion, who will stop it? This is an historical place, we all have to take responsibility to retain natural beauty of the Sahyadri. There will be serious consequences if we destroy this.

**Q.5. Mr. Tanaji Ravande, Tal: Shahuwadi, Dist: Kolhapur.**

A day before yesterday, a G.R. has been published in daily 'Pudhari' in which it is mentioned that village Parali, village Ghungur, village Savarde Budruk and other 72 villages in Shahuwadi taluka have been declared as reserve forest area. Copy of that G.R. is in my hands now. And hence, no permission to any kind of mine should be granted on this land. If permission is given, a tragedy like Malin can take place in this area. Because in this hilly area there are habitations of 25 villages. About 550 trucks will run on the roads in this taluka. The cases of accidents in this taluka are high which will increase due to proposed project. And there is possibility and danger of deaths of our own children.

**Q.6. Mr. Pradip Bhikaji Kamble, village Savarde Budruk, Tal: Shahuwadi, Dist: Kolhapur.**

Cutting of trees in the area of 110 hectares of land for the proposed project will create a big problem of water shortage. All percolations lakes are only found across these jungles. On page No. 28 of the E.I.A. report of the proposed project, it is mentioned that there is no any percolation lake. Next to it, it is has been also mentioned that borewell is a source of water for all these five villages. We say that Hon'ble District Collector, S.D.O., Tahsildar should visit the site, carry out inspection and give justice to the farmers. We say that permission should not be given to the proposed project.

**Q.7. Mr. Mahadev Tukaram Bade, village Savarde Budruk Paiki Ganewadi, Tal: Shahuwadi, Dist: Kolhapur.**

The forest land in village Savarde Budruk also comes under the proposed mine area. Some people said that the drinking water schemes run through the forest land which I know. In the year 1965 water schemes for village Pishavi and in 1978 water scheme for village Savarde Budruk, Partale villages were approved. At that time the population of these villages were less. Today the population of village Pishavi is more than 5000 and their need of water is more which is not satisfied by forest department water schemes and hence, they bring water from river Kadavi. If their need is fulfilled by the water which is available in mining area then why they lift water from river? In the months of March, April, May and June, water is purchased at Rs. 5/- to

10/- per can in village Savarde. This water is used for various purposes like drinking, washing cloths, washing of cattles etc. and reused. The mine site is totally rocky. Because of unemployment in this taluka, villagers have left their homes and settled in Kolhapur, Mumbai. To give them jobs in their own village/area, this proposed project must start. To solve the problem of drinking water, schemes to lift water from river Kadavi should be prepared. Previously, there was no water in river Kadavi but after construction of Chandoli dam the river is full of water. The government officers and peoples representatives should supply drinking water to us from this river. Our need of water will not be fulfilled by the water sources in the mining area. Hence, the proposed project must start.

**Q.8. Mr. Shivaji Mahipati Kesarkar, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

I work as a porter in Kolhapur city. We must get employment opportunities in our own village. Those who are opposing the proposed project had started an institute and thereby collected money from poor local people. But they closed that institute and did not returned the money. Our children are working in Kolhapur, Pune as porters. The proposed project must start.

**Q.9. Mr. Mansingh Savare, Social Worker, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

I totally oppose the proposed project. As a social worker I have studied lot of things minutely. I thought there is need of employment in this area because during survey, it was found that there are 350 families which hold job card. Afterwards, I came to know that these people do need employment. They have not applied for employment to grampanchayats. Under employment guarantee scheme daily wage rate is Rs. 200/- but they are working in hotels for Rs. 50/- Even though they can get employment under employment guarantee scheme, they are not ready to apply for the same which means that they do not need job. If they need job, why they have not applied for it for last five years ? Why did employment guarantee scheme fail ? Why are we thirsty ? In the last 10 years, no forest officer have undertaken work of excavation of trenches, projects of employment, building bunds, water storage. I object the proposed project. It will cause various diseases and there is no guarantee of employment generation even if we feel so.

**Q.10. Mr. Prakash Kamble, Tal: Shahuwadi, Dist: Kolhapur.**

In Shahuwadi taluka, there are already seven bauxite mines in existence. So many people in western part of Malakapur including truck owners, tractor owners, drivers, cleaners, tyre puncture workers, hotel owners are dependent on these mines. Their problem of employment and livelihood has been solved. Because of closing down of Udgiri bauxite mine, loan instalments payable to finance companies by the truck owners have stopped, and hence, they have seized trucks from defaulter truck owners. Shahuwadi taluka is remote place and backward taluka. In this taluka, there is no other

industry except one M/s. Udaysingrao Gaikwad S.S.K. Ltd. And hence, there is high rate of unemployment. People in this taluka are working in Pune and Mumbai. To create employment opportunity, such type of projects are necessary to start in this taluka by maintaining ecological balance. To solve the problem of drinking water, there should be lift irrigation scheme to lift water from river. Also, there is a proposed project of M/s. Udaysingrao Gaikwad S.S.K. Ltd. to provide water to various villages. Projects beneficial to local people and also creating job opportunities should be started in this taluka. I support the project.

**Q.11. Mr. Deepak Ananda Patil, Ex-Dy. Sarpanch, village Nanundre, Tal: Panhala, Dist: Kolhapur.**

I have come here to support the proposed project. I support the project because the son of the farmer from this area is going to start it. I request that we all should support the project because it will maintain ecological balance. We should see that there will be development of this area once the proposed project starts. I support the proposed project on behalf of residents of Panhala taluka.

**Q.12. Mr. Rambhau Methe, village Kerle, Tal: Panhala, Dist: Kolhapur.**

We support the proposed project because this area will certainly develop once it starts. Shahuwadi and Panhala are remote talukas. People here face various difficulties because financially they are not so strong and they will overcome these hardships completely.

**Q.13. Mr. Tukaram Khutale, Tal: Shahuwadi, Dist: Kolhapur.**

The proposed project is located in five villages of Shahuwadi taluka. Hence, people from Panhala taluka should not speak here. They should develop their own taluka, instead of talking about development of Shahuwadi taluka.

**Q.14. Mr. Shivaji Anna Khot, village Parakhandale, Tal: Shahuwadi, Dist: Kolhapur.**

This environmental public hearing is held for five villages of Shahuwadi taluka in which it is not relevant to express views by people other than these five villages. Not even an inch of land belonging to village Parkhadale will be given for the proposed project.

**Q.15. Mr. Vishwajit Mahajan, Tal: Shahuwadi, Dist: Kolhapur.**

All dignitaries told that there will be development of Shahuwadi taluka after the proposed mine starts. But they should tell us what development took place in village Ringewadi, village Udgiri and village Girgaon due to bauxite mines which are running from last so many years. Development of few contractors does not mean that development of common people. We oppose the proposed project on behalf of Swabhimani Shetakari Sanghatana and

Hon'ble Member of Parliament Mr Raju Shetty and we will oppose the project till end. In order to develop this taluka we have to stop mining activities and efforts should be made to start environment friendly projects and tourism activity. The developing countries are based on tourism only. Those countries which have mining activities are not developing. Till now, there has been a lot of deterioration of our taluka and if this continues the taluka will be totally destroyed.

**Q.16. Mr. Mrkant Appaji Khot, Village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

I am from farmer family. I have total nine acres of agricultural land and out of that land, I cultivate sugarcane crop on two acres. In the month of May, we do have enough water for our crops. The expenditure incurred on cultivation is more than the agricultural income. Hence, we are not able to feed our family on agriculture. We do not have financial condition to take patients of our family to the hospital. In this area, 75% people are educated but unemployed. For that purpose, the proposed project should start.

**Q.17. Mr. Rangrao Krishna Kite, Village Savarde Budruk, Tal: Shahuwadi, Dist: Kolhapur.**

The proposed project must start, we all fully support the project.

**Q.18. Mr. Tanaji Ramrao Bhoasale, Village Bandivade, Tal: Panhala, Dist: Kolhapur.**

I support the proposed project.

**Q.19. Mr. Sardar Vasant Kamble, Village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

Although I am resident of this village, my father is settled at another place since last 40 years. The only reason is that there were no opportunity for employment in this taluka till today. I am student of science faculty. We have to plant trees and raise them to save the environment. I support the proposed project to boost development.

**Q.20. Mrs. Madhuri Yashwant Mane, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

The proposed project must not start in Ghungurwadi village. This hilly area is like a heaven for us. Government encourages scheme of tree plantation. But due to proposed project, trees will be cut down. Hence, the proposed project should not start.

**Q.21. Mr. Sagar Dagadu Kesarkar, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

In the year 2012, the scheme of Maharashtra Rajya Gramin Abhiyan was launched which was meant for imparting training and creating employment opportunities. The scheme got closed in six months. I was a trainer at Karveer Panchayat Samiti. We got job for six months only and we are unemployed from last four years. Due to proposed project we will get job in our own village and hence, the government must approve the project.

**Q.22. Mrs. Savita Shamrao Khot, village Ghungurwadi, Tal: Shahuwadi, Dist: Kolhapur.**

We oppose the proposed project. Our village will be destroyed, we have no drinking water.

**Q.23. Mrs. Rekha Bajirao Patil, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

We oppose the proposed project. Our five villages will not get drinking water if the project is started. It must not start.

**Q.24. Mr. Shantaram Ramchandra Patil, Village Nandari, Tal: Shahuwadi, Dist: Kolhapur.**

We express full support to the proposed project. The project will not cause any kind of damage. It is necessary to start the same.

**Q.25. Mrs. Geeta Sambhaji Patil, village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

We do not support the proposed project.

**Q.26. Mrs. Kalpana Yuvraj Patil, Village Ghungur, Tal: Shahuwadi, Dist: Kolhapur.**

We support the proposed project.

**Q.27. Mr. Bajirao Redekar, village Nandgaon, Tal: Shahuwadi, Dist: Kolhapur.**

I support the proposed project. It will be started as per rules of the government.

**Q.28. Mrs. Manisha Nivrutti Sutar, village Ghungurwadi, Tal: Shahuwadi, Dist: Kolhapur.**

We support the proposed project.

**Q.29. Mr. Yashwant Pandurang Sutar, village Ambarde, Ex-Member of Panchayat Samiti, Tal: Shahuwadi, Dist: Kolhapur.**

We have four small habitations which have no approach roads. It becomes difficult for us to carry ill persons and pregnant womens. Proposed project should start as it will provide us our livelihood. We support the proposed project.

**Q. 30. Mr. Dnyaneshwar Sutar, Ghungur.**

The proposed project should comply with environmental conditions and and it should start.

After above discussion, Mr. Dilip Khedkar, Member instructed technical consultant of the proposed project to give explanation regarding questions asked by the public and written representations/complaints. Thereafter, Dr. Banne tried to explain about the objections/complaints but people present started messing around by shouting hence he could not be able to reply all the questions/complaints/objections.

Thereafter, Mr. Dilip Khedkar, Member informed that the committee has recorded all the objections, suggestions, comments, questions raised by the public which will be included in the minutes of the public hearing. Then he requested Hon'ble Chairman of the public hearing to express his views. Thereafter, Hon'ble Chairman said that the views of public gathered here have been recorded by the committee and all written representations and video recording of the environmental public hearing will be submitted to Government of Maharshta. Finally, Hon'ble Chairman thanked all and concluded the public hearing.

The copies of written representations received by the Board before the public hearing and also at the time of public hearing are enclosed with these minutes. Also, the Board has received written representations in respect of the proposed project after the public hearing, the list of which is enclosed separately with the minutes.

In addition to above written representations, some citizens have approached the Regional Officer cum Member of the Environmental Public Hearing Committee and have raised objections about the proposed project during the course of discussion with the Regional Officer. Thereafter, the Regional Office vide his letter dated 23.10.2017 communicated the Sub Regional Officer cum Convener of the Public Hearing about these oral objections and instructed him to include the same in the minutes of the meeting. These objections are as follows.

1. It is mandatory to conduct the public hearing within 30 days from notice excluding public holidays. This has not taken into consideration by the Board resulting in time period less than 30 days. Hence, the proposed

public hearing should be cancelled and public hearing should be conducted after including public holidays in 30 working days.

2. The proposed mines are located in the areas of different villages. This is not cluster mining area. Hence, the project proponent has give false information.
3. There should be separate EIA report for each mine.
4. If all above mines comes under one cluster then at the time of preparation of EIA report then why present operating mines not considered in the said report.
5. The rivers located near the project site are not mentioned in the EIA report.
6. Project proponenet has not submitted IBM plan.
7. No proper noise and air pollution control measures have been taken.
8. It has been not mentioned about effect of transporation together.
9. There is no mention of archaeological sites like Pawan Khind, Panhala to Pawan Khind, Masai cave, Vishalgad in the E.I.A report.
10. There is no information about weather, wind direction, speed etc.
11. Is there road for mine ssite? It has not been shown in the map.
12. The distance from National Tiger project area and nearby sanctuary not mentioned.
13. Details of distance from ESA and ESZ from the proposed projects not mentioned.
