Shri S. A. Redasni, Sub Regional Officer, MPCB, Nashik and Convener of the Public Hearing Committee welcome the Hon'ble Chairman of the public hearing committee, company officials and public who were present in large number and informed that as per the EIA Notification of Ministry of Environment, Forest & Climate Change, Govt, of India, (i.e. MoEFCC, Gol) dated 14th September, 2006 as amended on 1^{s1} December, 2009, it is mandatory to conduct prior public hearing to certain projects which are covered in the Schedule of the said Notification and as per EIA Notification, 2006.

The Convener of the Public Hearing informed that, M/s. M/s. Indian Oil Corporation Ltd:, Manmad Terminal , Manmad Nadgaon Highway , Village Nagapur Tal. Nadgaon Dist. Nashik, has submitted an application for conducting the public hearing for proposed expansion of isolated storage terminal with additional storage tanks for 42,940 KL HSD; 15,000 KL HSD (B5), 53,858 KL MS; 70 KL SKO; 1442 KL Ethanol and 540 KL Bio-diesel at Manmad Bulk Petroleum Terminal, Manmad Nandgaon Road, Village Nagapur, Tal. Nandgaon, Dist. Nashik, Maharashtra, at the site of the company.

The aim of conducting the public hearing is to make aware the local people participant in the hearing and they should know the developmental activities and environment management plan of the unit. The project proponent had submitted prescribed application along with pre-feasibility report to the MoEFCC, GoI for Terms of Reference.

As per said Notification, the Public hearing is mandatory & on this grounds today's public hearing is arranged. The Convener further informed that the suggestions and objections raised during the meeting will be incorporated in the minutes of the meeting and will be submitted to Central Government through HQ, MPCB Mumbai.

The Convener and SRO MPCB Nashik, requested the Chairman of the Committee to permit to start the proceedings.

The Chairman of Committee and Addl. District Magistrate, Nashik informed officials of the project to explain the details of pollution control devices and environment management plan of the project in local language Marathi. He also appealed general public to give objection / suggestion if any about the proposed project after their technical presentation.

The Project Proponent has given the presentation of the proposed project and Environment Management Plan in detail as hereunder,-

Project information:

1. INTRODUCTION:

Indian Oil Corporation Ltd., (IOCL) is country's largest commercial enterprise and flagship national Oil Company. IOCL propose for the an installation of isolated storage tanks thereby expanding fuel storage capacity of High Speed Diesel (HSD), Motor Spirit (MS), Superior Kerosene Oil (SKO), Ethenol and Biodiesel at Manmad Bulk Petroleum Terminal, Manmad Nandgaon Road, village Nagapur, Tal. Nandgaon, Dist. Nashik, Maharashtra.

2. PROJECT DESCRIPTION:

The project is classified as Category 'B 'project. The proposed project falls under Schedule Project activity Service Sector. "6(b)-Isolated storage & handling of hazardous chemicals (as per threshold planning quantity indicated in column 3 of schedule 2 & 3 of MSIHC Rules 1989 amended 2000)" as per EIA Notification 2006, as amended till date.

3. PROPOSED PROJECT:

Currently, Manmad Terminal has cumulative storage capacity of 22376 KL for MS, SKO, Ethanol, Bio Diesel and HSD, Proposed expansion will increase cumulative storage capacity of Manmad depot by 113850 KL i.e. total cumulative storage capacity will be 136226KL.

Out of total 11 existing tanks 6 tanks will be converted and rest 5 tanks will remain same. Additional 15 tanks will be installed.

After proposed expansion, there will be total 26 storage tanks.

4. ENVIRONMENTAL MANAGEMENT PLAN:

Environmental Management Plan for suggested mitigation measures and monitoring plan will include:

- Review of Compliance of EMP, EC & statutory conditions in the management meeting.
- Preparation and timely submission of required statutory reports and Cess.
- Proper hazardous waste inventory accounting by HSE department.
- Monitoring for reduction in air emissions generation of hazardous waste quantity by concerned department heads as per QMS developed by IOCL.
- Reviewing time bound action plan for imparting training to drivers and availability of TREM cards.
- Review annual performance of EHS in board meeting.
- An Environmental Cell with adequate professional expertise and resources shall be established to discharge responsibilities related to environmental management including statutory compliance, pollution prevention, environmental monitoring etc.,

IOCL-Manmad Terminal is/will have Environmental Management Cell headed by Dy. General Managerr-HSC and supported by Chief Terminal Manager & Managers at Manmad-Terminal.



5. CONCLUSION:

Based on the EIA study conducted in Summer Season of 2017 and as per terms of reference given by SEAC dated 15th July, 2017, the following highlights emerge:

- There are no Protected Areas, Critically polluted areas, Eco-sensitive areas, inter-state boundaries and international boundaries located in d10 km of study area from the proposed project site.
- There will be negligible pollution potential on air, water and noise environment, which, with the implementation of the mitigation measures and EMP, can be reduced considerably.
- The proposed project activities will have positive beneficial effect on the local population, economic output and other related facilities viz. employment, development of business, transportation etc.,
- Rapid risk assessment including emergency response plan and DMP has been prepared to handle any sort of emergencies.

The Chairman of the Public Hearing Panel informed that, Govt. has given plantation target of 13 corers. On the eve of World Environment day, plantation programmes are undertaken. Company and villagers should jointly undertake the plantation programme outside the premises of the company, near the Grampanchayat premises.

The Representative of the company informed that, if the villagers dig the trenches company will provide the plants.

The Chairman of the Public Hearing Panel suggested to take due care of plants by the villagers.

The representative of the company informed that, preservation of the plants is very important. The water will also be supplied through tankers by the company. The suggestion regarding availability of the Ambulance is also very good and we welcome the same. We will try through our management make available Ambulance through the oil companies and we'll provide one stand by ambulance.

> The Chairman of the public hearing panel suggested that, it will be appropriate that, each of the oil company should make available the ambulance, it is not so costly. Recently, through the help of Powergreed co., one ambulance and one school bus is made available to Grampanchayat Awankhed. It is large light

Anil Ragho Kangar, Member Grampanchayat Dhotane and project affected farmer of the Indian Oil bottling plant pointed out that, job preference may please be given to the local residents in this project. The partly rehabilitation is undertaken. Complaints in this respect are frequently made to the Collector Office. The project affected are very dissatisfied. One day it will come out hence due care shall be taken. Six people are permanent by Indian Oil Helpage Group and they are getting 80,000/- salary per month and I am nowhere. He demanded for the rehabilitation of the project affected. It is necessary to sort out this issue. The TTs after filling parked directly on the road side, the General Managers of all the 3 companies should take due care so that, the filled TTs should be go away without any stoppage and will help to avoid accidents.

Regarding job opportunities to the project affected, he informed that, he is project affected and descendent also.

Further, he demanded to call a meeting of project affected and find out the solution being a District Rehabilitation Officer. Further, he informed that, till the rehabilitation of the project affected is not done the NOC of the Grampanchayats shall not be given for the proposed additional storage.

Shri. Sudhakar Dhondu Pawar r/o. Nagapur informed that, he has written a letter to PWD for putting the road dividers but they've informed that, this road is National Highway so they're unable to put the road dividers. This issue is in the purview of the District Collector, so he demanded to put the road dividers around the company and in the vicinity of Nagapur.

Further, he informed that, company is established since long years but the job opportunity isn't given to the project affected. The Grampanchayats shall not issue any NOC to the company, till the job opportunity isn't given to the project affected. The company has not made payment of their land to the project affected and demanded for action in this matter.

The Chairman of the Public Hearing Panel informed that, in 2011 year, the Rehabilitation Act has been changed. According to this Act, the certificates are issued to the project affected persons. But in case the land is given for another reason (not for dam) in 5% job that case, opportunities in Govt. establishments reserved. 5% posts are reserved for the project affected, but they've to face examinations also and we have to qualify according to the norms of State Govt. or Central Govt. ventures.

The Chairman of the Panel informed that, before leaving office, he has intimated the District Collector in this matter.

The Chairman of the Public Hearing Panel informed that, as per the directions of the Ministry of Surface Services, speed breakers are banned for State / National Highways but Road Safety Committee is constituted under the Chairmanship of District Collector. He advised to concerned the Grampanchayats submit their resolution to the concerned RTO at Nashik / Malegaon for discussion in the meeting and as per the decision of the committee the action regarding putting the speed breakers is taken accordingly.

The Chairman of the Public Hearing Panel informed that, this expanded project is to be established on the acquired land. If newly project is coming at that time, NOC is required for

He requested to give necessary instructions to the company authorities for giving priorities to the local residents.

He demanded to give priority to the labour institutions in providing contract labour so as to control the whims and wishes of the contractors and to restrict him from suspending the contract labours. He further, informed that, in other time, they are not getting an opportunity to express their thoughts, and now they are submitting their demands in your witness for telling the concerned officers. The trees are cut down for this project and demanded for plantation so as to maintain the environment equilibrium and to help the villages in the vicinity for progress through the CSR Funds.

Shri. Pandharinath Bhilaji Kakad, Ex. Sarpanch of Kari, he mentioned that, people have been called for this public hearing to listen their view, comments, suggestions etc., I would like to thank the concerned on behalf of Sarpanch and villagers as you are considering us. Secondly, 11 storage tanks are provided and 15 additional storage tanks will be provided and same are installed in the acquired land that's why we do not have any objection. The assured plantation should be done. The plants should be provided along with the tree guards to Grampanchayats, High School and Primary Schools and responsibility of the preservation of the plant shall be fixed on the concerned Grampanchayat and school. He demanded help from the company for providing compound wall to the school, to make available the Ambulance in his village for the utilization to the surrounding villages also, shed for the bus stop. He further raised a query that, there will be any adverse effect on the rain due to installation of additional 15 storage tanks. He further raised a query regarding making compulsory rain water harvesting to the School, College and Public Buildings so as to increase the ground water level. He demanded to issue the order from the District Collector to ban the tree cutting. He demanded subsidy for the water harvesting programme for increasing the involvement of the general public. He suggested to the company to pay more attention regarding plantation.

He further pointed out that, their land is acquired, judgment is coming out after a lapse of sufficient time period but no any payment is made. Now father become older, I am also in 30s when will we get the amount? The land of my father is acquired and amount will be given to our son/s or otherwise.

The Representative of the factory informed that, the trees are cut down with the permission of the forest department and they will plant 10 times of trees in place of trees cut down. It will be useful, if the trees are planted near the rain water harvesting location. It will help for proper preservation and growth of the trees.

He assured that, the plants will be supplied along with the tree guards.

It is necessary to submit the solvency for withdrawal of the amount from the Court. He directed the company representative to make available the copy of the calculations to farmers.

He further informed that the point related to job opportunity to the project affected is discussed repeatedly so don't raise it again. It is directed to fix the date of the meeting

Rajendra Pawar, Ex Zilha Parishad Member raised a point that, at present in the area of 10 to 15 villages, no water is available in any bandhara and water is supplied after 8 to 10 days. 42 villages water supply scheme is completed and handed over by the Maharashtra Jeevan Pradhikaran is handed over to the samittee but so many villages facing difficulties for payment of the electricity and how can they pay the water taxes? If the water and electricity charges are not deposited towards the Samittee then later on this scheme will also be closed. The water source is only Nagya-sakya. He has requested to pay due attention so as to keep the said scheme in working permanently and how the flow of water will be increased so as to supply the water after 3 to 4 days inspite of after 11 days. He demanded that, either the company under the CSR fund should pay the electricity bill of the scheme or install water meters in every village and pay the water bill charges. In the summer, to take onion crop becomes so difficult due to shortage of water, hence demanded for cement plug bandharas in the concerned villages. A good work will come out through the help of Indian Oil Company. He further requested to handle the issue of traffic. Further, he thanked the Chairman, Public Hearing Panel for his contribution to make available the electric big pumps for the 42 villages water supply scheme.		The Chairman of the Public Hearing Panel regretted for not just thanking the chair as two electric pumps were made available for the 42 villages water supply scheme from the scarcity. Further, he assured that, the 42 villages water supply scheme is related to the one lakh population hence, necessary steps will be taken to sort out the issue.
