Convener of public hearing Mr. S. M. Kurmude, Sub-Regional Officer, Maharashtra Pollution Control Board, Jalgaon welcomed the Chairman of public hearing panel, Regional Officer, MPC Board, Nashik who was attending the hearing through video conferencing, Officers of Revenue Department and all citizens of Jalgaon District who were attending the public hearing through video conferencing. Then the public hearing was started with the permission of Hon'ble Chairman.

First of all, convener of public hearing explained that it is mandatory to obtain environmental clearance for certain type of projects according to the provisions of EIA Notification of Ministry of Environment, Forest and Climate Change dated 14/9/2006 and Amendment dated 1/12/2009 and environmental public hearing is mandatory before obtaining the environmental clearance.

Project Proponent Additional District Collector, Jalgaon has submitted proposal on 9/3/2020 along with requisite fee for conducting the environmental public hearing for proposed sand excavation activity at total 43 sand ghats of Jalgaon District.

Convener further explained that Mining Department, Central Government has published 'Sand Mining Frame Work, 2018' in March 2018. In which certain guidelines are given for sand excavation. Hon'ble National Green Tribunal (NGT) in its order dated 19/9/2018 in the matter of OA No. 368/2015 issued directions to coordinate with Ministry of Environment, Forest and Climate Change and to make necessary changes in the policies as per Sustainable sand Mining Guidelines, 2016 and Sand Mining Frame Work, 2018 and 2020 and to conduct environmental public hearing.

Convener of public hearing further narrated that the main purpose of public hearing is to get acquainted with the citizens' views about the various aspects of project and the effects thereof. Also to make people aware about the pollution control arrangements required in the project and the concerned rules, and to consider the views expressed during the public hearing.

According to the application received to MPC Board for conducting public hearing the dates of 21/4/2020, 22/4/2020 and 23/4/2020 were fixed earlier with the approval of District Collector, Jalgaon. The notice for the public hearing was published in Marathi Daily 'Lokmat' and English Daily 'The Times of India' dated 19/3/2020. Environment Department, Government of Maharashtra vide its letter number dated 4/5/2020 instructed to conduct public hearing of sand ghats through video-conferencing as lock-down is imposed by the Government due to ongoing COVID-19 outbreak. Accordingly, the Environmental Public Hearing for above mentioned 43 sand ghats of Jalgaon District is conducted on 18/5/2020 at 11.00 AM through video conferencing (Zoom App). The public notice for the public hearing was published in Marathi Daily 'Lokmat' and English Daily 'The Times of India' dated 8/5/2020.

Thereafter, District Mining Officer, Mr. Dipak Chavan gave a brief presentation on proposed sand ghats and measures proposed for pollution control during sand excavation.

After the presentation, convener informed that two representations were received through email from citizens regarding the public hearing of sand ghats. He then appealed participants to express their views, objections, instructions etc. through the video conferencing.
