Convener of public hearing Mr. V. P. Shelke, Sub-Regional Officer, Maharashtra Pollution Control Board, Latur welcomed the Chairman of public hearing panel and Additional Collector, Latur, I/c. District Mining Officer, Latur, Regional Officer, MPC Board, Aurangabad who was attending the hearing through video conferencing (Webex App) and all Participants who were attending the public hearing. Then the public hearing was started with the permission of Hon'ble Chairman.

First of all, convener of public hearing explained that it is mandatory to obtain environmental clearance for certain type of projects according to the provisions of EIA Notification of Ministry of Environment, Forest and Climate Change dated 14/9/2006 and Amendment dated 01/12/2009 and environmental public hearing is mandatory before obtaining the environmental clearance.

Project Proponent District Mining Officer, Latur has submitted proposal on 21.07.2020 along with requisite fee for conducting the environmental public hearing for proposed sand excavation activity at total 05 sand ghats of Latur District.

Convener further explained that Mining Department, Central Government of India has published 'Sand Mining Framework, 2018' in March 2018. In which certain guidelines are given for sand excavation. Hon'ble National Green Tribunal (NGT) in its order dated 19/9/2018 in the matter of OA No. 368/2015 issued directions to coordinate with Ministry of Environment, Forest and Climate Chang, New Dilhi and to make necessary changes in the policies as per Sustainable sand Mining Guidelines, 2016 and Sand Mining Frame Work, 2018 and to conduct environmental public hearing. However, convener informed that as per letter dated 03.12.2019 issued by Environment Department Mantralay Mumbai. It is mandatory for to conduct public hearing for obtain prior environment clearance for sand ghat project.

Convener of public hearing further narrated that the main purpose of public hearing is to get acquainted with the citizens' views about the various aspects of project and the effects thereof. Also, to make people aware about the pollution control arrangements required in the project and the concerned rules, and to consider the views expressed during the public hearing.

According to the application received to MPC Board for conducting public hearing the date of 31.08.2020 was fixed earlier with the approval of Additional Collector, Latur. The notice for the public hearing was published prior before 30 days in Marathi newspaper Daily 'Sakal' and English newspaper Daily 'Times of India' dated 28.07.2020. The documents containing EMP, Ex Summery of proposed sand ghats were made available at the respective grampanchayats and other Government offices as given below for the knowledge of the people.

After the presentation, Convener informed that there is no any Suggestion/objection were received at Sub Regional Office, Maharashtra Pollution Control Board, Latur from citizens regarding the public hearing of sand ghats and requested to all participant if any questions in view with Environmental angle they can ask with his name & address.
