The public hearing for proposed expansion project of molasses based distillery from 45 KLD to 90 KLD in respect of M/s. Loknete Sunderraoji Solanke Sahakari Sakhar Karkhana Ltd., At Village Sundernagar, Po. Telgaon, Tal. Dharur, Dist. Beed, Maharashtra was conducted under the Chairmanship of the Residential Deputy Collector, Beed on 17th July, 2020 at 11.00 a.m. at the Collector Office, Beed. Dr. Yoginee Balankhe, Sub Regional Officer, MPCB, Jalna and Convener of the Public Hearing Committee welcome the Hon'ble Chairman of the Public Hearing Panel, officials, public representatives and public who were online present and with the permission of the Chairman of the Public Hearing Committee she gave information in brief about the said proposed expansion project of molasses based distillery from 45 KLD to 90 KLD in respect of M/s. She informed that, as per the EIA Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEFCC, GoI) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory to conduct prior public hearing to certain projects which are covered in the Schedule of the said Notification and this unit is also comes under the purview of this Notification.

The Project Proponent has submitted an application to the Maharashtra Pollution Control Board on 03.03.2020 for conducting the public hearing for proposed expansion project of molasses based distillery from 45 KLD to 90 KLD. As per said Notification, one month advance public notice was published in the local newspapers in "Daily Sakal" for Marathi and in national newspaper "The Times of India" for English on 6th June, 2020. The public were appealed to send their suggestions or objections regarding the project.

The District Magistrate and Chairman of the Public Hearing Panel has directed to conduct the said public hearing through CISCO WEBEX APP due to current COVID lockdown and corrigendum in this regard was published in "Daily Sakal" for Marathi and in national newspaper "The Times of India" for English on 16th July, 2020.

The Convener further informed that, the aim of conducting public hearing is to make aware local people who can be participanted in the hearing and they should know the activity to be carried out in the proposed expansion project of molasses based distillery from 45 KLD to 90 KLD in respect of M/s. Loknete Sunderraoji Solanke Sahakari Sakhar Karkhana Ltd., At Village Sundernagar, Po. Telgaon, Tal. Dharur, Dist. Beed, Maharashtra.

Convener and Sub-Regional Officer, MPCB Jalna has advised to take in hand plantation programme on large scale for preservation of the environment as well as go for Dense Forest type of plantation.

The Chairman of the Public Hearing Panel again appealed to the participants in the said public hearing to give suggestions, views, comments etc., if any? but nobody has raised any point.

The Convener of the Public Hearing Panel summarized the public hearing in brief.
