MINUTES OF THE PUBLIC HEARING FOR PROPOSED 20 NOS. OF SAND BELTS IN THE JALNA DISTRICT PARTICULARLY FROM MANTHA, PARTUR, GHANSAVANGI, BHOKARDAN, JAFRABAD TALUKAS:

The public hearing for proposed 20 Nos. of sand belts in the Jalna District particularly from Mantha, Partur, Ghansavangi, Bhokardan & Jafrabad Talukas proposed by the District Mining Officer, Jalna, Collector Office, Jalna, Maharashtra, was conducted under the Chairmanship of nominee of the District Magistrate i.e. Residence District Collector, Jalna on 27<sup>th</sup> October, 2020 at 11.00 a.m. at the Collector Office, Jalna. During the said public hearing chairman of the panal informed that this public hearing should be conducted for 19 sand ponds only by deleting one sand spot namely Changatpuri. Because Changatpuri area is more than 5 hectors. Hence the said public hearing is conducted for 19 sand spots in Jalna district. The said public hearing was conducted at Meeting hall at Collector Office Jalna as well as through online Cisco Webex App due to current COVID 19 situation.

Dr. Yogini Balankhe, Sub Regional Officer, MPCB, Jalna and Convener of the Public Hearing Committee welcome Hon'ble Chairman of the public hearing committee, officials, public representatives and public who were online present and with the permission of the Chairman of the Public Hearing Committee she gave information in brief about the said proposed 19 Nos. of sand belts in the Jalna District particularly from

Mantha, Partur, Ghansavangi, Bhokardan & Jafrabad Talukas proposed by the District Mining Officer, Jalna, Collector Office, Jalna, Maharashtra.

She informed that as per the EIA Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEFCC, GoI) dated 14<sup>th</sup> September, 2006 as amended on 1<sup>st</sup> December, 2009, it is mandatory to conduct prior public hearing to certain projects which are covered in the Schedule of the said Notification. The Addl. District Collector, Jalna has submitted application to the Maharashtra Pollution Control Board on 15.04.2020 for conducting the public hearing for proposed 19 Nos. of sand belts in the Jalna District particularly from Mantha, Partur, Ghansavangi, Bhokardan & Jafrabad Talukas proposed by the District Mining Officer, Jalna, Collector Office, Jalna, Maharashtra. The District Collector and Chairman of the Public Hearing Panel directed to conduct the said public hearing at Collector office, Jalna as well as through online App due to current COVID lockdown. The District Collector and Chairman of the Public Hearing Panel has nominated Shri Ankush Netake, RDC Jalna as Chairman of the said Public Hearing.

The Convener further informed that, the aim of conducting public hearing is to make aware, local people who can be participant in the hearing and they should know the mining activity to be carried out in the proposed 20 Nos. of sand belts in the Jalna District particularly from Mantha, Partur, Ghansavangi, Bhokardan & Jafrabad Talukas proposed by the District Mining Officer, Jalna, Collector Office, Jalna, Maharashtra and environment management plan for the said activity.

As per said Notification, one month advance public notice was published in the local newspapers in Daily Samana for Marathi and in national newspaper The Times of India for English on 26<sup>th</sup> September, 2020. The public were appealed to send their suggestions or objections regarding the project.

She appealed Chairman of the Committee to allow the Environment Consultant for giving the presentation & the Chairman directed to give the presentation in this matter.

The Regional Officer, Maharashtra Pollution Control Board, Aurangabad and Member of the Public Hearing Panel suggested to the Environment Consultant to give presentation in Marathi regarding Environment Management Plan. In response to this, the Environment Consultant has given the presentation of the project and Environment Management Plan in detail in Marathi. i.e. Environmental Clearance is sought for 19 sand belts located in Mantha, Partur, Ghansavangi, Bhokardan & Jafrabad Talukas in Jalna District. The said information is recorded in the CD and in the minutes of the hearing. The Notice for the said public hearing was published in the Daily Saamana in Marathi and in the Times of India in English & online link was communicated. As per Govt. of Maharashtra letter No. Sankirn – 2019 / p.k. 01 / Ta.K.3 dated Dec. 3, 2019, Public Hearing has to be conducted for mines Less than 5 hectares.

The District Collector Office Jalna vide WO. No. 2020/Mashaka/Gaukh/Kavi 105 dated 29/09/2020 has appointed M/s. Integrated Precision Systems & Services Pvt. Ltd., for obtaining environmental clearance for the sand belts in Jalna District (A) Tq. Mantha (3 nos.) – Village 1. Bhuvan Shirpur, 2. Devthana Uswad2, 3. Devthana Uswad3, (B) Tq. Partur (7 nos.) - Village 4. Dolhara, 5. Babai, 6. Nandra 7. Bramhawadgaon, 8. Golegaon, 9. Sawargaon Bu., (C) Tq. Bhokardan (4 nos.) - Village 10. Avhana, 11. Javkheda Thombre, 12. Nalni Bu., 13. Khadki, (D) Tq. Jafrabad (3 nos.) - Village 14. Pimpalkhuta, 15. Deulgaon Ugle, 16. Javkheda Theng, (E) Tq. Ghansawangi (3 nos.) – Village 17. Bhadli, 18. Jogladevi, 19. Ranjni Dist.Jalna

During presentation, consultant informed that in the said mining opencast manual method without drilling and blasting will be adopted. Only manual tools such as spade, Ghamelas will be used. The excavation of sand will be done from dry riverbed only. For control of air pollution periodic water sprinkling will be done on katcha roads, which will

be used for sand transport. The sand will be transported through tractor trolleys & trucks covered with tarpaulin. The mining and sand transport will be carried out during day time only for control of noise pollution. For control of water pollution sand mining will be carried out in dry riverbed only. The depth of mine pit will be maintained above river water level. The river streams will not be diverted to form inactive channels. The washing of vehicles in the river will be prohibited. Due care will be taken to avoid of the generation of any effluent from the mining activities. The mobile toilets will be provided to the workers. The mining will be avoided during monsoon and floods this will allow the sand deposit to replenish. For control of land environment mining will not exceeds beyond the allowed extraction capacity. The plantation will be developed along with the river bank and nearby the spaces. According to Green Belt Development Plan 150 trees will be planted. For occupational health safety management mine operators will be provided with personal protective equipments. The first aid kit will be provided at the mining site. The proposed project will provide indirect employment opportunities to local residents. Due care will be taken for protection of the environment.

After completion of the presentation, Dr. Yogini Balankhe, Sub Regional Officer, MPCB, Jalna and Convener of the Public Hearing Committee also the Chairman of the Public Hearing Panel appealed to the participants in the said public hearing to give suggestions, views, comments etc., if any? so as to enable to take the note of the same in the proceedings. Further, he appealed to the participants to inform name, address before raising any suggestions, views, comments etc., if any?
