MINUTES OF THE PUBLIC HEARING FOR PROPOSED EXPANSION OF SYNTHETIC ORGANIC CHEMICAL AT GUT NO. 8, 13, 15, 16, 25, 75, VILLAGE – HONAD, TAL – KHALAPUR, DIST – RAIGAD, MAHARASHTRA BY PROJECT PROPONENT M/S PRASOL CHEMICAL PRIVATE LIMITED.

The public hearing for proposed expansion of Synthetic Organic Chemical at Gut No. 8, 13, 15, 16, 25, 75, Village – Honad, Tal – Khalapur, Dist – Raigad, Maharashtra by Project Proponent M/s Prasol Chemical Private Limited was conducted on 13th October, 2020 at 12.00 noon at Samuel Hall, 4th Floor, Old Mumbai Pune High Way (N.H.4), Khopoli, Dist – Raigad – 410 710.

Shri J. S. Salunkhe, I/c Regional Officer, MPCB, Raigad Member, Convener of the Public Hearing Committee welcomed Hon'ble Chairperson of the Public Hearing Committee, Company Officials and who were present and informed that as per the participants Environment Impact Assessment Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEFCC, GoI) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification. The Sub Regional Office, Raigad-I, MPCB, Navi Mumbai was in receipt of application for proposed expansion of Synthetic Organic Chemical at Gut No. 8, 13, 15, 16, 25, 75, Village - Honad, Tal - Khalapur, Dist - Raigad, Maharashtra by Project Proponent M/s Prasol Chemical Private Limited. existing site of the industry.

The Convener further informed that, as per EIA Notification, 2006 the category of project falls under Category A 5 (f). The aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing and they should know the developmental activities and Environment Management Plan of the unit.

Project Proponent had submitted online prescribed application alongwith pre-feasibility report to the MoEFCC, Gol for Terms of Reference (ToR) for conduct of EIA studies and MoEFCC, Gol, New Delhi considered the project and given online approval on 27-06-2019.

As per Office Memorandum referred at sr.no. (2) above, guidelines have been issued by the Govt. of India to conduct the Public Hearing in the background of COVID-19. It is directed that with Virtual Public Hearing, Online Public Hearing should also be conducted. It is directed that 100 persons will be allowed in a session in Virtual Public Hearing meeting with keeping social distancing and wearing of mask, use of sanitizer will be mandatory. If the participants are more than 100, next sessions be conducted till all are given opportunity.

As per said Notification, 30 days' advance public notice was published in the local newspapers in Daily Loksatta and Krushival for Marathi and in national newspaper daily Indian Express for English on 13/09/2020 and 26/09/2020. The public were appealed to send their suggestions, views, doubts or objections regarding the proposed new molasses-based distillery unit.

Also copy of EIA report and executive summery were made available at various notified offices of Government i.e. Ministry of Environment, Forest & Climate Change, Zonal Office, West Central Zone, New Secretariat Building, Ground Floor, East Wing, Civil Line, Nagpur-440 001; District Magistrate Office, Raigad; Additional District Magistrate Office, Raigad; Zilla Parishad Office, Raigad District Industries Centre

Office, Raigad; Tahsildar Office-Khalapur, Dist, Raigad; Grampanchayat offices at Group Grampanchayat, Honad, Chinchvali, Tebewadi, Dheku, Thane-Nhave, Akatargaon, Tal – Khalapur, Dist- Raigad; Sub Regional Office, Raigad -I, MPCB, Navi Mumbai; Regional Office- Raigad, MPCB, Navi Mumbai and at Head Office of MPCB at Mumbai, Environment Department, Govt. of Maharashtra, Mumbai and on the website of MPCB.

The public in general were appealed to send any suggestion or objection regarding the proposed expansion of the project. Member of the Public Hearing, appealed Chairman of the Committee to allow to start the proceedings.

With the permission of the Hon'ble Chairperson of the Public Hearing Committee, Project Environment Consultant gave the presentation on Environment Management Plan of the project.

After the presentation, Chairperson, Member and Convener of the Public Hearing Committee appealed the participants to raise their suggestions, objections regarding Environment Management Plan of the project.

Followings have taken part in the discussions:

1) Shri Narendra Galkwad, Residence - At - Aatakargaon, Post - Salgaon, Tal - Khalapur, Dist - Ralgad :-

requested Additional He District Magistrate-Raigad Chairperson, Environment Public Hearing Committee to cancel this public hearing session. Shri Narendra Galkwad informed that M/s Prasol Chemicals Pvt. Ltd., is in operation at Mouje Honad and due to its pollution the 10 k.m. radius and surrounding areas of four Grampanchayats have been affected. The total livelihood of the area is disturbed. He further remarked that this public hearing should have arranged at project site or in the area jurisdiction of four Grampanchayats. If it is not possible to due COVID-19, then why this public hearing meeting is called so hesitatively and when 100 persons only allowed to this meeting. This meeting could have conducted after Covid-19 pandemic. So, this public hearing should be cancelled and next meeting please be arranged at appropriate

Hence, it is requested that this public hearing should be cancelled, and it should be conducted at suitable time.

Shri Gaikwad informed that after the public hearing, the local villagers desires to submit writing objections. Shri Gaikwad

informed that in 2013, the public hearing of this company was conducted. It was conducted in jurisdiction of Horlad Grampanchayat area.

Many promises were made in the meeting. The commitment of village development was made. Nothing is done till date. We also blame that MPCB did not follow the strict guidelines of water and air pollution. The people staying in the vicinity of project suffer due to smell nuisance. The project officials have totally violated the strict Safety guidelines. While entering in the company/project, there should be open space. It is not there. Hon'ble Chairperson is requested that after completion of this meeting, it is requested that along with MPCB officials and with us, inspect the site of the factory.

Shri Gaikwad further objected that the promises made in 2013 are not still completed. There is no guarantee of workers' safety. It was also promised that the treated effluent will not be generated in the river. But it is released many times. The incidence of fish kill occurred. Heavy losses were incurred of the local farmers. Hence, local poor farmers sat at Tahsil Office for Fast-unto-Death. The project proponent has accepted the fast. At this moment, the project officials has accepted the discrepancies. The domestic animals were also unable to drink the water.

He informed that schemes of various Grampanchayat are on the river.

He further blamed that the Project Proponent is not following any rule and playing the life of poor villagers. The Maharashtra Pollution Control Board is also not taing any action against the industry. The company do generate its effluent into the river in rainy season.

Here local people are not familiar with online system. There is no net problem in rural areas. Hence this office line public hearing and online public hearing should be cancelled and after Corona epidemic, the public hearing should be called on the open ground near the company. Here, only 100 persons are permitted, hence local issues cannot be raised.

Here Chairperson of the Public Hearing Committee informed that at a time 100 persons are allowed in a session. If there are more than 100 persons, the meeting will continue till all are given an opportunity to raise their views. But the participant must follow strict guidelines issued by the Government for prevention of Covid-19 i.e. wearing of mask, following social distancing and use of sanitizers.

Shri Gaikwad informed that this information is not given to villagers. Hence, local people, project affected farmers could not attend the meeting. Secondly, the meeting should be arranged were the people are suffering due to activities of this project.

Chairperson, Environment Public Hearing Committee directed Project Proponent to give answers to the objections

Shri J. S. Salunkhe, Regional Officer, Raigad, MPCB, Navi Mumbai and Member, Convener of the Environment Public Hearing Committee informed that MPCB has initiated the action as specified in Environment Laws from time to time against any project. The bank guarantee of this project is forfeited in 2011 and in 2019 also. If any industry violates the norms as specified by the Board in the consent, an action is action as per the Environmental Laws.

Member, Convener of the Environment Public Hearing Committee asked Project Proponent to give following clarifications in the meeting -

- a) Clarification regarding safety measures in the project;
- b) Whether adjoining villages suffer smell nuisance;
- c) Whether open space is available in the project?

Project Environment Consultant answered that in 2012-2013, an Environment Public Hearing is conducted of this project. We agree that at that time, no social welfare scheme was implemented in the area by the company under Corporate Social Responsibility Fund. But after 4-5 years, various positive steps are taken to implement the social welfare schemes. The complimentary letters as received by the various Grampanchayat can be made available here. Also, Project Proponent has requested Grampanchayats to submit the schemes to be implemented in the areas.

Environment Consultant informed that project officials do visit the local colleges and inform the activities of the project. After conducting the interviews, the local people have been job opportunities.

Here, some participants blamed that this is false and misleading. There were no interviews in the colleges. Project Proponent informed that 425 persons are working in the project. All are local people only. In future, if there is need of manpower, it will be fulfilled through local people only. The private contractors are

required for completion of various works and 75% contractors are local people only.

Member, Convener of the Environment Public Hearing Committee asked to give explanation to the objections raised during the meeting.

Project Proponent informed that the objection is raised regarding the smell nuisance. This is to inform that most advanced equipments are used in the process. Now Water Proof Double Stage Cover System is in operation, which is most advanced system. Also Gas Flare System is also in operation.

Shri Narendra Gaikwad here objected that smoke and dust do release from the project and at this moment also it is released. Project officials here informed that there is no release of H₂S gas. It is totally scrubbed. The bag filter and dust collectors are provided to the boiler.

2) Shri Shashikant Sudam Deshmukj, Ex-Sarpanch, Honad Grampanchayat, Tal-Khalapur, Dist – Raigad :-

Shri Deshmukh while raising objections informed that he himself has granted No Objection Certificate to the company. At that time, it is promised that they will repair the boiler. But one boiler is not repaired. The people are suffering due to its smoke, moreover due to this smoke nuisance, few people have to be operated for eyes. If anybody does the wrong, naturally the people will talk. Further the project proponent has installed the boiler near the road. Hence, if the street passer suffers any injury, then whether the company will take any responsibility?

Project officials here informed that the boiler is installed for power generation plant only. Most advanced Triple System i.e. Bag Filter, Dust Collector and ESP – Electro Static Precipitator are in operation. Hence, the dust does not release in the environment. The boiler is installed 500-600 meters from the road.

Environment Consultant informed that the boilers which were installed previously had no bag filter. Now, the old boilers will not be used. Now most advanced ESP – Electro Static Precipitator system is installed which gives 99.5% efficiency.

Here one villager informed that there is huge noise in the process. We, nearby people do suffer due to pollution, but not a

single young man from our village is given an opportunity to work in the plant. Moreover, outside people are appointed.

Here Project officials informed that at this moment also the record can be made available that 80% persons working in the company are local people only. They are from nearby areas and from the Taluka only. Shri Narendra Gaikwad objected that a school is 60-70 meter away from the project site. Hence, the students are facing the pollution problems. Project officials informed that the plant is commissioned as per the Rules of the Government.

3) Shri Prakash Patil, Member, Group Grampanchayat-Chinchwali, Resident of Chinchwali, Tal – Khalapur, Dist – Raigad :-

The project is in operation for last 25 years. For the development of the region, it is necessary that various projects should be installed in the area. Here few objections have been raised for the expansion of the project. If the project proponent does follow the guidelines as laid down by the Government and under CSR Fund implementing various social welfare schemes, health schemes, then forgetting the differences support should be extended for the expansion of the project. Just now project officials informed that unemployed local youths and young ladies will get the job opportunities. The Grampanchayat will get the revenue.

It is our experience that we should support the expansion and Project Proponent should also follow the strict guidelines of Environment.

Here Shri Narendra Gaikwad remarked that when there was public hearing in 2013 of this company, he himself supported the project. But the promises made at that time by the Project Proponent i.e. help to the drinking water schemes, funds will be provided to local schools. After expansion, whether the promises will be followed?

Project officials informed that the repairs of school classes and its beautification, repairs and cleaning of water tank of the school are carried by the Prasol Company. It is already shown in the presentations.

Here Shri Narendra Gaikwad remarked that the school was in existence before the project. Here it is informed that Managing Director of the Project is here. The amount is spent as per the Order of Managing Director of the project only.

4) Shri Sandip Deshmukh, Resident of Adoshi village, Member of Adoshi Grampanchayat:-

Shri Deshmukh said that I welcome the expansion of the project. He further remarked that in future also the project should be welcomed.

The sapling is planted, tomorrow we will get the fruits. Local people get the job opportunities. Local business will also flourish. The project will be beneficial to local people and the area.

Shri Deshmukh here opined that the suggestions given by Shri Narendra Gaikwad should be implemented. The health issues of the local people should be given priority. In future, the company should be recognised as the Project of Health Care. The project officials should implement various pollution control systems as directed.

Here project officials informed that we will implement all the schemes. If there is any error in Environment Management Plan, it will be rectified. The local people will be top priority in the job opportunities, in permanent jobs and for contractual labours.

5) Shri Viju Hange, Resident – Khopoli, Dist-Raigad :-

He informed that I am resident of Khopoli city. I have read all the report of expansion. The project should be definitely appreciated. But if at there are some local issues, then it should be solved mutually. Local people should be given priority in the jobs, then only we will support the project.

6) Shri Manish Khavale, Resident of Dheku, Tal-Khalapur, Dist – Raigad :-

He asked two questions to Project Consultant. Shri Khavale informed that in the last public hearing in 2013, M/s Aditya Environment has prepared the Environment Impact Assessment Report. In the report of 2013, it is mentioned that 850 trees are on the project site. Now seven years have passed. Now, for this project, the survey might have carried in the month of May, 2020. Then whether the trees i.e. 850 in numbers are still there. He requested Project Consultant to give true and correct information.

Shri Khavale further remarked that if the survey is carried by Aditya Environment, the information should be made available. He further asked to give explanation that whether two acres of land is available for green belt development in the company? He further

said that in total there should 5.75 acre should be available in the company premises for green belt development.

Shri Khavale further remarked that the expansion of the project is welcomed. But whether the project proponent is implementing all the guidelines as stipulated by the Government? Which Government Agency keeps vigil on the green belt status of the industry?

Here, Member, Convener of the Environment Public Hearing Committee asked to give details of open space in the project. The remaining space should be green belt only.

Environment Consultant further informed that the project is 8,290.0 square meter. Our team do visit the site. We will re-survey the green belt and mistakes will be corrected. Here, Chairperson, Environment Public Hearing Committee informed to carry re-survey of the green belt.

Here Shri Khavale objected that the explanation of the area in the last report of 2013 and this report be informed in detail. He further suggested that oxygen generating trees such as Vad, Pimpal and Umbar be planted.

7) Shri Ramchandra Deshmukh, Resident of Khalapur, Dist - Raigad :-

He remarked that the company should be grown. It should be expanded. He informed that he has attended the previous public hearing also. We have supported the project. If the project officials are trying to grow, they should be given an opportunity. The suggestions, objections raised should also be complied. He supported the views expressed by Shri Manish Khavale that the trees Vad, Pimpal, Umbar which gives 24 hour oxygen should be planted. The Project Proponent should also follow the Rules. He wished project success.

Here Environment Project Consultant informed that we will resurvey the green belt area and prepare the report.

Shri Narendra Gaikwad informed that factual position should be brought to the local people. Then how the manipulated report is prepared? This is totally cheating of common people.

8) Shri Nitesh Patil, Resident of Atkargaon Village, Tal-Khalapur, Dist - Raigad :-

He informed that his wife is Sarpanch of Atkargaon village. Company has given the survey nos 8, 13, 15, 16, 25, 75. Which survey numbers are these and whether they are at the back side or adjoining sides? Here many people complained that the company is not following the Rules. Keeping of distance from the road is not maintained by the company. He further asked where the expansion project will be implemented? It is mentioned that 22,000.0 sq. meter space is kept vacant. Then it should be shown. Parking facilities should be shown. As per our knowledge, the company has violated all the rules while construction. It has not kept distance while constructing the project. The vehicles of the company just stand on the road, which makes hurdles in the daily traffic. If a pregnant woman is going to hospital, she has to face heavy traffic. The local people should be taken into confidence. The Government officials should carry the survey and action should be initiated.

If the local people are taken into confidence, then only the project expansion will be supported

The Project officials informed that for expansion, the new machineries will be brought. Some machineries will be modified. There is no plan of developing new site. S. No. 75 is for parking facilities. The survey numbers are given by the Grampanchayat office only. Now it is informed that the vehicles are kept standing on the road. We will inform our workers to park it inside of the building.

Member, Environment Public Hearing Committee informed Project Officials to give clear answer that if there is 22,000 sq. feet place, then inform whether there is 300 sq. feet place for parking. Project officials informed that we have enough place. Chairperson, Environment Public Hearing Committee directed to take into confidence of local people while carrying expansion.

9) Shri Naresh Patil, Member, Raigad Zilla Parishad:-

Shri Naresh Patil remarked that if the project has planned for expansion, naturally the local people expects the job opportunities. Hence, local people should be given priority.

He further said that project officials already promised to give jobs to local people. It is also noted that local private contractor are also working efficiently.

It is also informed by the project officials that the suggestions given by Shri Narendra Gaikwad will be followed.

 Shri Ulhas Deshmukh, Local resident informed that his son has applied for the job, but not considered.

Chairperson, Environment Public Hearing Committee directed project officials to give answers to the objections raised by the participants.

Project officials while giving all the answers informed that the suggestions given by Shri Manish Khawale will be implemented. The answer given to Naresh Patil that project officials always prefer local people only as without co-operation of local people, project will not succeed.

SECOND SESSION

As per the directives of Govt. of India to prevent Covid-19 pandemic, another session of 100 persons is conducted for Public Hearing Meeting.

Followings have taken part in the discussions:-

1) Shri Sandip Ravindra Borle, Dy.Sarpanch, Thane Nhave, Dist – Raigad -

The company discharged it effluent into river. Hence there was fish-kill incidence. The local farmers have sat for fast. Then only project proponent have gave the compensation. The project is definitely working good. The effluent will not go outside the factory.

He said that the local people should be given priority in job opportunities. The revenue income of the Grampanchayat is very less. It is requested that under CSR Fund, an ambulance be purchased for our village. We support the expansion.

Project officials informed that for getting any job basic skill is most important. If the students of our village learns it, definitely they will be given job opportunity in the project. Further it is requested to give proposal for purchase of ambulance. After approval in the Company Meeting, it will be informed.

Chairperson, Environment Public Hearing Committee informed that as demanded, 100% job opportunities be given to local people. The skill which is required in the project should be given by training. She directed project officials to give training programmes to the local

people. It is informed by the Project Proponent that in 2016, 50 local people were appointed. They all are in company services.

2) Shri Uchharppa Warchale, Phata, Tal-Khalapur, Dist - Raigad :-

Due to Corona, the projects are closing down their activities. Here, expansion is planned. Hence wholehearted support to the expansion.

3) Shri Rahul Patil, Resident of Chinchwali, Tal-Khalapur, Dist – Raigad :-

The company is trying to minimise the pollution. The large number of trees are planted in the project. Due to project, the surrounding areas will be benefited. Hence, supporting the expansion.

4) Shri Mahadev Thombar, Resident of Honad, Dist-Raigad:-

The project is welcomed. Everything is informed in the project. It is promised to give job opportunities to local people. It is also agreed by the Project Management that Skill Development Programme will be implemented and 100% local people will be appointed.

5) Shri Vilas Deshmukh, Honad Village, Dist-Raigad :-

The company do spent fund for social welfare schemes, environment management schemes. Previously, dust used to release in the atmosphere. At present it is observed that it is not released. 80% people in the project are local people only. Honad Grampanchayat has already supported the project.

6) Shri Abhijit Deshmukh, Resident of Honad Gaon, Dist – Raigad –

He asked how many local contractor are in the project? It is informed that out of 80, 56 are local contractor only.

7) Shri Digambar Patil, Resident of Chinchwali, Tal – Khalapur, Dist – Raigad –

He informed that he was worker in 2006-2009. Then started tanker business. Now it is going on. Suported for Expansion.

8) Shri Devendra Patil, Resident of Chinchwali, Tal – Khalapur, Dist – Raigad –

If the company is expanded, it will beneficial to local people and area. Company should give priority for Skill Development only.

Member and Convener of the Public Hearing Committee asked participants to raise their suggestions if any. As there was not response, Convener of the Public Hearing informed that the suggestions, objections raised during the meeting are noted and it will be included in the minutes of the meeting. The minutes alongwith Final Environment Impact Assessment Report will be submitted to Expert Committee of Ministry of Environment, Forest & Climate Change, Govt. of India. The Expert Committee will take further decision accordingly.

Member, Convener, Environment Public Hearing Committee informed in the meeting that the participants has raised the objections that no safety guidelines are followed in project site and the life of the workers will be in danger. Hence Project Proponent is directed to carry the detailed survey report (Detailed Inspection & in respect of Accident & Safety Report) through Directorate of Industrial Safety & Health, Maharashtra State (DISH). Project Proponent is directed to follow the all instructions and also suggested that it is responsibility of company owner and DISH.

The Public Hearing Committee appealed the participants to raise any objections, suggestions regarding the project. There was no response. Chairperson, Environment Public Hearing Committee asked Member, Convener of the Public Hearing Committee to conclude the meeting.

Member and Convener of the Public Hearing Committee asked participants to raise their suggestions if any. As there was not response, Convener of the Public Hearing informed that the suggestions, objections raised during the meeting are noted and it will be included in the minutes of the meeting. The minutes alongwith Final Environment Impact Assessment Report will be submitted to Expert Committee of Ministry of Environment, Forest & Climate Change, Govt. of India. The Expert Committee will take further decision accordingly.

Member, Convener of the Environment Public Hearing on behalf of the Chairperson of the Environment Public Hearing concluded the meeting. The meeting ended giving thanks to the Chair.

Afterwards, the participants who were online appealed to raise any objections, suggestions regarding Environment Management Plan (EMP) of the company.
