

**MINUTES OF THE PUBLIC HEARING FOR PROPOSED ESTABLISHMENT OF
MOLASSES BASED DISTILLERY – 45.0 KLPD CAPACITY IN THE EXISTING SUGAR
FACTORY PREMISES AT DINDAYAL NAGAR, HUSENPUR, POST – CHITE
PIMPALGAON, TAL & DIST – AURANGABAD, MAHARASHTRA BY PROJECT
PROPONENT M/S CHATRAPATI SAMBHAJI RAJE SAKHAR UDYOG LIMITED**

The Public Hearing for proposed establishment of Molasses Based Distillery – 45.0 KLPD capacity in existing sugar factory unit at Dindayal Nagar, Husenpur, Post – Chite Pimpalgaon, Tal & District – Aurangabad, Maharashtra by Project Proponent M/s Chatrapati Sambhaji Rajee Sakhar Udyog Ltd., was conducted on Thursday, the 30th September, 2021 at the site of the said industry at 11.30 a.m.

Hon. District Collector, Aurangabad approved the date of public hearing on Thursday, the 30th September, 2021 and as per the Notification dated 14-09-2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, GoI), New Delhi and subsequent amendment on 01-12-2019, Member Secretary, Maharashtra Pollution Control Board, Mumbai has constituted Public Hearing Panel vide Board's Office Order No. E-71 of 2021 under letter no. BO/JD (WPC)/PH/B- 210903-FTS 0009, , dated 03.09. 2021 and Hon. Collector Aurangabad has appointed Additional District Collector as a Chairmen vide letter no. 894 dated 27.9.2021 for the said public hearing:-

Shri. Pradeep Wankhede, Sub Regional Officer, Aurangabad-I, MPCB, Aurangabad and Convener of the Environment Public Hearing Committee welcomed Dr. Anant Gavane, Additional District Magistrate, Aurangabad and Chairman of the Environment Public Hearing Committee; Dr. Pravin M. Joshi, Regional Officer, MPCB, Aurangabad and Member of the Environment Public Hearing Committee; Environmentalists, NGOs, Journalists and Company Officials and local people/participants who were present and informed that as per the Environment Impact Assessment Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, GoI) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification.

Convener of the Public Hearing Committee welcomed all and informed that the meeting is called in the prevailing situation of Covid-19 pandemic. Hence, it is requested all the participants to follow strict guidelines as issued by Govt. of India and Govt. of Maharashtra from time to time. As per the guidelines, only 100 persons/participants are allowed in a session. If the participants are more, then remaining will be allowed in next session. The sessions will continue till all the participants are given opportunity to attend the meeting. The thermal checking and use of sanitizer is kept at the entrance of the pandol and now it is compulsory to wear a mask and follow the social distancing amongst the persons in the meeting hall.

He informed that Maharashtra Pollution Control Board was in receipt of application from Project Proponent M/s Chatrapati Sambhaji Raje Sakhar Udyog Ltd., Dindayal Nagar, Husenpur, Post – Chite Pimpalgaon, Tal & District – Aurangabad, Maharashtra for proposed establishment of Molasses Based Distillery – 45.0 KLPD capacity in existing sugar factory unit.

The Convener further informed that this existing project and as per EIA Notification, 2006 the category of project falls under Category Red/LSI, which requires to obtain prior Environmental Clearance from the Environment and Climate Change Department, Govt of Maharashtra, Mumbai for which prior environmental consultation is mandatory.

Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing, and they should know the developmental activities and Environment Management Plan of the unit.

Project Proponent had submitted online prescribed application along with pre-feasibility report to the State Environment Assessment Committee-I, Environment & Climate Change Department, New Administrative Building, Mantralaya, Mumbai for Terms of Reference (ToR) for conduct of EIA studies on 04-06-2021 and it has been considered and given online approval on 11-08-2021.

As per said Notification, 30 days' advance public notice was published by Sub Regional Office, MPCB Aurangabad in the Local Newspaper in Daily Sakal for Marathi and in National Newspaper daily The Times of India for English on 30th August, 2021. The public were appealed to send their suggestions, views, doubts or objections regarding the proposed unit.

Also copy of EIA report and executive summery were made available at various notified offices of Government i.e. Ministry of Environment, Forest & Climate Change, Zonal Office, West Central Zone, New Secretariat Building, Ground Floor, East Wing, Civil Line, Nagpur-440 001; District Magistrate Office, Aurangabad; Additional District Magistrate Office, Aurangabad; Chief Executive Officer, Zilla Parishad Office, Aurangabad; General Manager, District Industries Centre Office, Aurangabad; Tahsildar, Tahsil Office – Aurangabad, Dist -Aurangabad; Block Development Officer, Panchayat Samiti, Aurangabad, Gram Vikas Adhikari, Grampanchayat Office, Takli Mali, Pimpalgaon Chite, Garkheda, Sanjkheda, Pimpri Raja, Kadrabad, Pimpalgaon Pandhari, these seven Grampanchayat offices, Tal & Dist – Aurangabad; Environment & Climate Change Department, Maharashtra Government, New Administrative Building, Mantralaya, Mumbai; Head Office, Maharashtra Pollution Control Board; Regional Office, Maharashtra Pollution Control Board, Aurangabad; Sub Regional Office, Aurangabad-I, Maharashtra Pollution Control Board, Aurangabad; and on the website of MPCB. The public in general were appealed to send any suggestion or objection regarding the proposed new distillery project.

Convener informed that participants can raise their views, suggestions/objections for the proposed expansion of the project in environmental angle only orally as well as in

writing also. It will be noted minutes of the meeting. Also, the video recording of this meeting will be forwarded as it is to Environment, Forest & Climate Change Department, Govt. of India, New Delhi.

With the permission of Chairman, Project Environment Consultant gave geographical location of the proposed unit, proposed impact on the environment due to proposed project and details of Environment Management Plan of the proposed unit. Environment Consultant informed that Project Proponent has ear-marked capital cost of Rupees 1,365/- lakh and for maintenance of pollution control devices Rupees 237.04 lakh.

After presentations, Environment Public Hearing Committee appealed the participants to raise their views, suggestions or objections regarding propose plant in environmental angle only.

Chairman, Environment Public Hearing Committee appealed the participants to raise views, suggestions or objections regarding proposed project in environmental angle only in brief. While raising it, first name and name of the village should be informed.

Following persons have taken part in the discussions and the answers given by Project Environment Consultant/Project Proponent/ Environment Public Hearing Committee: -

1) Shri Prakash Changulpay, Z. P. Member, Residence-Pimpri Raja, Tal & Dist – Aurangabad:-

Whether due to this project, there will be any ill effects on surrounding villages? Whether health of surrounding people will have any adverse effects due to this project?

Project Environment Consultant answered that as shown in the Presentation, the effluent which will be generated in manufacturing activities will be treated, recycled and reused in the process. Not a single drop of treated effluent will be discharged outside the factory premises. Hence, there will not be any water pollution in the surrounding area.

The boiler ash will be made available to the local brick manufacturers.

With this new technology, the factory will get money by recycling the waste. Since this is a large-scale, sustainable project, the Project Proponent has to invest some money at the initial stage, and it will provide income in the future and will also protect the environment.

2) Shri Ganesh Swarupchand Bramhanat, Residence-Husenpur, Post – Chite Pimpalgaon, Tal & Dist – Aurangabad:-

Though in this public hearing, there are people from Husenpur village, but 75% of them are employees of the factory only. Hence, local people of Husenpur and employees of the factory should be bifurcated and should sit separately.

At this moment, Chairman, Environment Public Hearing Committee informed that this is public hearing. A public notice was published in local and national newspaper 30 days in advance. Hence, if some people are at outside, they will also be called. The employees are appointed to complete the task. Nobody will prevent you to raise your views. It will be noted. Hence you are informed to raise your views, opinions fearlessly.

Shri. Bramhanat objected that in the EIA report, it is mentioned that the water samples were taken from five wells at Husenpur village near the project. Then why sample of my well water is not collected?

At this moment, Member, Environment Public Hearing Committee asked Project Environment Consultant to inform the names of five wells whose samples were collected at Husenpur and its result also.

Environment Consultant gave the details of survey carried of all locations/spots of ground water, surface water, soil, noise and air.

Here Member, Environment Public Hearing Committee remarked that simple question is asked by the participant that why the water sample from his well is not collected? If not, then you can collect the sample following all scientific procedure.

At this moment, Shri. Pratapsingh Mahasingh Ghunawat remarked that Distillery Project is yet to be commissioned. But we are talking about the adverse effects of present sugar factory.

Environment Consultant here informed that those who desires to check the water samples of wells may give written application. It will be carried accordingly.

Member, Environment Public Hearing Committee directed that the report should be made available by collecting the well water samples in a scientific manner by taking the name of the persons concerned.

Shri. Ganesh Swarupchand Bramhanat further objected that the ash from the factory is just thrown in the open space. While filling the ash in the tractor due to wind it flies and goes to the animal feed. Therefore, animals do not eat fodder. The ash flies and falls on the citrus fruit. Traders buy citrus fruits at very low prices. Shri. Ganesh Bramhanat handed over the fruits to the Environment Public Hearing Committee.

At this moment Chairman, Environment Public Hearing Committee informed that this public hearing is called for the proposed new project. Hence, it is desirable that whatever suggestions, views or objections be raised for the proposed project in environmental angle only.

Chairman, Environment Public Hearing Committee further directed Project Proponent that to take immediate action if the project is causing any inconvenience to the farmers in the area, affecting the crops, citrus blackening, ash billowing and complaints from the surrounding residents about the project.

He appealed all to raise suggestions regarding proposed distillery project only.

Member, Environment Public Hearing Committee further asked Environment Consultant regarding further management of the ash. Environment Consultant further answered that in Western Maharashtra, experiments were carried out to make ash bricks. It can be used in construction using ash and binding materials. After studying the weight of ash bricks and the bricks currently in use, it has been proved that ash bricks also have potential. It's use has begun. The demand of the people is increasing day by day.

Chairman of the Project Proponent informed that since last 20 years, the sugar factory is in operation. Most of the workers are from the adjoining villages only. Up til now, not a single complaint is received by our office about ash

nuisance and pollution. Since last two years, Online Monitoring System is in operation. Smoke is not generated outside. While cleaning of the boiler for ten minutes, it is seen.

The ashes are collected by the tractor personnels and then it is handed over to the kilns immediately. This factory did not damage anything. After commissioning of the distillery project, the terms and conditions as specified by the MPCB will be implemented.

Shri. Ganesh Swarupchand Bramhanat further blamed that three pits have been dug to the east of the factory for disposal sewage from the factory. The sewage generated from the factory is released there.

The effluent to the tune of 33.0 M3/day will be produced in the distillery project. How it will dispose off? This is going to have very bad consequences.

Here, Member, Environment Public Hearing Committee asked Shri. Ganesh Swarupchand Bramhanat to raise all the objections. Afterwards Environment Consultant will answer it collectively.

Shri. Ganesh Swarupchand Bramhanat further objected that proposed distillery unit will require 995.0 M3/day of water. It will be lifted from the Sukhana Dam. Small canal goes from our village. If the water from Sukhana Dam is lifted for the project, we, the local farmers will get less water.

Hence, due to this project, our village will suffer a lot. Hence, our village oppose the project. If this project is allowed to operate, there will be adverse effects. If there is an adverse effect, then I am going to set myself on fire at the Collector's office.

3) Shri Pratapsingh Mahasingh Ghunawat, Village -Husenpur, Post – Chite Pimpalgaon, Tal & District – Aurangabad :-

Chhatrapati Sambhaji Raje Sakhar Udyog Limited is established in my area in 2001. At the time, we thought it would benefit in the area for the various developmental work.

But we have no benefit, only adverse effects. Distillery will be established in future. Hence, our village has planned to oppose the project. Here other projects are likely to be commissioned. We are not at all opposing it.

But in our Husenpur village on our local language, it is called as Liquor Industry, should not come here.

He further raised the objection that "No Objection Certificate "(NOC) had to be issued to the Project Proponent only after passing a resolution in Gram Sabha in the village first. But that did not happen.

Similarly, after holding Gram Sabha in other villages in the area, and only after that, it was necessary to issue No-Objection Certificate to the Project Proponent. But NOC is issued to Project Proponent violating all the directives.

The letter signed by all Gram Sabha Members of my Husenpur village is submitted to you. Due to operation of this factory, the trouble faced by those who come and go in this area is not at all considered

The road is built from Sanjkheda to Husenpur and from Husenpur to Kachner Command. The road is connected to these two villages.

There is a water pollution control plant installed on the side of the road. When the factory is in operation, a spray of water flows from it and the man gets soaked with all the sewage water/dirty water while walking down the road. Similarly, the generated saw-dust gets into the eye and hence it is not possible to ride a motor cycle. These are difficulties faced now by us. I wonder if we have to leave the village, once the distillery starts. This project should be installed in MIDC area. It should not be on our fields and dams. Though this factory provided employment, only two workers from Husenpur are permanent employee.

The heavenly crisis has come upon us in the form of rain. Our standing crops have vanished. Now crisis in the form Demon Distillery Unit is arriving.

If our heartfelt requests are not listened, then some farmers will have no choice but to commit suicide. All the villagers are opposing the project. Hence this is request and please co-operate us.

Chairman of the Project informed that if the water of spray pond sprays, we will definitely solve the issue. Secondly, for giving employment opportunity to temporary workers, the distillery unit is planned. The Ethanol will require for petrol blending. Our country has to import 85% of petrol. Due to petrol blending, the foreign exchange will

be saved. The gas can be produced from Ethanol. The vehicles can be run on it in future. The provision is already made. Hence, it is requested to support the project.

4) Shri Rajaram Kisan Bramhanat, Husenpur, Post -Chite Pimpalgaon, Tal & Dist – Aurangabad:-

I am working in the fields since last 20 years. I am only person who come from Husenpur since last 20 years. As my water is polluted, the factory was ready to give me Rupees 10,000/- as compensation. But I have not taken. Now after three years, again my water is polluted. Hence, my agriculture fields should not be damaged and water should not be polluted.

Chariman of the Project informed that when there was not water in the dam, we have brought water from the city and kept the sugar factory in operation. Since 2012-12, we are collecting and preserving rain water and keeping the sugar factory in operation. The water of sugarcane crop is removed and filled back in the ponds. We have not lifted the water from the dam since 2013. Anybody can watch our electricity bill.

Chairman of the sugar factory further said that our wells are just neighbor to the wells of Shri Rajaram Kisan Bramhanat. If the water in our well is good and we use it, then how can the well of Mr. Bramhnat , just adjacent neighbor/next door be bad? We and MPCB offices do monitor from time to time.

It is informed by the local people that liquor will be produced in the factory. The liquor is not at all produced in the factory. From sugarcane juice Ethenol, from Molasses Ethanol will be produced. The final product Ethanol will be sent to petroleum companies for petrol blending.

5) Mrs. Rekha Punamsingh Bramhnat, Residence - Husenpur, Post -Chite Pimpalgaon, Tal & Dist – Aurangabad:-

I am agriculturists from the Husenpur. I got married in 2000 and from 2000 I am watching the pollution from the existing sugar industry. The local villagers feel that there should not be distillery project in the village. The Rajput Community stays in the village. They cannot understand local language Marathi. Hence, MLA may think that only two people from Husenpur have raised objections. There many people who are opposing the project are standing outside the premises. We are suffering due to

pollution of the sugar factory. Hence we think that there should not be Distillery Unit, which will increase our sufferings.

Here Chairman, Environment Public Hearing Committee asked lady participant to explain the adverse effects of the proposed project which they think they will suffer.

Mrs. Rekha Punamsingh Bramhnat informed that we are suffering due to effluent of the factory. There is smell nuisance. The polluted water percolates in the soil. Here Managing Director, who is MLA says that nobody has opposed me. Can poor people, common people oppose MLA? While commissioning the sugar factory, it was promised that one person from each family from Husenpur village will be given job opportunities in the sugar factory. There are only 4 – 5 persons from Husenpur and they are also not permanent. They are working on 7-8 thousand since so many years. We demand that Distillery Project should not be in our village.

6) Shri Adinath More, Sarpanch, Pandhare Pimpalgaon, Tal and Dist – Aurangabad :-

Whether any hazardous waste will be generated from this project?

It is answered by the Project Consultant that there is no use of any hazardous chemicals in the process and there is no hazardous products manufactured in the process.

As shown in the Presentation, the effluent will be treated and it will be recycled and reused in the process. The ash will be made available to local brick manufacturers. The sludge will be given to produce fertiliser. Therefore, no hazardous substances will be released from the project.

7) Shri Ravindra Uttamrao Gavali, Residence-Takalimali, Tal and District – Aurangabad:-

How much effluent will be produced in the distillery and how it will be disposed of?
There will be generation of 376.0 KLPD effluent. It will be connected to CPU (Condensate Polishing Unit). The effluent will be converted into fresh water and it will be recycled and reused in the process.

8) Shri Ganesh Kacharu Gavali, Residence – Sanj Kheda, Tal and District – Aurangabad:-

How many days the distillery project will be in operation? Secondly, the youths from the area of Gram Panchayats from whom permission has been sought for installing of the distillery project should be given job opportunities in the distillery project.

The Distillery Unit will run up to 270 days. It means 9-10 months it will run. This will increase the employment opportunities in the area. Though 65 persons will be appointed is mentioned, 65 persons required are technical personnel. But there will be tremendous increase indirect business and job opportunities.

Continuous Online Monitoring System is in operation in the project. It is connected to server of Head Office of MPCB and atCPCB, New Delhi. Hence, we have to keep all the pollution control devices in operation effectively.

9) **Shri Lalchand Devchand Bramahnat, Husenpur, Tal and District – Aurangabad:-**

The effluent from the factory goes into the gutter, due to which all the sewage/gutter water comes in our yard. When this factory is started, I have made available the water. But my water Connection has been shut down by the factory.

10) **Shri Gajanan Narayan Gavali, Sanjkheda, Tal & Dist – Aurangabad :-**

From this site at 4 km distance, Ambika Shivar farming. 4.0 km beyond Radico has a plant that processes press mud. When it is in operation, there is tremendous smell nuisance in the area. Hence, which preventive steps will be taken to avoid smell nuisance in the distillery plant?

The environmental consultant said that we will recycle liquid waste into production. This is made possible by new technology. That is why we are going to invest around Rs 30 crore.

Chairman, Environment Public Hearing Committee expressed the opinion that the participants have given very good suggestions. The name of the questioner, the village and the draft of the question are noted. Two types of topics came up in the meeting. The public hearing was called for the proposed distillery

project. At the public hearing, many have reported suggestions and objections about the new project. Development works and environment are the main objectives of such public hearings.

After setting up such a committee i.e. this Environment Public Hearing Committee, there is a Government Committee on it, which approves the projects keeping in view all the legitimacy.

In this meeting, doubts about water availability were raised. People's suspicions are true. But the Government has announced a policy for each category of water, such as drinking water, water for agriculture, water for industry, etc.

The participants have given their suggestions and objections in a very playful atmosphere. All the suggestions, views, objections have been noted. The Live Videography is also taken. He thanked administration for arranging the meeting and thanked all for attending the Public Hearing.

Accordingly, the Chairman of the public hearing panel advised to submit the written representation. In response to this, 01 representations were submitted by villagers of Husenpur wherein mentioned that, project proponent has taken NOC of Gramp Panchayat Takli Mali/Eklahra/Mahamdpur/Husenpur/Malkapur Tal. and Dist. Aurangabad without taking peoples participation and their views and requested to not grant permission for the proposed project.






