Precaution will be taken during excavation that flow of the river will not be diverted. Movable toilet will be provided to the workers. CCTV cameras will be installed at the sand ghats.

After completion of the presentation, Shri S. M. Kurmude, Sub Regional Officer, MPCB, Parbhani and Convener of the Public Hearing Committee appealed participants to raise the suggestions or objections with his Name, resident village Name regarding the Environment Management Plan of the Sand Ghats.

Following participants participated during the discussions and the Answers given by the Project Proponent / Project Consultant / Public Hearing Committee are as under: -

# 1) Shri Mayur Manikrao Wagh, Sub-Sarpanch of Village Pimpari, Tal-Selu, Dist- Parbhani: -

He informed that, is there any profit to local grampanchayat from this activity he also mentioned that they have not received last year funds from the District Mining office, collector office, Parbhani.

Chairman of the Environment Public Hearing Committee informed that, available road outside village will be utilized for sand transportation for that funds are reserved. No vehicle will be passed through inside village roads. He also informed

that, for previous funds he will looking to the matter and in future the funds will be directly released to the grampanchayat as per rules. After auction of Sand Ghats.

### 2) Shri Ananta Dyanoba Bhabat, Resident of Village Khadgoan, Tal-Selu, Dist-Parbhani: -

He informed to committee member no funds received from the District Mining office, collector office, Parbhani.

Shri. Rameshwar Borkar, informed that, in future funds will be directly released to grampanchayat as per rules after auction of sand ghats.

Chairman of the Environment Public Hearing Committee informed that, for previous funds he will looking to the matter and in future the funds will be directly released to the grampanchayat as per rules. After auction of Sand Ghats.

## 3) Shri Pramod Pralhad Gayake, Resident of Village Sonna, Tal-Selu, Dist-Parbhani: -

He informed that previous funds are not released to local grampanchaat.

Chairman of the Environment Public Hearing Committee also ensured that that funds will be deposited in local grampanchyat account by District Mining office, collector office, Parbhani.

Shri S. M. Kurmude, Convener of the Public Hearing Committee, asked the participants to raise suggestions, objections if any. There was no response. He thanked all government officials, project officials and public who were present in large number and declared that the meeting is concluded.
