The said enviromantal public hearing was conducted Under the Chairperson of Smt. Nayana Gunde, District Magistrate, Gondia. Shri. Ashok Kare, Regional Officer M.P.C. Board, Nagpur, member of Public Hearing panel and Additional District Collector Shri. Rajesh Khawale were present for public hearing. Smt. Hema Deshpande, Sub-Regional Officer, M.P.C. Board, Bhandara was convener of the said Public Hearing. About 56 people were participated public hearing. (Annexure-I)

District Mining officer, collector Office, Gondia vide letter dtd.27/10/2022 has submitted proposal for carrying out public hearing of 33 Sand Ghats in Gondia district, which requires Environmental Clearance from the Environment and climate change department, Govt. of Maharashtra. The Head office of the M. P. C. Board, had accorded approval to conduct public hearing procedure. Following guidelines stipulated under EIA Notification dtd. 14 Sep 2006, amended dtd.01.12.2009 venue, date and time was finalized after consultation with the District Magistrate, Gondia. The M.P.C. Board office vide letter dtd 23/11/2022 issued office order No. E-92/2022 to conduct public hearing at collector office Planning Building, Gondia on dtd. 09 December 2022 at 2.00 PM under the chairperson of District Magistrate, Gondia. Advertisement of the said public Hearing was published in English daily "The Hitvada" & Marathi daily "Navrashtra" dtd. 08 November 2022 with thirty days period to receive objections of the concerns. (Annexation)

No objections, memorandums were received before & during Public Hearing.

Public Hearing proceedings started at. 2.00 PM after due permission of the chairperson. Convener & Sub-Regional Officer, M.P.C. Board Bhandara Smt.Hema Deshpande taken permission from Hon'ble chairperson Smt. Nayana Gunde, District Magistrate, Gondia. Shri. Ashok Kare, Regional Officer M.P.C. Board, Nagpur, and welcomed all present during public hearing.

Her introductory speech explained procedure of public hearing and cleared that, public hearing panel doesn't have right to recommend or approved the proposed project. The proceeding of public hearing along with received written objection/memorandums and video recording will be submitted to the Ministry for further needful action.

She then invited Mining officer ,Collector Office, Gondia Representative to give power point presentation of proposed Sand Ghats projects.

Mining Officer Gondia has given background for the proposed mining proposal. He told that as per Maharashtra sand policy 03.09.2019 District Mining Officer is project proponent initially and after auction of sand ghats Environmental Clearance will be transferred to successful bidder. Total 63 sand ghats were surveyed but 33 ghats are finalized for EC by Taluka level Technical Committee headed by Tahsildar and team members are Dy. Engineer irrigation Department, Junior Geologist appointed by Directorate of Geology and Mining, Junior Geologist from G.S.DA. Gondia and representative Maharashtra Pollution Control Board.

Manual method of mining will be adopted for excavation of sand from designated area of Riverbed. He asked Representative of a Technical Consultancy M/s. Mahabal Enviro Ltd. For said sand Ghat projects to give power point presentations in Marathi. Details of proposed project, Project, present Environmental status, impact of proposed project & Environmental mitigation measures for each sand ghats was presented by them in power point presentation.

Smt. Hema Deshpande, convener of the hearing invited present people to put their views, objections etc. regarding project on behalf of Hon'ble chairperson. Those who raised the issue they should first tell their name, village and designation.

Also, it is mandatory to plant different types of trees in the mining area / area and the relevant authorities / departments will be instructed to plant trees as per the rules.

After that, the questions raised and the answers of the project proponents were reviewed and it was reported that the people present in Gondia District regarding 33 Sand Ghats quietly presented their statements and the points raised were accurately recorded in the minutes.

The chairperson of the Public Hearing committee concluded the Public Hearing. Smt. Hema Deshpande, Convener and Sub-Regional officer M.P.C. Board Bhandara expressed the vote of thanks and also the representative of the project proponents expressed their vote of thanks.
