The Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi (MoEF & CC, Gol, New Delhi) approved Terms of Reference (ToR) on 16-07-2020 & revised TOR dtd. 16/05/2023. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing and to include in the final environmental impact assessment report the environmental issues raised by the project affected people about the proposed project. As the proposed project falls under Category A Schedule 3 (a) - Metallurgical Industry (Ferrous & Non-Ferrous) and sub category 1 (d) (Thermal Power), it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from MoEF & CC, Gol, New Delhi.

Project Proponent M/s SMW Ispat Pvt. Ltd., At Plot No.B-1/2, B-1/3, B-1/4, R2 AND R3, MIDC Deoli And S.NO.SR-46/2, 562, 564, 565, Taluka - Deoli, District -Wardha, Maharashtra has applied Maharashtra Pollution Control Board on 12/06/2023 for conducting Environment Public Hearing.

District Collector, Wardha, Maharashtra State, in co-ordination with MPCB Nagpur Office, approved to hold physical as well as online public hearing on 27-07-2023 at project site at Plot No.B-1/2, B-1/3, B-1/4, R2 AND R3, MIDC Deoli And S.NO.SR-46/2, 562, 564, 565, Taluka – Deoli, District – Wardha, Maharashtra. The meeting number and password was made available.

But "Red alert" was declared due to the rain situation in Wardha district, so the public hearing was postponed. It was announced vide letter dated 27-07-2023 of the District Magistrate, Wardha (Annexure-I), Then, vide Revised Notification of the Ministry of Environment, Forests & Climate Change, New Delhi dated 09th May 2022, the Environmental Public Hearing of the proposed project was again held on 18-08-2023.

As per EIA Notification, 2006, 30 days' advance public notice was published by Sub Regional Office, Nagpur-2, MPCB Nagpur (30 days before 27-07-2023) in the Local Newspaper in Daily Lokmat, Nagpur Edition for Marathi and in National Newspaper daily The Hitavad, Nagpur Edition for English on 21-06-2023 (Annexure-II). An appeal is made to residents of the area, environmental organizations, residents to be displaced by the project or residents to be affected by the project in any other way to submit their views, comments, suggestions or objections about the proposed project in writing or by email to the local MPCB Nagpur office till the date of public hearing. Sub Reginal Office, Nagpur-II was in receipt of 07 suggestions/objections by hand/email.

Similarly, after the postponement of the public heating, the public notice of the date of the new public hearing was re-published for public information 03/08/2023 in the local Newspaper Lokmat, Nagpur Edition in Marathi and in the National Newspaper Hitawada, Nagpur Edition in English. (Annexure-III).

This office is in receipt of 07 notices, complaints, statements, objections regarding the above project and the persons / concerned institutions have been informed to attend the public hearing and submit their views, opinion, suggestions or objections if any. complaints, statements, objections. (Annexure-IV)

The attendance sheets of the participants during the public hearing as well as the Order of the Environment Public Hearing Committee constituted by the Maharashtra Pollution Control Board are attached herewith as Annexure-V & VI).

Minutes of the Environment Public Hearing:-

At the beginning of the meeting, Shri Atual Satfale, Sub Regional Officer, Nagpur-II, Maharashtra Pollution Control Board, Nagpur and Convener, Environment Public Hearing Committee welcomed Mrs. Archana More, Additional District Magistrate, Wardha and Chairperson, Environment Public Hearing Committee; Sou. Hema Deshpande, Regional Officer, Maharashtra Pollution Control Board, Nagpur and Member, Environment Public Hearing Committee, Project officials, Journalists, NGOs working in the field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized only for the local people and project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairperson of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of Chairman of the Environment Public Hearing Committee, Convener asked Environment Consultant to give presentation of Environment Management Plan of the proposed project.

Project Consultant informed regarding expansion of the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting:-

Detailed Information of the Project -

 Project Area, Latitude-Longitude, Map, Submerged Area, Beneficiary Area, Forest Area, Project; Features, Project Significance, Consequences, Land Use, Earthquake Stability;

 Project objectives, social status, employment opportunities, development of farmers due to the project;

- Information about air, water, land, sound, project affected areas etc.
- Impact and management of air, water, displacement, biodiversity due to planned project
- Information on environmental management after project implementation
- Information on other environmental management

After the Presentation, participants were appealed to raise any suggestion, objections regarding the proposed project in environmental angle only. While raising suggestion, objection, full name and name of the village please be informed.

1)	The presentation shows that the proposed project will provide job opportunities to 2,050 local people. Clarity about this and the agreement to be made for it must be made with peoples of Deoli. Apart from that, there is a project of the company in operation, where the locals have not been provided employment as per the Rules.	If the new project is going to provide employment to 2,050 people, a question was asked whether an agreement can be made for that. There is an agreement with Government of Maharashtra as per the Rules. But local means the resident of the entire State of Maharashtra and the people of all the districts of the State of Maharashtra are included in the definition of local and not only the resident of Deoli or Wardha. 80% of the total employment in the project has to be provided to locals. However, our effort is to get the best employee, because he works well and stays. Also, the proposed project requires three cadres of employees. They are Skilled, Semi -Skilled and Unskiller. According to the educational qualification, maximum employment opportunity will be given to the locals of the project area. We intend to form a "Co-ordinating Committee" for this in the new project and the Company Administration will discuss it with the dignitaries of Deoli.

Six kilometer from Deoli village, the current situation of pollution is shown, but the villagers of Deoli are not aware of the extent of the pollution and what measures the company has planned for it. Even before this, various representations have been submitted to the Hon.	A further objection was raised that the chimneys in the working project were of less height causing pollution. Whereas, the said chimney is mandatory to be implemented as per the directives passed by the Central Pollution Control Board, New Delhi and Maharashtra Pollution Control Board, Mumbai and accordingly the chimney has been installed in the project. 2)	Similarly, big figures were given in the presentation regarding tree plantation. It was said in the presentation that one lakh trees have been planted here. We do not deny that, but the plantation has not been done as seriously as it should have been. For this, I have many times suggested that participation of local people, local non-governmental organizations (NGOs) should be implemented along with green belt development programme. Many local non-governmental organizations (NGOs) demanded tree guards, but they were not provided by the company	Tree conservation done by us has been recorded and all the Orders directed by the Government are fulfilled from time to time. Why do the stacks have been kept idle/close at that time? Company Administration look into the matter seriously. Special care should be taken for the health of Deoli villagers. Convener, Environment Public Hearing Committee, said that the company's bank guarantee of Rs five lakh was recently forfeited by Maharashtra Pollution Control Board for violation of norms. A Show Cause Notice has been issued to the company on May, 2023. So, the implementation of pollution rules and all subsequent processes after that is a continuous process. Convener said that the secondary emissions control system of the existing project should be improved/developed.

Member, Environment Public Hearing Committee opined that the said factory is a "notified industrial zone" of Maharashtra Government and the factory needs to do more in terms of green belt development. Planting of local species plants should be done on a large scale by distinguishing between industrial areas and residential areas. Similarly, all the directions of the District Planning Authority must be followed by the company and MIDC.

So the company must keep the pollution control system in operation very carefully and efficiently and follow the directives as passed by the Government of India and Government of Maharashtra from time to time. It is necessary for everyone to follow the rules regarding the buffer zone and keep an eye on it.

An Expert Committee will take further decision accordinglyConvener, Environmental Public Hearing Committee, asserted at the very beginning of the meeting that this Committee is only to record public opinion, suggestions, objections and does not have the authority to approve, reject or recommend the project.
