The Environment Public Hearing in respect of proposed expansion of Sugarcane Crushing Capacity from 1250 TCD to 3500 TCD & Co-Generation Plant Capacity from 3.0 MW to 6.5 MW & Establishment of 250 KLPD Syrup Based / 200 KLPD B & C Heavy Molasses Based Distillery at Gat No. 265,266,272,273,274,275,Village – Adgaon Darade, & Gat No. 28,29,30, Village- Rajura, Taluka – Selu, District – Parbhani, Maharashtra Proposed By Project Proponent Shree Tuljabhavani Sugar Private Limited, Adgaon Darade, Taluka-Selu, District-Parbhani, Maharashtra was conducted on Wednesday, the 04th October, 2023 at the site of the said industry at 11.00 a.m.

Shri Shripad R. Kulkarni, Sub Regional Officer, Maharashtra Pollution Control Board, Parbhani and Convener of the Environment Public Hearing Committee welcomed Smt. Anuradha Dhalkari, Additional District Magistrate, Parbhani and Chairperson of the Environment Public Hearing Committee; Shri Sujit Dholam, Regional Officer, Maharashtra Pollution Control Board, Chatrapati Sambhaji Nagar and Member of the Environment Public Hearing Committee, Environmentalists, NGOs, Journalists, Representative of media channels and Industry Officials and local people/participants who were present and with the permission of Chairperson Environment Public Hearing Committee started the proceedings of the public hearing.

Convener, Environment Public Hearing Committee informed that as per the Environment Impact Assessment (EIA) Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, Gol) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory

for certain projects which are covered in the schedule of the said Notification to obtain prior environmental clearance and public consultation is an important step for the same.

He informed that Maharashtra Pollution Control Board was in receipt of application from Project Proponent M/s Shree Tuljabhavani Sugar Private Limited, Adgaon Darade, Taluka-Selu, District-Parbhani, Maharashtra in respect of proposed expansion of Sugarcane Crushing Capacity from 1250 TCD to 3500 TCD & Co-Generation Plant Capacity from 3.0 MW to 6.5 MW & Establishment of 250 KLPD Syrup Based / 200 KLPD B & C Heavy Molasses Based Distillery at Gat No. 265,266,272,273,274,275,Village – Adgaon Darade, & Gat No. 28,29,30, Village-Rajura, Taluka – Selu, District – Parbhani, Maharashtra.

Convener further informed as per EIA Notification, 2006 the category of project falls under Category A schedule 5 (g) which requires to obtain prior Environmental Clearance from the Environment, Forest & Climate Change, Govt of India, New Delhi for which prior environmental consultation is mandatory.

Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing, and to inform them the developmental activities and Environment Management Plan of the proposed project.

Project Proponent had submitted online prescribed application along with pre-feasibility report to the, Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi on 16-06-2023 and it has been considered and Terms of Reference (TOR) were finalized and conveyed to the project proponent vide letter dtd. 30-06-2023.

After grant of permission from District Collector, Parbhani to conduct the Physical Environment Public Hearing on Wednesday, the 04th October, 2023 at 11.00 a.m. and as per the Notification dated 14-09-2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, GoI), New Delhi and subsequent amendment on 01-12-2019, Member Secretary,

Maharashtra Pollution Control Board, Mumbai constituted Environment Public Hearing Committee vide Board's Office Order No. E- 61 of 2023 vide letter no. BO/JD (WPC)/PH/B- 230831- FTS- 0002 dated 31-08-2023 as under: -

Convener informed that an opportunity is given to all participants to raise any doubts, suggestions or objections regarding the proposed project in environmental angle, which can be submitted by orally or in writing also during proceedings of public hearing.

The convener asserted that this Committee is only for recording public opinion, views, suggestions, objections regarding the proposed project from an environmental angle only and the Committee has no right to approve, reject or recommend the project. The suggestions/objections raised by the participants in the public hearing will be noted and it will be included in the minutes of the meeting. Similarly, the revised Environmental Assessment Report prepared by the Project Proponent and minutes of the public hearing after taking note of the video recording of the said meeting, suggestions and objections recorded in the meeting and after approval of Chairperson to the minutes, will be submitted to the Department of Environment, Forest & Climate Change, Government of

India, New Delhi through MPCB Head Office. An Expert Committee there will take further decision regarding granting of Environmental Clerance. Then the Convenor requested the Project Proponent/their Environmental consultant to start the presentation with due permission of the Chairperson of the Environment Public Hearing Committee.

With the permission of the Chairperson, the Environmental Consultant of the project made a presentation on the entire details of the proposed project along with the Environmental Management Plan (EMP). He informed that the total investment for the project will be Rupees 209.17 crores and for Environment Management proposed capital investment will be Rupees 52.8994 crores and Recurring investment would be 7.3538 crore. He informed that project is ZLD – Zero Liquid Discharge based. 150 people will get direct job opportunities in the project and after commissioning and staring operation of the project, there will be tremendous increase in indirect business of the area.

After the Presentation, Convener, Environment Public Hearing Committee appealed all attendees to raise suggestions, views, objections in respect of the proposed project in environmental angle only. While putting their point, first full name and name of the resident village to be mentioned.

Environmental Consultant said that as mentioned in the presentation the said project is a ZLD – Zero Liquid Discharge project and no liquid waste will be discharged out of industry premises. An Electro-Static-Precipitator, the most advanced device will be installed prior to the stack/ chimney, which will arrest the dust particles. The efficiency of the ESP is 99.9%. Therefore, the residents of the area will not suffer from air pollution. Apart from that, monitoring of stack emissions will be carried out regularly from the laboratory approved by the Ministry of Environment, Forest and Climate Change, Government of India. Hence, there will be no adverse effect on the crops.
