The Environment Public Hearing in respect of proposed project of Dongargaon Limestone Mine of capacity Total ROM: 1.52 MTPA (Limestone – 0.9 MTPA, Soil – 0.06 MTPA & OB – 0.56 MTPA) in Total Mine Lease Area of 252.36 hector located at Villages – Dongargaon, Dahigaon of Wani Taluka & Village Wegaon of Taluka – Maregaon, District – Yavatmal, Maharashtra proposed by Project Proponent M/s RCCPL Private Limited, 2nd Flooor, Industry House, 159, Churchgate Reclamation, Mumbai – 400 020, Maharashtra was conducted on Monday, the 17th July, 2023 at the site of the said industry on 11.00 morning.

At the commencement of the meeting, Shri Vasudev Laxmanrao Vidhate, At Post—Marki Mangli, District-Yavatmal, objected that the time of public hearing is 11:00 AM and it is now half past twelve. It is 11.00 am and still Hon. Collector has not come. General public is waiting here for almost one and a half hours. Farmers have come here. They have work in the fields. Still just sitting here for the past two hours. However, all those present agreed loudly that we would boycott this public hearing.

At this time Shri Vidhate appealed that no one in the pandol should stop. We want to cancel this public hearing. However, no one should participate in this public hearing. Everyone gave it a loud nod and many stood up to go out of the pavilion.

Shri Borkar, District President – Yavatmal, Maharashtra Navnirman Sena, who was present at that time appealed that even if the present Collector comes, no one should stay here. Everyone supported it. My laborers have been coming here since ten o'clock in the morning. There is no arrangement for them to sit. There are farming days. If the administration is not time bound, we don't need it. The need is for them.

We will grow our food and eat it. Some of the people coming out came out shouting slogans. He announced that the land belongs to us, not to anyone's father. Farmers were proclaiming the victory of the Shetkari Kruti Samiti.

At that time Shri Amol Yedge, IAS, Collector, Yavatmal arrived. After taking place on the dais by the Environment Public Hearing Committee, Shri Umashankar Bhadule, Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur informed those present outside the pavilion to come and take their place inside the pavilion.

Shri Amol Yedge, IAS, Collector, Yavatmal said that today RCCPL Pvt Ltd is having Environmental Public Hearing. The meeting time was at 11.00. But due to the emergence of "District Level Calamity " situation, I had to work there, I had to give some instructions over phone to some departments. So, there is late coming for the meeting.

Hence now I am directing to start the procedure of the Environment Public Hearing. The location of this project is Dongargaon, Dahigaon and Wegaon, Tehsil/Taluka is Wani and Maregaon. The company is located in two tehsils of Yavatmal district. The proposed limestone production capacity is 0.9 million.

Collector, Yavatmal said that this public hearing has been held today on July 17, 2023. As per order of Maharashtra Pollution Control Board dated 05/07/2023, Regional Officer, Maharashtra Pollution Control Board, Chandrapur is Member and Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur is Convener. Hence, now they are directed to start the public hearing process.

Shri Umashankar Bhadule, Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener of the Environment Public Hearing Committee welcomed Shri Amol Yedge, IAS, District Magistrate, Yavatmal and Chairman of the Environment Public Hearing Committee; Sou. Hema Deshpande, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member of the Environment Public Hearing Committee, Environmentalists, NGOs, Journalists, Representative of media channels and Company Officials and local people/participants who were present and with permission of Chairperson. Environment Public Hearing Committee started the proceedings.



Convener of the Environment Public Hearing Committee informed that Maharashtra Pollution Control Board was in receipt of application from Project Proponent M/s RCCPL Private Limited, 2nd Floor, Industry House, 159, Churchgate Reclamation, Mumbai – 400 020, Maharashtra for their proposed project of Dongargaon Limestone Mine of capacity Total ROM: 1.52 MTPA (Limestone – 0.9 MTPA, Soil – 0.06 MTPA & OB – 0.56 MTPA) in Total Mine Lease Area of 252.36 hector (Private Farm Land) located at Villages – Dongargaon, Dahigaon of Wani Taluka & Village Wegaon of Taluka – Maregaon, District – Yavatmal, Maharashtra.

Convener, Environment Public Hearing Committee informed that as per the Environment Impact Assessment (EIA) Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, Gol) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification.

Convener further informed as per EIA Notification, 2006 the category of proposed project falls under category "A" schedule no.1(a) Mining of Minerals which requires to obtain prior Environmental Clearance from the Environment, Forest & Climate Change, Govt of India, New Delhi for which prior environmental consultation is mandatory.

Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing and they should know the developmental activities and Environment Management Plan of the unit.

Project Proponent had submitted online prescribed application alongwith pre-feasibility report on 29-10-2021 to the, Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi and it has been considered and given online approval on 03-10-2022.

After sanction from District Collector, Yavatmal to conduct the Physical and Online Environment Public Hearing on Monday, the 17th July, 2023 at 11.00 morning, and as per the Notification dated 14-09-2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, Gol), New Delhi and subsequent amendment on 01-12-2019, Member Secretary, Maharashtra Pollution Control Board, Mumbai has constituted Environment Public Hearing Committee vide Board's Office Order No. E- 46 of 2023 under letter no. BO/JD (WPC)/PH/B- BO/JD(WPC)/PH/B-230705-FTS-0034 dated 05/07/2023 as under:-

It is also informed to the notified government departments (Sr.no.06 to 21 as above) about giving wide publicity at their level regarding Environmental Public Hearing.

The public hearing was thus widely publicized following the due procedure as per the Notification, so that it would be convenient for the project affected or concerned persons to register their views, comments, suggestions or objections with the concerned department. As per the directives, the public consultation is arranged on the project site.

This office is in receipt 05 notices, complaints, statements, objections regarding the above project and the persons / concerned institutions have been informed to attend the public hearing and submit their views, opinion, suggestions or objections if any. The participants who wishes to submit their writing statements can hand over the same to the representative of the MPCB.

The attendance sheets of the participants during the public hearing as well as the Order of the Environment Public Hearing Committee constituted by the Maharashtra Pollution Control Board are attached herewith as Annexure-I & II.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and

after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of the Chairman, Convener instructed the Project Proponent of the project to make a presentation on the proposed project's Environment Management Plan.

Convener appealed to the participants to raise their thoughts, comments, suggestions or objections regarding the proposed expansion project. Since the said public hearing is about environment, it is suggested to raise questions related to environment and while registering suggestions and objections, first mention your full name and village.

At that time, the Chairman, Environment Public Hearing Committee appealed the persons standing outside the pandol to come and take their place in the pandol. They were given five minutes for that. Chairman instructed Project Proponent to make a presentation after five minutes.

Convener also appealed the people standing outside the mandap to come inside the mandap and take their place. Project Proponent also suggested the local people to come to the pavilion for the meeting.

Chairman, Environmental Public Hearing Committee instructed Sub Divisional Officers and Tehsildars of Maregaon and Wani villages to instruct the people outside the pandol to go to the pandol from the respective villages of Maregaon and Wani talukas. Chairman ordered the videographer to film the Tehsildar instructing the people of the concerned village to go to the public hearing pavilion.

Chairman, Environment Public Hearing Committee said that the local farmers who were standing outside the pavilion were instructed to sit in the meeting. Five minutes was given for that. It has been ten minutes now and some farmers have come to the pavilion. However, six minutes more time is being given to the farmers. It is now 12.34 minutes and at 12.40 minutes and now Project Proponent will present the presentation.

Chairman, Environmental Public Hearing Committee said that after publication of public hearing notices in local and national newspapers, people



from the country, state and local villages were repeatedly advised to come to the pavilion for the meeting.

Chairman said that sixteen minutes ago the Sub Divisional Officer and Wani, Maregaon, Sarpanch were instructed to request the local people outside the pavilion and the local farmers to go to the pavilion for the meeting and they are requesting accordingly.

Chairman, Environment Public Hearing Committee directed that "in the minutes of the meeting, local people were requested to come to the pavilion for the meeting and it should be filmed".

Chairman, Environmental Public Hearing Committee advised the Project Proponent on further action. Project Proponent started the presentation of the project. Project Officer made a presentation in Marathi language regarding the expansion of the project and the Environment Management Plan. The following points were mainly explained in the presentation:-

Project Consultant informed regarding expansion of the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting:-

Detailed Information of the Project -

- Project Area, Latitude-Longitude, Map, Submerged Area, Beneficiary Area, Forest Area, Project; Features, Project Significance, Consequences, Land Use, Earthquake Stability;
- Project objectives, social status, employment opportunities, development of farmers due to the project;
- Project analysis, summary, findings;
- Analysis of social and economic status
- Information about air, water, land, sound, project affected areas etc.
- Impact and management of air, water, displacement, biodiversity due to planned project
- Information on environmental management after project implementation
- Information on other environmental management

After the presentation was over, Convener, Environmental Public Hearing Committee, said that the Project Proponent had made a detailed presentation about the proposed project. Now the participants are invited to register environmental suggestions, objections about the proposed project.

At that time, Chairman, Environmental Public Hearing Committee suggested to register questions and objections on each line. He urged the participants in the first row to ask suggestions, questions. There was no response in the first line. Then the audience in the second row was appealed to ask questions. There was no response from the other line.

Here again Chairman, Environment Public Hearing Committee called upon the participants in the third row to ask questions and suggestions. The persons in the third row had no response. So the persons in the fourth line were called upon to ask. There was no response from the fourth line.

At that time, Chairman appealed to those who want to raise their hands if they want to register environmental suggestions, thoughts, criticisms and objections about the proposed project. Here, after raising their hands, the Chairman directed to speak from the place instead of coming near the podium.

I am making some suggestions for environment conservation:-	that unemployment is the biggest pollution in the society, industrialization and various projects are needed to overcome it.

"Controlled blasting " should be done in the project. Similarly, the system of sprinkling water on the road should be implemented properly. If these two things are implemented in the project, there will be no problem of pollution in the mining project. Locals should be involved in all these activities. Similarly, Skill Development Training should be implemented for the youth in the project area. Therefore, the local vouth who will not aet employment in this project, can find it elsewhere.

Due to the said project, the Government gets revenue, employment opportunities are available to the local people. But obtaining "Environmental Clearance (EC)""

process is time-consuming and everyone loses. However, I request the Central government to avoid delay in the said process and grant environmental clearance within one year. I request the Environmental Public Hearing Committee to approve the said project. Similarly, the company requests that utmost care should be taken to prevent water and air pollution from the project.

Your Environmental Consultant has done a study/survey of the current state of the environment in the area. However, the current health status of the area should be studied Similarly, the current condition of crops in the area should also be studied. Also the ground level in the project area should be studied.

We are studying the groundwater level. All directions of CGWA Department of Central Government will be followed-Consolidated Hydro Geology Survey, planning/study of surrounding water storage, project water and ground water conservation. Due to the project, the project will not have any adverse effect on the water sources, drains (seasonal and perennial) in the area.

2)	Now regarding the pollution i.e. Wani, Maregaon talukas or neighboring Chandrapur district, big promises are given to the farmers living near and adjacent to the project until the project starts. Those farmers suffer a lot. But once the project starts, no one asks him. When the project is completed, he dies while requesting to give justice, but no one looks at him. So, the wall that is built next to OB, how long it will last and how much trouble will that OB cause to that farmer. This needs to be deliberated. Because during digging, fertile land is disturbed. Where you take OB. Can that soil be used for cultivation under CSR fund? A policy needs to be decided in this regard.	Project Proponent said that after the completion of the project, objections were raised about the disturbance. So here our project is going to be done in 252.36 hectares. So after completion of the project in the mining area, it is mandatory to develop the area as a green belt or as a water body. The slope of each dipping shall be maintained. It will be protected by a wall. Care will be taken to ensure that there is no damage to the nearby farmers.

At that time, Convener of the Environment Public Hearing Committee remarked that O.B. should not go into the drain.

Project Officer said that the dumping yard will keep it at a distance of 150 meters. Its slope will be maintained and a retention wall will be built. In any case, O.B. will not go down the drain.



Point no 3 -

Clogging of bore wells of farmers -

Answer -

There is no possibility of farmers' bore wells getting blocked. But if the borewell gets blocked because of us, we will compensate 100%. If it is confirmed, they will be given another bore. There is blasting and transportation, so there is no dust problem. The main issue here is fugitive emissions. Appropriate measures will be taken to control it. Wani, Maregaon which is an industrial area, has high air quality i.e. PM10 – 2,5; NOx exceeds national standards.

Here the Chairperson, Environment Public Hearing Committee appealed that the persons sitting at the back had just arrived. If they want to present their demand, they should raise their hands.

Apart from that, till this written statement continues, the government officials who are standing outside will request the persons standing outside to sit and raise their views in the mandap.

Convener said that PM10 - 2.5; The limit of NOx has been exceeded here. PM10 - more than 2.5 and NOx and SO2 more than 80. Your project will add to it.

Project Proponent said that the baseline survey of the area has been done. Air Pollutants are detected within the prescribed limits passed by the Central Government.

Convener, read out the statement that – the parameters in various locations are not real but false.

Project Officer said that the area has been surveyed and analyzed. All the proofs, photos are attached with the EIA report.

<u>Point No.. 3 -</u>

No details have been mentioned by the project promoter in the executive summary.

Answer –

All the above information has been submitted by us along with the EIA report. All eight locations were for water, air, and soil, all of which are included in the EIA report.

Point No.4 -

Not all measures to effectively control gas emissions and eliminate stack emissions.

This question has been answered. Pollution on Sponge Iron Plant – We don't have any project.

Point No. 5 -

There shall be no monitoring of ground water levels and its available quantity will be deteriorated. For residential area or Wani and Maregaon and nearby villages above the limits which is 55 dBA for residential area, 75 for industrial area, when did these activities will start, noise levels will go up. Noise levels are in prescribed standards.

Point No. 6 -

Chairman, Environment Public Hearing Committee again appealed that an opportunity is given for anyone to speak. He said that those who are standing outside the pandol are being given five minutes if they want to speak. They can come in and speak, they are given five minutes. It has been 03.53 p.m. Those who want to express their views, are being given an opportunity and the Project Proponent will give an answer. Those who are sitting in the pandol meanwhile can register any suggestions, objections they may have. There was no response from the audience.



Chairman, Environmental Public Hearing Committee while concluding the meeting said that the meeting was attended by a large number of people from across the country, from the state of Maharashtra and also from the project affected villages here. Everyone was allowed to speak. People have their say. However, the last opportunity is given to record suggestions, objections, thoughts. There was no response from the participants.

Chairman, Environmental Public Hearing Committee said that here various people have registered their suggestions, objections regarding the proposed project. Some written representations have been received for the meeting and those have also been answered by the Project Proponent.

Chairman, Environment Public Hearing Committee said that despite repeated requests to the public, no one raised their hands to make suggestions. Local farmers and others present in the meeting have left after giving their opinion. Hence, Environment Public Hearing Committee came to the conclusion that local people and other participants have been given enough time to raise their suggestions, objections and after raising it, they left the place.

Chairman, Environment Public Hearing Committee said that today Project Proponent presented the project of RCCPL Private Company, Dongargaon Limestone Mine, Area 252.36 Hectares, Location – Dongargaon, Dahegaon and Wegaon in three villages and Wani and Maregaon Talukas of Yavatmal District.

After that, after the presentation in front of the people who were present, the issues and questions asked by the participants were answered by the Project Proponent. Project Proponent have replied to the written representations received in the meeting and to the written representations received earlier. It is hereby announced that if the suggestions, objections are received by mail till 6.00 pm today, Project Proponent should submit their replies for the minutes of the public hearing.

Chairman, Environment Public Hearing Committee said that according to the rules of the government, the public hearing process has been completed by giving full notice to the people in advance in the newspaper, giving full notice to the notified government departments and village level and then giving full time in the meeting.
