Project Proponent M/s. Shree Cement Limited (Unit: Vidarbha Cement Plant), Bangur Nagar, Post Box No. 33, Beawar, Rajasthan has applied to Environment, Forest & Climate Change Department (MoEF & CC) Govt. of India, (Gol), New Delhi for permission of carrying out the study in the radius of 10 k.m. of project and preparation of Environment Impact Assessment (EIA) Report for obtaining Environmental Clearance for the Proposed Integrated Cement Plant with production capacity of Clinker: 1.5 Million Ton Per Annum; Cement: 3.5 Million Ton Per Annum (Ordinary Portland Cement, Portland Pozzolana Cement, Portland Slag Cement, Sulphate Resisting Cement, Rapid Hardening Portland Cement & Composite Cement); Captive Power Plant: 20 MW; Waste Heat Recovery System: 9.5 MW; Synthetic Gypsum: 1560 Ton Per Day (65 Tone Per Hour) and Diesel Generator Sets: 2500 KVA (1 x 2500 KVA or 2 x 1000 KVA & 1 x 500 KVA or 1 x 1000 KVA, 2 x 500 KVA & 2 x 250 KVA) Villages: Nimsala (Nimsada), Kondhala & Dahegaon, Taluka: Warora, District: Chandrapur, Maharashtra.

The proposed project has been approved by the MoEF & CC, Gol, New Delhi and Terms of Reference (ToR) was sanctioned on 31/05/2025. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing. To include in the final environmental impact assessment report the environmental issues raised by the project affected people about the proposed project. As the proposed project falls under Category A-3 (b), it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from MoEF & CC, Gol, New Delhi.

Project Proponent M/s. Shree Cement Limited, Bangur Nagar, Post Box No. 33, Beawar, Rajasthan, has applied Maharashtra Pollution Control Board on



28/08/2025 for conducting Environment Public Hearing. District Collector, Chandrapur, Maharashtra State, in co-ordination with MPCB Chandrapur Office, approved to hold a public hearing on 29/12/2025 in offline (physical) and online mode.

As per EIA Notification, 2006, 30 days' advance public notice was published by Sub Regional Office, MPCB Chandrapur in the Local Newspaper in Lokmat, Nagpur Edition for Marathi and in National Newspaper daily The Hitavada for English on 25/11/2025. An appeal is made to residents of the area, environmental organizations, residents to be displaced by the project or residents to be affected by the project in any other way to submit their views, comments, suggestions or objections about the proposed project in writing or by email to the local MPCB Chandrapur office till the date of public hearing. It included the online meeting number & password.

This office is in receipt of notices, complaints, statements, objections regarding the above project and the persons / concerned institutions have been informed to attend the public hearing and submit their views, opinion, suggestions or objections if any complaints, statements, objections.

The attendance sheets of the participants during the public hearing as well as the Order of the Environment Public Hearing Committee constituted by the Maharashtra Pollution Control Board are attached herewith as **Annexure-I & II.**

Minutes of the Environment Public Hearing:-

At the beginning of the meeting, Shri Umashankar Bhadule, Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener, Environment Public Hearing Committee welcomed Dr. Nitin Vyavhare, Additional District Magistrate, Chandrapur and Chairman, Environment Public Hearing Committee; Shri Tanaji Yadav, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member, Environment Public Hearing Committee, Project officials, Journalists, NGOs working in the field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized for the people and project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or



recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of Chairman of the Environment Public Hearing Committee, Convener asked Environment Consultant to give presentation of Environment Management Plan of the proposed project.

Project Consultant informed regarding the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting:-

1)	M/s Shree Cement Ltd. has informed the Gram Panchayats of Dahegaon,	The project proponents have stated that a cement industry will be

Kondhala, and Nimsada that it has purchased land in the boundary areas of these villages for the establishment of a cement project. However, a few days ago, a news report was published in a daily newspaper stating that the said land was not acquired for a cement project but for a coal mine and coal washery project, thereby attempting to create confusion among the local residents. Subsequently, within two days, this news was contradicted by the daily newspaper *Punya Nagari*. As a result, the project-affected people in Dahegaon, Kondhala, and Nimsada are confused as to whether a cement project or a coal mining project is proposed in this area. In this regard, it is necessary for both the District Administration and the company management to issue a clear clarification. It is also necessary to clarify what action will be taken against the journalists who published the false news. At the same time, the company has purchased agricultural land from farmers in Dahegaon, Kondhala, and Nimsada villages. Consequently, the farmers who have been cultivating this land for generations and the labourers dependent on agriculture have lost their means of livelihood. Therefore, I request the company management and the District Administration to provide employment opportunities in the industry to the project-affected farmers and agricultural labourers, in accordance with their educational qualifications. As per government norms, 80 percent of employment should be given to local people; however, this has not been implemented in the existing industries in this area. Therefore, I request the company management to ensure that 80 percent of the employment is given on a priority basis to the local people.

established at this location. An application has been submitted to the Ministry of Environment, Forest and Climate Change, Government of India, New Delhi, for a cement industry in this area; therefore, there is no connection whatsoever with coal mining in this region. Further, a proposal for a limestone mine of M/s Shree Cement Ltd. is adjacent to the said cement project, and a public hearing in this regard is proposed to be held on 31/12/2025. As stated by the Environmental Consultant, Mr. Kavadiya, during the project presentation, limestone is used for cement production. Therefore, the local people should ignore the confusion regarding coal mining, as only a cement industry and a limestone mine are proposed in this area. No coal mining project has been proposed in this region.

The Regional Officer of the Maharashtra Pollution Control Board, Chandrapur, has also stated that only a cement industry is proposed in this area and that no coal mining project has been proposed.

1)	Today, a public hearing has been organized by the Maharashtra Pollution Control Board. In this context, it has been stated here that the total project area is 42.76 hectares. Out of this, information should be provided regarding how many acres of land have been acquired in Kondhala, Belgaon, and Nimsada, since the public notice of the hearing mentions the names of a total of ten Gram Panchayats, including villages from Charurkhathi to Chinora, Majra. Therefore, my question is whether the said industry intends to expand in the future and establish industrial units in other villages as	The project proponents stated that their cement company has made a provision of approximately Rs. 167 crore for air pollution control. It is proposed to install state-of-the-art Electrostatic Precipitators (ESPs) and bag filters for various sources of pollution in the cement plant. Two Electrostatic Precipitators have been provided for the coal mill and raw mill. In addition, three bag houses have been proposed, and a total of 88 bag filters are proposed to be installed throughout the cement plant. These proposed pollution control systems are based on advanced technology and will be capable of controlling

well. There is an acute scarcity of water in Belgaon and Kondhala villages. At present, water has to be transported to Belgaon by bullock carts. The existing M/s Sunflag underground mine has severely affected the villagers; therefore, our confidence in this proposed project is also low. Hence, we require a clear clarification from the company management in written form. As stated during the presentation, the project will require a total workforce of 1,670 persons. However, it should be clarified whether this manpower requirement will be on a daily basis or on a monthly basis. It has also been stated that employment will be provided as per educational qualifications. Therefore, information should be provided regarding what percentage of local people from the project-affected villages will be given employment and what percentage of locals will remain unemployed. Due to the transportation associated with the proposed cement project, farmers owning land along the roadsides are likely to suffer losses. Therefore, information should be provided regarding the amount of compensation that will be paid to such farmers by the project proponents. Further, details of the transportation routes to be used should also be provided. Yensa and Kondhala have only one common route available, and this route is in a very dilapidated condition. The project will involve large-scale excavation, which will result in air pollution. Information should be provided regarding the measures proposed to control such pollution. Detailed information should also be provided regarding the tree plantation to be undertaken in the surrounding area.

99.99 percent of pollution. Further, raw materials such as iron ore, bauxite, and fly ash will be stored in enclosed sheds, which will significantly reduce the possibility of dust emissions in the surrounding area. The finished products will be stored in silos. All the above measures are proposed to prevent dust emissions. For the transportation of limestone from the proposed limestone mine, an enclosed conveyor belt system will be provided so that no dust emissions occur during transportation. All pollution control systems will be regularly maintained and repaired, for which an annual provision of Rs. 3.5 crore has been made. For this purpose, an Environmental Cell has been established, which will monitor the implementation of all these measures. In addition, continuous ambient air quality monitoring systems will be installed and connected to the servers of the Maharashtra Pollution Control Board and the Central Pollution Control Board. Information regarding emissions from the industry will be displayed at the main gate for public access. A separate road will be constructed by the company for transportation, which will be connected to the highway. No transportation will pass through the villages. The project will be developed on 42.76 hectares of land, out of which 33 percent, i.e., approximately 14.11 hectares, will be developed as a green belt. A three-tier green belt will be developed along the boundary wall of the industry as per the guidelines of the Central Pollution Control Board. As per CPCB norms, 2,500 trees per hectare are required to be planted. Accordingly, a total of 35,275 trees are proposed to be planted under this project. During the construction phase of the project, approximately 870 persons will be required. After

		commissioning of the project, about 800 persons will be required, including 300 permanent employees and 500 contract workers. The manpower will be required on a daily basis, as the plant will operate 24 hours a day. The company group has industrial units operating across India, and in all projects, significant employment is provided to local people. The industry requires skilled manpower; accordingly, in this project also, local people will be provided employment as per their educational qualifications.

The issues raised by local residents during the public hearing are recorded, and based on these, a time-bound action plan for development works proposed under CSR is prepared. This action plan is submitted to the Ministry of Environment, Forest and Climate Change, New Delhi. The Ministry examines the timelines and financial provisions, and compliance with the same is mandatory for all projects. Accordingly, CSR activities are implemented. After commencement of the project, development works will be carried out in consultation with the adjoining

	Gram Panchayats under the CSR framework. Wherever RO plants are required in the Gram Panchats, RO plants will be installed to provide purified drinking water. 1)	<p>Due to the existing Sunflag coal mine, Kondhala and Belgaon villages are facing severe water scarcity. In addition, a cement plant is proposed in this area. The company management is proposing to install RO plants; however, since there is no adequate availability of water in this region, such plants will not be of much use. The company should first ensure the availability of drinking water in the villages and only thereafter commence the project. While distributing CSR funds, the company should provide an amount of Rs. 8.0 lakh to each village so that the financial condition of the villages can improve. This will help in providing drinking water and other basic facilities. Buses and other facilities should be provided for school children.
