Preamble:-

Project Proponent M/s. Karnataka Power Corporation Ltd, Shakti Bhawan No. 82, Race Course Road, Bengaluru Urban, Karnataka has applied to Environment, Forest & Climate Change Department (MoEF & CC) Govt. of India, (Gol), New Delhi for permission of carrying out the study in the radius of 10 k.m. of project and preparation of Environment Impact Assessment (EIA) Report for obtaining Environmental Clearance for the Proposed Baranj Opencast Coal Mining Project, for Mining lease area: 1457.20 Ha Expansion in capacity from 3.50 MTPA to 5.00 MTPA located at Village: Somnala, Bonthala, Chek Baranj, Kadholi, Kesurli, Chichordi & Baranj Mokasa, Tal. Bhadrawati, Dist. Chandrapur, Maharashtra.

The proposed project has been approved by the MoEF & CC, Gol, New Delhi and Terms of Reference (ToR) was sanctioned on 09/08/2025. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing and to include in the final environmental impact assessment report the environmental issues raised by the project affected people about the proposed project. As the proposed project falls under Category A-1 (a), it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from MoEF & CC, Gol, New Delhi.

Project Proponent M/s. Karnataka Power Corporation Ltd, Shakti Bhawan No. 82, Race Course Road, Bengaluru Urban, Karnataka, has applied Maharashtra Pollution Control Board on 12/11/2025 for conducting Environment Public Hearing. District Collector, Chandrapur, Maharashtra State, in co-ordination with MPCB Chandrapur Office, approved to hold a public hearing on 30/12/2025.

As per EIA Notification, 2006, 30 days' advance public notice was published by Sub Regional Office, MPCB Chandrapur in the Local Newspaper in Lokmat & Punyanagari, Nagpur Edition for Marathi and in National Newspaper daily The Times of India & The Hitavada for English on 27/11/2025. An appeal is made to residents of the area, environmental organizations, residents to be displaced by the project or residents to be affected by the project in any other way to submit their views,



comments, suggestions or objections about the proposed project in writing or by email to the local MPCB Chandrapur office till the date of public hearing.

This office is in receipt 19 notices, complaints, statements, objections regarding the above project and the persons / concerned institutions have been informed to attend the public hearing and submit their views, opinion, suggestions or objections if any complaints, statements, objections.

The attendance sheets of the participants during the public hearing as well as the Order of the Environment Public Hearing Committee constituted by the Maharashtra Pollution Control Board are attached herewith as **Annexure-I & II.**

Minutes of the Environment Public Hearing:-

At the beginning of the meeting, Shri Umashankar Bhadule, Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener, Environment Public Hearing Committee welcomed Dr. Nitin Vyavhare, Additional District Magistrate, Chandrapur and Chairman, Environment Public Hearing Committee; Shri Tanaji Yadav, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member, Environment Public Hearing Committee, Project officials, Journalists, NGOs working in the field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized for the local people and the project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of Chairman of the Environment Public Hearing Committee, Convener asked Environment Consultant to give presentation of details of the proposed project.



Project Consultant informed regarding expansion of the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting:-

Detailed Information of the Project -

- Project Area, Latitude-Longitude, Map, Submerged Area, Beneficiary Area, Forest Area, Project; Features, Project Significance, Consequences, Land Use, Earthquake Stability;
- Project objectives, social status, employment opportunities, development of farmers due to the project;
- Project analysis, summary, findings;
- Analysis of social and economic status
- Information about air, water, land, sound, project affected areas etc.
- Impact and management of air, water, displacement, biodiversity due to planned project
- Information on environmental management after project implementation
- Information on other environmental management

After presentation was made through PPT by the company, the Convener appealed to the participants to raise their environmental suggestions or objections about the proposed project. While raising questions, inform the full name, village. He also informed Project Environment Consultant and Project Proponent to give appropriate answers.

The company is imposing terms and conditions while carrying out the rehabilitation of the village. We oppose this company until proper rehabilitation is carried out. Certain terms and conditions were imposed by your authority in this regard. should be provided on whether and how these specific terms and conditions have been complied with. One of the conditions stated: "PP shall construct permanent boundary wall all along the boundary of Ordinance Factory within 1 year." A period of three months was allotted for this, with an expected expenditure of INR 20 million. However, the protective wall has not yet been constructed. If the company is not complying with the terms and conditions, clarification is required on the purpose of holding this public hearing. If the company is unable to comply with the conditions of the environmental clearance, this public hearing should be cancelled. No approval for expansion should be granted until the company fulfills all conditions of the environmental clearance. It has been reported that 185 hectares of land located 50 meters from Chichordi village is intended for acquisition for expansion according to the agreement of December 2016. However, even after ten years, the land has not been acquired. In a recent meeting in Nagpur, it was stated that KPCL will acquire the land at Chichordi. Chichordi already suffers from severe air, noise, and water pollution. Until the company acquires the 185 hectares, permission should not be granted for annual production of 5.0 million tons. I request the Hon. Minister of Environment, Government of India, Mr. Bhupendra Yadav, and Hon. Ms. Pankajatai Munde, Minister of Environment and Climate Change, Maharashtra Government, Mumbai, to ensure that compliance with the conditions for 3.5 million tons per year before granting permission. Another condition in the environmental clearance was: "PP shall construct Sewage Treatment Plant (STP) within one year" with an expected expenditure of INR 5 million. The

Maharashtra Pollution Control Board issued a 'show cause notice' to the company, and a copy of the response is available to me under the Right to Information. The proposed instructions included: "You have not provided ETP for workshop & vehicle washing effluent, and effluent is being discharged on land near coal transportation roadside. You have not provided tyre washing system." To date, the company has not installed the tyre washing system. It is not possible that the vehicles from the mine will not cause pollution. I acknowledge the importance of industries for national economic development; however, human life must be safeguarded. The company has not established a buffer zone or a green belt. No fixed-type water sprinkling system has been installed. As per the notice: "You have provided only kachha lagoon instead of sedimentation tank with baffle wall & mine water discharged into local nalla which finally meets Kondha nalla." The company operates 400-500 vehicles daily without any apparent planning. As a result, residents of Kondha, Baranj, and Mokasa are suffering from dust pollution, which adversely affects their health. The Government of India and the Government of Maharashtra must consider whether human life or production takes precedence. If companies violate environmental regulations, the future of India is at risk. The company should have at least four air quality monitoring systems. Neighboring companies have four such systems providing PM10, PM2.5, and other data. Information should be provided on the placement of the company's air quality monitoring system. The company was expected to respond within seven days, but no response was received. The Maharashtra Pollution Control

Board was expected to take action within seven days, but over a year, only bank guarantees were seized. Seizing bank guarantees of INR 5–10 lakh does not achieve any corrective outcome. Despite these measures, if no improvements occur, the company's CTE, CTO, and environmental clearance should be revoked. No permission should be granted to the company until proper environmental planning and compliance are ensured. The company has mined 7.5 million metric tons of coal from forest areas. Permission was granted by the Forest Department on 11/07/2022 under certain conditions. Until the rehabilitation of Baranj Mokasa village is completed, mining from forest areas should not be permitted. Mining has caused the death of eight cows owned by Mr. Nilesh Korde and the death of the mother of Mr. Arvind Devtale. Additionally, eight deaths occurred in Kondha due to pollution-related accidents. How environmental and pollution balance is being maintained is questionable. The mother of Mr. Arvind Devtale died following a tiger attack near the company's electric fence. Her body was found two days later, and her last rites were performed. In this context, I question the rationale for sending the public hearing proposal to the District Collector, Chandrapur, after screening and scoping by the Ministry of Environment, Government of India. The proposal should be cancelled. Expansion should not be approved until all issues are resolved and pollution is controlled. I request the Hon. Minister of Environment, Maharashtra Government, to obtain clarification from the company based on a truthful report. Thousands of employment opportunities exist in the country; the company's operations are tantamount to a threat to human life.

<p>In countries such as China, environmental protection is prioritized, and strict compliance is monitored daily. In India, such monitoring facilities do not exist. However, complaints against a company should prompt proper monitoring by the Pollution Control Board. Currently, the Sarpanch, Deputy Sarpanch, and residents oppose the company. In 2020, we supported the company's commencement, as officials assured that the village would be rehabilitated within three months. However, mining has proceeded for the company's benefit, and the promise of rehabilitation has been ignored. The company imposes terms and conditions to harass locals. Regarding the mining of 7.5 million metric tons, I request the Hon. Additional District Magistrate to conduct a thorough investigation. Mining from forest areas must also be examined, and appropriate action is expected. Three days ago, I met the Coal Minister, Mr. Kishan Reddy, and submitted a petition with signatures of 285 residents. He assured a thorough investigation and action plan. The Government must take serious note of this matter. Failure to do so will leave residents of Baranj with no option but to undertake a hunger strike outside Jantar Mantar and the Minister of Environment's residence. There is no buffer zone, no green belt, no mechanized sweeping machines, no arrangement of transportation through villages, only one CAAQMS is installed. Cancel C2E, C2O and EC, do transportation by other route, use conveyor belt mechanism for coal transportation, provide public health care centers and schools. Mine is not eligible. Animals died due to pollution and due to accidents. I oppose this project.</p>

A clear explanation regarding this matter should be provided. As per the Hon'ble Supreme Court's orders, the mine had been completely cancelled. Subsequently, in accordance with the Supreme Court's directives, the mine was allowed to resume operations. When the mine was restarted, all rules should have been applied anew. It should be clarified under which rule a person residing in Maharashtra is prohibited from purchasing property in Karnataka. Earlier, citizens from other states were not permitted to purchase property in Jammu & Kashmir and Arunachal Pradesh; however, these restrictions have now been removed. Today, citizens of the country are allowed to buy property anywhere. If a person from Chandrapur has purchased property in Bhadravati, an explanation should be provided as to why they have been declared ineligible. According to the Gram Panchayat's list, all citizens should have been considered eligible by the company. Instead, the company has arbitrarily decided eligibility, creating a game of inclusion and exclusion, which is regrettable and unjust to the villagers. Until the village is fully rehabilitated, the rights over the land in question cannot be reduced. The rehabilitation process for the village has been ongoing for the past 15–20 years, yet the company has not completed the village's rehabilitation. Mining and coal extraction operations by the company commenced in 2021–22. Since then, local environmental



<p>organizations have repeatedly lodged complaints with the Maharashtra Pollution Control Board (MPCB) regarding violations of environmental regulations. Consequently, the MPCB has, in the financial years 2022, 2023, and 2024, confiscated the company's security deposits for three consecutive years. However, no criminal proceedings have been initiated. The MPCB should provide clarification on this matter. Due to the company's operations and transport activities, the Kondha Nala has become polluted, and the contaminated water is being discharged into the Penganga River, further polluting it. 



If required, a copy of this report will be provided to the villagers, and it will also be available on the company's website. The land acquisition compensation has been completed, and an amount of INR 6.97 crore has been disbursed. Following the project expansion, it is anticipated that traffic issues in Kondha village may increase. To address this, reports have been commissioned from two organizations namely, VNIT, Nagpur & RITES Ltd., New Delhi and a detailed project report is being prepared that will detail the associated costs and timelines. This work will be carried out in accordance with the guidelines of the Ministry of Environment, Forest and Climate Change, Government of India. Controlled blasting in the mine area is conducted following the guidelines of the Directorate General of Mines Safety. No untreated wastewater is being discharged into the Kondha Nala; only treated wastewater is released. Treatment facilities have been installed in accordance with the guidelines of the Ministry of Environment, Forest and Climate Change, Government of India. For dust control, the company utilizes 02 water tankers of 28 KL capacity, 04 water tankers of 12 KL capacity, and 02 water tankers of 09 KL capacity. Currently there is 01 cannon fogger, and provision will also be made to increase the number of cannon foggers, if required.</p>

Under Section 124 of the Gram Panchayat Act, 1958, the company has an outstanding liability of ₹3.40 crore, which has not yet been paid. Information should be provided regarding when the company will settle this amount. The company is providing only ₹15.0 lakh to the villagers. In a city like Bhadrawati, ₹15.0 lakh is insufficient to purchase land and construct a building. In comparison, Arvindo Company provides compensation of ₹26.0 lakh for building construction. Here, the villagers have to bear a loss of ₹9.0 lakh compared to Arvindo. The company should carry out the rehabilitation of the village and provide all necessary facilities at the rehabilitation site. Furthermore, as per Clause 10.3 of the agreement, Rs. 50 lakh was allocated for establishing an Industrial Training Institute (ITI); however, such an ITI has not yet been set up. There is significant dust pollution from the coal mine to the Majri railway siding, and the company has not taken any measures to address it. Spraying via canon foggers is necessary to control the dust. Although the company has shown canon foggers on paper, the actual arrangements have not been made. Canon foggers have been installed within the mining area, but not on the transportation roads where they are most needed. Unemployment among local youth is a major issue in this area. The company should provide information to the Hon'ble District Collector regarding the deposit of Rs. 50 lakh with the district administration. Despite the presence of highly educated local youth, the company is giving senior positions to outsiders. Have the lands of local residents been acquired only to employ them as security guards?
