STANDING ORDER

Sub : Constitution of the Scrutiny Committee to examine the cases of compliance in respect of Directions of closure reported by the defaulting industries as per the order passed by the Hon'ble Supreme Court of India in Writ Petition No. 657/95.

Hon'ble Supreme Court of India has issued various directions to the various authorities including the State Pollution Control Board by its order dated 14/10/2003. As per the order passed by Hon'ble Supreme Court of India, the Board has issued Directions of closure against the defaulting industries, generating hazardous waste, which have not applied for an authorization / not become a member of common facilities as well as not complied with the conditions of registration for processing oil.

A no of units have started filing their replies / objections stating that they have applied for authorization / become a member of the common facilities. It becomes necessary to examine this cases through a Committee instead of putting up day to day cases before Member Secretary / Hon'ble Chairman. Accordingly, the following Committee is constituted to scrutinise the cases and put up for the orders of Member Secretary / Chairman as per their availability in the office.
