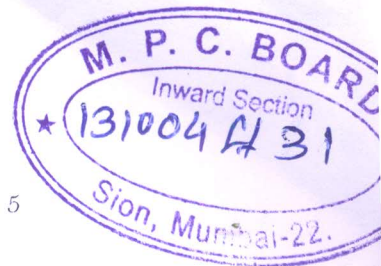



of Professional Charges and signing of Vakalatnama.



As per telephonic instructions of Shri. D.T. Devale, Sr. Law Officer of the MPCB on 23.9.2013, he has sent Bio-Data of Mrs. Supriya R. Dange, Advocate for her appointment to look after all matters of SEAC SEIAA and Environment Department, Govt. of Maharashtra alongwith Adv. Deepak Gupte on account of joint appearance before the NGT, Pune more particularly when Adv. Gupte may not be able to appear, due to attendance of High Court of Judicature at Mumbai, Bench at Mumbai. Mrs. Supriya R. Dange, Advocate is agreed to appear on behalf of the SEAC/SEIAA & Environment Department before the NGT, Pune. A copy of the Bio-Data alongwith her request for consideration is enclosed herewith at Annexure - VIII.

Adv. Deepak Gupte will be paid professional charges of Rs. 25,000/- for each case as per the scheme approved by the MPCB. The professional charges will be paid as under on account of joint appearance, as Shri. Gupte, Advocate when in High Court at Mumbai, Adv. Supriya Dange will attend the matters.

1. Rs. 20,000/- to Shri. Deepak Gupte, Advocate per case and
2. Rs. 5,000/- to Mrs. Supriya Dange, Advocate per case to attend cases jointly with him and more particularly independently when Adv. Gupte is at Mumbai High Court.

Both of them to co-ordinate with each other and to ensure that each case is attended by any one of them without fail.

Sr. Law Officer, MPCB will co-ordinate with them and will attend as well as appear jointly with them in all matters by signing vakalatnama. He will argue and conduct important matters as and when necessary. He will issue appropriate appointment order being a Nodal Officer in this behalf as approved in the above note.

This is submitted for the development of good mechanism and proper attention of all the NGT matters. This may also brought to the notice of Hon'ble Bench at NGT.
