Maharashtra Pollution Control Board is functioning under the Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986. Board has powers of Entry and Inspection of the establishments u/s 23 (1) of Water (Prevention & Control of Pollution) Act, 1974, u/s 24 (1) of Air (Prevention & Control of Pollution) Act, 1981 and u/s 10 (1) Environment (Protection) Act, 1986.

Board has introduced "Randomized Risk Based Inspection & Sampling" through software based tool for selection of industries based on pollution potential. This software based tool for field staff is introduced to ensure the transparency and strong monitoring mechanism of the Field Officers performance. The list of the industries for sampling and inspection for each Field Officer is generated for his jurisdiction through software and same is monitored through automated software based tool.

Department of Industrial Policy and Promotion (DIPP) under 'Ease of Doing Business' Project recommended Business Reforms to various departments in Maharashtra which includes initiation of 'Central Inspection System (CiS)'wherein four government departments namely – MPCB, Labour Directorate, Maharashtra Labour Welfare Board (MLWB) and Directorate of Industrial Safety & Health (DISH), will visit the Industry jointly as per schedule generated at the beginning of the month. Software base system developed in such way that, same Inspector will not inspect the same establishment/Industry/organization twice consecutively.

The field officers of the Board will get schedule of sampling and inspection of 20 no's of units per month through Central Inspections System and same shall be monitored through automated software based tool. In addition to this, Board will assign need-based field visits (unavoidable circumstance such as Accident, complaint, committee visit, Consent

Management related visit, surprise squad visit, etc.) to Sub-Regional Officer, Regional Officer and HOD(s). The earlier, visit scheduler generated through "Randomized Risk Based Inspection & Sampling" system is replaced by Central Inspections System (CtS).

Therefore, to ensure the transparency and strong monitoring mechanism, it is decided to follow procedure strictly as below:

- All the officers shall carry out sampling & inspections as per the Schedule given by the software based tool.
- The Inspection report of MPCB duly signed by the visiting officer of MPCB and industry representatives shall be uploaded on the portal within 48 hours.
- The appropriate legal action as per the non-compliances reported will be initiated with
 due process as defined in the Board's earlier Circulars. The Sub-Regional
 Officer/Regional Officer shall initiate suitable legal action, and pursue it to logical end,
 under intimation to the concerned HOD / area co-ordinator.
- 4. In addition to the risk- based inspections, inspections of the unit's in an unavoidable circumstance such matter related to Legal Cases/Complaints/Press Clipping/Issue referred by Government and other authorities, the concerned Regional Officer / Sub-Regional Officer shall arrange to carry out inspections as per the instructions issued therein so as to take further action for implementation of various Environmental Laws.

This circular is issued with overriding effect on earlier circular issued by the Board vide reference at Sr. No. 5 and 6 above.

This circular will come in force with immediate effect.
