CIRCULAR

Sub: Establishment / Expansion of industrial units with effluent treatment in CETPs- regarding.

Ref: 1. Directions of CPCB No. B-22013/2/PCI-III/2008 dated 02.09.2008
2. The Honorable NGT Order dtd. 02/07/2015
3. The Honorable High Court Order dtd. 13/08/2015

Chairman Central Pollution Control Board has issued the directions u/s 18(1)(b) of the Water (Prevention & Control of Pollution) Act, 1974 to MPC Board that expansion/establishment of the industrial units should not be permitted in the areas where the associated CETPs are not complying with the required standards and where such CETPs do not have adequate hydraulic load capacities.

However Honorable National Green Tribunal (West Zone) in the Application No. 37/2013 (WZ) vide order dated 02/07/2015 has reproduced directions issued by CPCB as:

- Initiate monitoring program for all CETPs at least every quarter and take follow up action against industries/CETPs not complying with the prescribed standards.
- Not to permit expansion/establishment of the industrial units in the areas where the associated CETPs are not complying with the required standards and where such CETPs do not have adequate hydraulic load capacities.
- Submit action report every quarter on (1) and (2) above within one month of every quarter to CPCB.


Also the Honorable High Court in the Writ petition No. 7208/2015 vide order dated 13/08/2015 has issued directions that "without disturbing the above directions of Honorable NGT at this stage we clarify that where MIDC finds that concerned industry has no pollution potential, MIDC may grant the permission for establishing or expansion of an industrial unit under intimation to NGT."

Board is continuously evaluating performance of CETPs in Maharashtra. During evaluation and based on JVS analysis reports it is observed that some of CETPs are not conforming with the prescribed consented standards. The list of CETPs whose performance is not satisfactory is enclosed as annexure – I.

Therefore in compliance with the orders issued by Honorable NGT and Honorable High Court; Board has decided to not to consider expansion/establishment of the industrial units in the area of these CETPs except units which has Zero Liquid Discharge and no pollution potential.

The nonconforming CETPs shall be monitored weekly by respective Regional Officers of Board and the performance shall be assessed quarterly. On the basis of quarterly assessment the list of nonconforming CETPs will be updated.

This is issued with the approval of the Chairperson, MPC Board.
