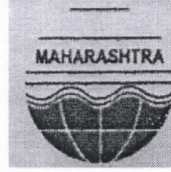

## CIRCULAR

**Sub:** - Sampling of industries under the purview of CAC & CC


**Ref:** - Discussion during CC & CAC meetings held from time to time.

You are aware that the monitoring of industries under the purview of CAC & CC should be carried out monthly & reports submitted alongwith application of the respective industry for grant of consent.

During discussion in CAC & CC meetings it is observed that latest JVS monitoring reports of Air & Water are not submitted along with applications received for grant of consent. Sometimes it is also observed that even in case of Air Pollution potential industries only water analysis reports are submitted & vice-versa.

It is therefore directed that all the applications submitted for grant of consent of industries under the purview of CC & CAC should be enclosed with minimum 6 nos. of latest JVS reports of Water pollution potential industries & vice versa to Air pollution potential industries, also if you fail to collect samples you are directed to submit undertaking that the samples of the respective industry are not collected & reason for the same.

All the Regional/ Sub Regional Officers are hereby directed to scrupulously follow the said Circular with immediate effect failing which stringent will be initiated against the concerned Officer.
