This has reference the initiative of the Govt. of India for 'Ease in doing business' towards simplifying the process of obtaining licenses from the various Government Offices.

Combined application form under Water Act; Air Act & HW Rule for obtaining Consent from the Board by Red/ Orange/ Green Category of industries has already been initiated by the Board from since 1996-97 and uploaded on Board's website later on. It is observed that most of the information contained in the application form like details of Hazardous Waste, details of Hazardous Chemicals, applicability of Environmental Clearance etc. are not related to Green Category of industry. Small entrepreneurs are finding it difficult and often confused at the time of filling application form. Therefore, the process of filling the application form is getting delayed. Hence, it has been decided to simplify the Consent application form for Green Category industry by removing irrelevant information as a Maharashtra initiative with regards to ease of business from the applicability of Environmental licenses.

The CAC in its meeting held on 24/06/2015 has decided to introduce Simplified Consent application form for obtaining Consent for 'Green' category of industries with the approval of the Environment Dept. Also, Board in it's 165th meeting held on 14/10/2015 has approved Simplified Consent application form for Green category of industry subject to approval of GoM. Environment Department, GOM vide letter No. SEAC-2016/C.R.-11/TC-2 dtd. 11/02/2016 has approved draft of Simplified Consent Application form for Green Category industry.

Hence, for the ease of doing business, it has been decided to adopt Simplified Consent application form for Green Category industry.

Therefore, henceforth it is directed to accept Simplified Consent application form for Green Category industry.
