## Circular

- Sub:** 1) Categorization of new or left-over White category industries on Directions issued u/s 18(1)(b) of The Water (P & CP) Act, 1974 and The Air (P & CP) Act, 1981 vide dated 12/02/2025.  
2) Self declaration for grant of consent under White category
- Ref:** 1) Directions issued u/s 18(1)(b) of The Water (P & CP) Act, 1974 and The Air (P & CP) Act, 1981 regarding harmonization of classification of industrial sectors under Red, Orange, Green, White & Blue categories issued by CPCB vide dated 12/02/2025.  
2) Constitution of committee for Categorization of new or left-over White Category industries vide dated 19/05/2025.

The Central Pollution Control Board has issued Directions u/s 18(1)(b) of The Water (P & CP) Act, 1974 and The Air (P & CP) Act, 1981 regarding harmonization of classification of industrial sectors under Red, Orange, Green, White & Blue categories issued by CPCB vide dated 12/02/2025.

The CPCB in the said directions has directed that any further addition of any new or left-out sector & their classification which is not listed in revised list of Red, Orange, Green & White categories, shall be done at the level of concerned SPCB by constituting a committee & following revised criteria & guidelines as detailed in the report and no concurrence of CPCB shall normally be required

In compliance with these Directions, the MPC Board, vide Office Order dated 19/05/2025, constituted a Committee comprising the Technical Heads of Departments (HoDs) for the categorization of new or left-over White category industries. The White category is considered "practically non-polluting". The Committee has since identified 222 new White category industries, along with 56 sectors already identified by CPCB. The consolidated list of these 222 White category industries which is enclosed herewith for reference.

As per MoEF & CC letter No. Q-15012/2/2022/-CPW-Part(1)/e-240741, dated 14/11/2024 Standard Operating Procedure (SOP) for implementation of the said Notification dated 12/11/2024, the consents for White category industries will be granted based on self-certification by the respective White category industries on the portal of the MPC Board.

This circular shall be implemented scrupulously from the issuance of this letter without fail.

**Note: -**

1) After perusing the lists of other Pollution Control Boards, such as Gujarat, Madhya Pradesh, and Tamil Nadu, it is observed that most of the activities listed do not fall under the Consent regime. Examples include agricultural services not classified elsewhere (e.g., harvesting and threshing), distributors of agricultural machinery and equipment, distributors of industrial machinery and equipment (other than electrical), horticulture, jute and natural fibre goods manufacturing units, etc. Therefore, these activities do not require consent.

2) In the lists of other Pollution Control Boards, separate entries have been provided for each activity that could otherwise be grouped under a single category-for example, sports goods, cotton cloth knitting, cotton quilt and mattress making, cotton belts and tapes/cotton niwar, cotton cloth knitting without dyeing, cotton socks knitting, cotton vests knitting, etc. The Maharashtra Pollution Control Board, however, covers such activities under broader categories that covers nearly all activities listed individually by other Boards.

3) All trading activities of any kind are not listed in industry categorization and are not required to obtain consent in any category including White category.
