CIRCULAR

Sub: Coordination of Regional Offices and innovative methods for pollution control, monitoring & abatement measures and compliance

- Ref: 1) HODs Review Meeting held on 25-08-2008
 2) Letter No.MPCB/PCI-II/06/B-1631, dated 28-08-2006
 3) Circular No.MPCB/PCI-II/F-3842/B-7043, dated 26-11-2007

For effective implementation of the above referred circulars, it is necessary that the HODs take regular follow up of the following activities in the Regions allocated to them for coordination:

1. Visit their Regional Offices at least once every month for review
2. Evaluate performance as per Score Card and take measures to improve score
3. Review revenue earnings for their region and suggest measures for increase
4. Follow up action taken on complaints, newspaper reports, VIP references etc

In addition, various innovative methods with the help of technology are available for monitoring, control and compliance. Some areas are specified below for the concerned HODs which are not exhaustive.

PSO	Use of Zoning Atlas for Industrial location & more GIS based area specific plans
WPAE	Scrapping of extra lagoons, reducing hydraulic load and reduction of BOD/COD
APAE	Online monitoring of CETP, interlocking of pollution control devices/main process
ZO PAMS	Online monitoring of stacks, remote monitoring by web camera and other devices
RO HQ	Installation of GPS devices for monitoring all transport related to pollution control

It is expected that with their vast experience and knowledge there will be progress in each of these aspects and specific time bound projects will be implemented in their respective Regions.
