## OFFICE MEMORANDUM

Subject:- Requirement of Environmental Clearance for building projects - Clarification, regarding.

Environment Department, Government of Maharashtra had issued a Circular No. ENV-2013/CR-39/TC-3 dtd. 29.6.2013 to appraise the applications of the Project Proponents in the light of relief granted by the Hon'ble High Court in different Writ Petitions mentioned below. The said Circular was issued subject to further orders of the Hon'ble High Court.

The National Green Tribunal, Bench at Pune have passed Orders dtd. 26.9.2013 in Appeal No. 72/2013 filed by Virani Construction Co. V/s the SEAC and Appeal No. 73/2013 filed by Aadi Properties (P) Ltd. wherein stating following points:-

## In Appeal No. 72/2013 :-

1) At para 13 & 14 of the Order it is stated that, "Hon'ble Tribunal is of the opinion that the relief granted by the Hon'ble High Court to other Project Proponents like M/s Saumya Buildcon Pvt. Ltd., M/s Tridhatu Ventures Ltd and M/s Nahur Vivekanand Co-op. Housing Society Ltd. and another, having regard to the facts of particular cases. The Judgments of the Hon'ble High Court of Bombay are rendered in peculiar circumstances of each case. The said judgments do not give a ga-by to the requirements as enumerated vide MoEF Notification dtd. 14.9.2006 nor OM dtd. 12.12.12, issued by the Ministry of Environment & Forests (i.e. MoEF), has been quashed or held ultra vires. In fact, OM dtd. 12.12.12, brings about internal instructions given by the MoEF to the State Authority. The Appellant cannot, as a matter of right, challenge the impugned decision of SEAC"

### In Appeal No. 73/2013 :-

- 1) At para 15 of the Order it is stated that "So far as the requirement to obtain EC is concerned, it is essential to note that the proposed construction of the Appellant, even after excluding amenity building, will be more than 20000 m2. Hence, the EC is essential requirement."
- 2) At para 17 of the Order it is stated that "In the opinion of the Hon'ble Tribunal, the Judgment of Hon'ble High Court at Bombay, cannot be read in the manner as canvassed by the learned Counsel for the Appellant. The said Judgment cannot give a go-by to the requirements of the MoEF Notification dtd. 14.9.2006 nor O.M. dtd. 12.12.12 issued by the MoEF, has been quashed or held as ultra vires."

In view of the above Orders passed by Hon'ble National Green Tribunal, Pune Bench, the Circular No. ENV-2013/CR-39/TC-3 dtd. 29.6.2013 is hereby reviewed and taken back.

It may be further noted that, if any construction plan above 20000 m2 is approved (for Residential / Commercial / Rental Housing Scheme / SRA / Industrial construction etc.) by the Planning Authority and part Commencement Certificate below 20000 m2 issued for commencement of the construction work to the Project Proponent without making mandatory to obtain prior EC, then such construction will be treated as a violation of the provisions of the EIA Notification 2006 read with Office Memorandum No. J-11013/41/2006-IA.II (I) dated 12.12.12.
