CIRCULAR

Sub: Regarding grant of NOC for setting up Warehousing facility for storage of food grains in MIDC Areas.

* 2.C.P.C. Board's letter F.No. B-29012/1/2012/ESS/1540 dtd. 4/06/2012.

This has reference with letter of C.M.D., Maharashtra State Warehousing Corporation requesting to issue instructions to all Regional Officers to issue NOC whenever Corporation approach for NOC for construction of warehousing building facility for storage of food grains in MIDC Areas.

The Central Pollution Control Board vide letter F.No. B-29012/1/2012/ESS/1540 dtd. 4/06/2012 has issued directions u/s 18(1)(b) of Water (P&CP) Act, 1974 regarding Classification of industries into Red, Green and Orange Category according to which "Infrastructure Development Project" is categorized as "Orange" category at Sr. No. 39. Further, if construction BUA is above 20,000 sq. mtrs., we may consider grant of Consent to Establish subject to condition of obtaining Environmental Clearance and if construction BUA is less than 20,000 sq. mtrs. we may communicate that activity is to be regulated by the Local Authority and issue NOC accordingly.

Therefore, you are instructed to direct Sub-Regional Officers/Officers in your office to extend necessary co-operation whenever Officials/Staff of Maharashtra State Warehousing Corporation approach for obtaining NOC for construction of warehousing building facility for storage of food grains in MIDC Areas and help them for submission of the application for grant of Consent to Establish to the aforesaid activities.
