Sub: Effective implementation of Directions issued by the Central Pollution Control Board or the State Government u/s 18(1)(b) of the Water /Air (P&CP) Act, 1974/1981 respectively and u/s 5 of the Environment (Protection) Act, 1986.

- Meeting on the subject of compliance status of the Directions held on 16/3/2012 in the Chamber of Member Secretary, MPCB

A meeting was convened in the Chamber of the Member Secretary, MPCB to decide further line of action in respect of various directions received by the Maharashtra Pollution Control Board from the Central Pollution Control Board or the State Government u/s 18(1)(b) of the Water / Air (P&CP) Act, 1974/1981 respectively and u/s 5 of the Environment (Protection) Act, 1986 from the Central Government. It was specifically pointed out that the CPCB has specifically brought to the notice of the MPCB that the status of compliance of directions issued u/s 18 (1)(b) of the Water /Air (P&CP) Acts is not satisfactory. In the meeting of the Central Pollution Control Board, the status of compliance of the directions issued to the SPCBs / CCs was reviewed. The Board Members expressed displeasure on the poor status of compliance and desired that the SPCBs be advised to comply with the directions issued and communicate the status/action taken report to the CPCB immediately. A list of directions issued to the MPCB during last 3 years is enclosed herewith for further necessary action in the matter.

The Asstt.Secretary(Tech.) by his letter dtd.24/11/2011 requested the Policy and Law Division and concerned Regional Officers within whose jurisdiction the defaulting industries against whom directions have been issued u/s 18(1) (b) of the Water/Air Acts, with a request to forward detail compliance status report in respect of directions issued by the Central Pollution Control Board. Sr.L.O. pointed out that all the directions are not being received by the Policy and Law Division because of marking of such directions to different HoDs and therefore, the Policy & Law Divn. is unable to forward a detail compliance status report in respect of all the directions issued to the MPCB.

It was decided that all the HoDs should make available the copies of directions received by them from the CPCB/State Govt. u/s 18(1)(b) of both the Water / Air Acts within a weeks time as well as directions received by the MPCB u/s 5 of the E(P) Act, 1986, so as to initiate integrated actions on the above directions at the Policy & Law Division only.

It was further decided that one of the Asstt.Law Officer of P&L Divn. should be assigned the above work as a Co-Ordinator to ensure that the time bound follow up actions are being taken with the concerned ROs / HoDs till the logical conclusion of the above directions, which can be reported to concerned Authorities through P&L Divn. It was further decided that the HoDs should make available the copies of directions and Action Taken Reports available with them for further necessary compilation and submission thereof to the CPCB and other Authorities within a week's time, so that by 31/03/2012, MPCB can provide the status of compliance of the directions by initiating appropriate actions against the defaulting units.

Mrs.Vaishali Sadhale, Asstt.Law Officer is hereby deputed to co-ordinate the compilation of information from the Regional Officers/HoDs and to take further follow up with the concerned officers and Authorities, so as to initiate appropriate action in the matter and to secure the compliance of such type of actions as well as providing the status of compliance of directions issued by the CPCB and other Authorities by 31/03/2012.

HoDs are instructed to make available copies of above directions and also to take follow up with the concerned ROs for the compilation of such type of directions. Whenever any directions are received from the above Authorities, first of all, such directions can be forwarded to the concerned RO for submission of present status of compliance and for taking further necessary action in the matter. Copy of such directions shall be kept by the concerned HoD and also be made available to the subject Incharge for further doing needful in the matter. The original directions will be kept by the Policy & Law Division for taking further line of action to take it to the logical conclusion and further reporting the status of compliance to the concerned Authorities. A separate register shall be maintained at the Regional Level as well as HoD and Policy and Law Division level alongwith soft copy thereof also.

Sub: Compliance Status of Directions issued u/s 18(1)(b) of Water / Air (Prevention & Control of Pollution) Acts.

Central Pollution Control Board issues 'Directions u/s 18(1)(b) of the 'Water / Air (Prevention & Control of Pollution) Acts' to the State Pollution Control Board in different cases like non-complying industries and local bodies, inadequate waste treatment facilities, violation of pollution control norms by cluster of industries, common treatment facilities etc. It is observed that the status of compliance of the directions issued by this office is generally not satisfactory.

In the 'Board Meetings' the status of the compliance of the directions issued to SPCBs / PCCs was reviewed. The Board Members expressed displeasure on the poor status of compliance and desired that the SPCBs be advised to comply with the directions issued & communicate the status / action taken report in the matter to CPCB immediately.
