CIRCULAR

Sub: Returning of Application for consents & Authorization only with approval of competent authority as per the powers delegated for the Consent Management.

Ref: Discussion held in Consent Appraisal Committee Meeting on 24/12/2012.

In various CAC/CC meetings, it has come to the notice that the lower authorities are returning applications received for grant of consent to Establish/ Consent to Operate/ Consent to Renewal and Authorizations on various pretexts.

It may be noted that the authority competent to return applications is same as the authority, who is competent to grant consent as per the delegation of powers. Therefore, it is clarified once again that no applications for consents/Authorizations shall be returned to the project proponent on any pretext without the approval of the competent authority.

This circular should be followed very scrupulously and any deviation in procedure will invite for disciplinary action.
